Kidnapped boy rescued after 3 days from Joydevpur

A six-year-old boy, kidnapped a day before Eid, was rescued

around 8:00pm on August 8 from a tailoring shop near his house at Modhya Ouchpara in Tongi, Gazipur.

Khokon Mia, 30, owner of the shop Three Star Tailors; and his two associates - Shah Jamal Hasan, 35, and Mukul Mia, 25 - were arrested by Rab for planning the kidnap, said Kismat Hayat, Rab-1 commanding officer, at a press briefing yesterday at the battalion's office in the capital's Uttara.

At the briefing, Noor's mother Safia Akhter said her son had gone to the shop of Khokon who was a friend of Noor's father. But Noor was not there when she went to look for him around 10:00pm.

By 10:30pm when she could not find Noor anywhere, she

received a phone call and a man demanded Tk 50 lakh if she wished to see her son, Safia added. Hayat said two groups were involved in the kidnap. The planners were encouraged to commit the crime by the

actual kidnappers Babu, Sumon and a woman, whose name

could not be known yet, he said adding that Sumon was the shop staff Hasan's relative. "They convinced Khokon, who was aware of the financial wellbeing of Noor's father Mohammad Elam Mia, to

kidnap Noor," said Hayat.

Hayat said they arrested the planners from Gazipur yesterday at 8:30pm. The child was rescued two and a half hours later.

Attempt made to loot Agrani Bank in capital STAFF CORRESPONDENT

A heist attempt was made at a branch of state-run Agrani Bank in the capital during the Eid holidays, said police on Sunday.

Visiting the two-storey Nababganj branch of the bank in Lalbagh on Sunday, The Daily Star found a rectangular hole, about 11 inches wide and 15 inches high, on the wall of the bank vault.

Kazi Matiar Rahman, second officer of the branch was the first to discover the hole when he went to work after the three-day Eid holidays on Sunday.

Miscreants had entered the building through an iron-bar enforced ventilation duct on the first floor and then climbed down the stairs and broke a portion of a wall to get inside the vault. But they could not open the cash locker inside, said Nurul Muttakin, officer-in-charge (OC) of Lalbagh Police Station.

The Agrani Bank official confirmed that nothing had been stolen except for a monitor from the first floor. A peon was supposed to guard the branch during the holidays but he could not as he was sick.

The bank does not have any armed security personnel or close-circuit cameras, said the OC.

than normal, a normal flood would submerge the northwestern part known as the Ganges dependent area in the country in the second half of this month.

In the three-month forecast, starting from August, the weatherpersons forecasted normal rainfall in September and October.

The girl told The Daily Star that she screamed for help with all her might while she was attacked but nobody came to her rescue. Kamal, the rapist is the son of a tea stall
