



MILKY MURDER CASE

Another accused arrested

Shahidul Islam, a close associate and bodyguard of former Jubo League leader Shakhawat Hossain Chanchal, one of the main accused in the Milky Murder case, was arrested on Tuesday and taken into remand

yesterday. A week ago, Jahangir Mondol, another accused and Chanchal's driver, indentified Shahidul in the CCTV video footage that captured the murder of Jubo League leader Riazul Haque Khan Milky in front of a shopping mall in the capi-

tal's Gulshan on July 30. Rapid Action Battalion arrested Shahidul from the capital's Kamalapur Railway Station Tuesday, Rab-1 Commanding Officer Kismat Hayat told The Daily Star.

Rab produced Shahidul before a Dhaka court yesterday and prayed for a seven-day remand to interrogate him. In response, Metropolitan Magistrate Md Tanvir Ahmed granted four days.

Rab also prayed for a seven-day remand for Chanchal's brother-in-law Sharifuddin Chowdhury Pappu alias Dr Pappu who was arrested on August 6 and sent to jail.

So far, nine people have been arrested by Rab in connection with the Milky murder case.

However, the prime suspect, Jubo League leader Jahid Siddique Tarek, was killed in a shootout between his cohorts and Rab on July 31. Shakhawat Hossain Chanchal is still absconding.

HALL-MARK SCAM

2 more petitions filed against Jasmine's bail

The Anti-Corruption Commission yesterday filed two more petitions with the High Court to cancel the lower court orders that have granted bail to Hall-Mark Group Chairman Jasmine Islam in two loan scam cases.

On August 4, a Dhaka court granted bail to Jasmine in all the 11 cases filed by the ACC after she pledged to pay back in monthly instalments Tk 2,600 crore, which her company has swindled out of Sonali Bank.

The commission filed the first petition with the HC on Tuesday for cancelling her bail in one of the 11 cases.

ACC lawyer Khurshid Alam Khan told The Daily Star that the ACC would file eight more petitions in a few days for cancelling her bail in the remaining eight cases.

Citing from the petitions, he said Jasmine was granted bail illegally, as investigations were underway, and there were serious allegations of money laundering against her.

Granting conditional bail to an accused is always illegal, Khurshid said.

Hearing of the petitions may take place next week, he added.

The national and party flags will be kept at half mast and black flags will be flown atop Bangabandhu Bhaban and all party offices at the time of sunrise. On this day in 1975, Father of the Nation

Bangabandhu Sheikh Mujibur Rahman and most of his family members were assassinated by a disgruntled group of army officers. President Abdul Hamid, Prime Minister Sheikh Hasina, cabinet members, leaders of the

Awami League and its associated bodies, and people will place wreaths at the portrait of the father of the nation in front of Bangabandhu Bhaban on Dhanmondi road 32 in the capital

Hasina and General Secretary Syed Ashraful memorial in Dhanmondi.

Islam will lay wreaths at the grave of Bangabandhu at Tungipara, Gopalganj at 10:00am.

The AL will organise special prayers and a milad mahfil at the graves of the August 15 victims at Banani graveyard at 7:30am and Bangabandhu's grave at 11:00am.

Staff at the Prime Ministers' Office yesterday organised special prayers for the victims.

The AL will organise a discussion on the life of Bangabandhu today at 3:30pm at Bangabandhu International Conference Centre.

Mujib Sena Oikya League will organise a milad and discussion at its office in Gulistan.

Islamic Foundation is likely to offer daylong free medical care among the capital's destitute people.

On the occasion, the Gonojagoron Mancha will hold a daylong photo exhibition titled "Udito Surya" on the life and works of Bangabandhu at Shahbagh intersection,

TWO CASES AGAINST FAKHRUL Indictment hearing deferred till Sept 17

A Dhaka court yesterday deferred until September 17 the hearing on charge framing against BNP acting Secretary General Mirza Fakhrul Islam Alamgir and 25 other leaders and activists in two cases.

The court passed the order after lawyers of Moudud Ahmed, Mirza Abbas and Shahid Uddin Chowdhury Annee submitted separate petitions seeking adjournment of the hearing. The two cases were filed against them on charge of creating

anarchy and preventing police from discharging their duties on March 2 during their agitation programme. One case was filed against Fakhrul, Moudud and 24 others

with Paltan Police Station while another case filed against 23 BNP leaders and activists, including Fakhrul and Moudud, with Shahjahanpur Police Station.

Four accused, including Amanullah Aman and Nazimuddin Alam, were present in the court while Fakhrul, Moudud and two others were absent. Eighteen others have remained absconding.

Meanwhile, another Dhaka court yesterday adjourned until September 17 for hearing of the case filed against Fakhrul and An AL team led by party President Sheikh organise cultural events, and offer flowers at his 45 others for torching a vehicle before the Prime Minister's Office on April 29 last year.

Indian High Commissioner Pankaj Saran yesterday offered his country's assistance in developing the education sector of Bangladesh.



Woman 'burnt by husband' dies

A woman allegedly burnt by her husband at Joydevpur in Gazipur on August 3 died at Dhaka Medical College Hospital (DMCH) Burn Unit yesterday afternoon.

The victim is Seema Akhter, 30, wife of Mosharraf Hossain of the area.


Victim's elder sister Minara Parveen told The Daily Star that the couple had no good relations since their marriage 13 years ago. Mosharraf went abroad and returned two months back. After his return, their relation deteriorated further, she said.

Minara alleged that on the day Mosharraf asked Seema to bring Tk 1 lakh from her father's house but she expressed her inability that led to a quarrel at 2:00am.

At one stage, Mosharraf poured kerosene on Seema's body and set her on fire. She was admitted to DMCH with 68 percent burn injuries.

Seema lodged a complaint with the police against her husband. Police later arrested Mosharraf from DMCH the

same day. Joydevpur Police Station Officer-in-Charge (OC) SM Kamruzzaman said a murder case would be filed against Mosharraf who was now in jail.




