#### Justice Kemaluddin no more

Former chief justice Kemaluddin Hossain died of old age complications in the capital's United Hospital early yesterday. He was 90.

He left behind his wife, three sons, three daughtersin-law, and three grandchil-

for Law Qamrul Islam also


condoled his death. Justice Kemaluddin was the fourth chief justice of Bangladesh from February 1, 1978 to April 11, 1982.

In 1968, he was appointed as deputy attorney general of the East Pakistan High Court and in 1969 he was recruited as a judge of the East Pakistan High Court. Kemaluddin was appointed a judge of the Appellate Division of Bangladesh Supreme Court in 1978.

He was the Law Commission chairman between 1998 and 2001.

His first namaz-e-janaza was held on the Supreme Court premises at 2:30pm yesterday.

Later, he was buried at Banani graveyard following the second janaza at Gulshan Azad mosque, his son Istiaq Hossain told The Daily Star.



### HELPING RANA PLAZA VICTIMS Bring initiatives under single umbrella

Urges Dr Kamal

Initiatives redressing the loss suffered by Rana Plaza victims must be brought under a single organisational umbrella to create a more transparent system for providing compensation, urged Dr Kamal Hossain at a discussion yesterday. "A lot of people are donating money to funds created by

different organisations but there is no actual record of the amount of money provided to victims so far and to whom. Moreover, there are several lists of the number of the dead, injured and missing victims but nothing absolute," he said.

Representatives of 20 garment workers' organisations and lawyers convened the discussion in the capital's Supreme Court Bar Association premises.

They also demanded that the Prime Minister's Office and Bangladesh Garment Manufacturers and Exporters Association provide details on the amount of money which had accumulated in their funds and to whom it was being given.

A separate tribunal could be created to deal with cases, like those of the Savar victims, where victims could seek compensation for having been wronged, advised Barrister Amirul Islam.

"This is because the normal civil court proceedings are delayed by a backlog of cases," he said.

Barrister Sara Hossain told this correspondent that a separate act could be created to deal with the situation and all similar future ones.

The workers' organisations include Jatiya Poshak Shilpo Sramik Federation, Bangladesh Garments Sramik Shangha, Jatiya Garments Textile Sramik Federation, Textile Garments Workers' Federation, Samannito Garments Sramik Federation, and Garments Sramik Oikyo Forum.

# 45,066 Bangladeshis deported from New Delhi in last 22 yrs Indian court told

Over 40,000 illegal Bangladeshi migrants have been deported from India's national capital in the last 22 years, a Delhi court was told on Tuesday.

The Foreigners Regional Registration Office (FRRO) also said this year till June 30, they have deported 182 Bangladeshi migrants and 119 more are awaiting deportation.

"...this office (FRRO) has deported 45,066 illegal migrants of Bangladesh since the year 1991 till date and a batch of 119 illegal migrants of Bangladesh are restricted for deportation," the FRRO said in its reply to the court which had sought an explanation from it for not

complying with its direction to periodically identify illegal Bangladeshi migrants.

Additional Session Judge Rajender Kumar Shastri, while sentencing four Bangladeshi nationals to 13 years in jail for committing a robbery in south Delhi, had on April 4 directed Delhi state government to identify and deport all foreigners living illegally in the national capital.

An advocate, Rajesh Sharma, had approached the court, saying Bangladeshis are having an "easy access" to come and go back to their country after committing crimes.

"This cannot be possible without active connivance, nexus and collusion of government officials in Delhi or at borders," he said.

#### CTG ARMS HAUL CASES Ex-NSI DG implicated under govt pressure: Defence lawyer

The fifth and last investigation officer (IO) of the Chittagong arms haul cases implicated former National Security Intelligence (NSI) director general (DG) Brig Gen Abdur Rahim under pressure from the present government, claimed Abdur Rahim's lawyer yesterday.

The present government holds a political grudge against Abdur Rahim as he accompanied BNP Chairperson Khaleda Zia in her visits while she was the prime minister, added Advocate Kamrul Islam Sazzad.

Kamrul was cross-examining the IO, Moniruzzaman Chowdhury, also a prosecution witness, before Chittagong Metropolitan Special Tribunal Number-1 Judge SM Mojibur Rahman.

Kamrul also accused Moniruzzaman of giving false statements and taking confessions forcibly from witnesses.

The first statement Abdur Rahim provided to an IO did not have any mention of NSI and

Directorate General of Forces Intelligence (DGFI), he said. Neither did the statements of three witnesses -- the then deputy commissioner of

Chittagong police Abdullah Hel Baki,

Chittagong Metropolitan Police commissioner SM Sabbir Ali and Criminal Investigation Department (CID) deputy inspector general Forrukh Ahmed, he said.

However, Abdur Rahim was later compelled to give a confessional statement to a court and the remaining three statements to IOs relating to the NSI and DGFI, he added. Moniruzzaman denied these arguments.

Kamrul also said statements given by two witnesses -- sergeants Alauddin and Helaluddin -- to CID in 2009 differed from what they gave to a court in 2010. Moreover, they did not accuse anyone before 2010, he

Eleven accused of the cases, including former state minister for home Lutfozzaman Babar and former industries minister Motiur Rahman Nizami, were produced before the court yesterday. The court fixed today for the next hearing.

The two cases were filed with Karnaphuli Police Station a day after seven truckloads of arms and ammunitions were seized at a jetty of Chittagong Urea Fertiliser Ltd in Chittagong city on April 2, 2004.

Charge sheets of the two cases, one for smuggling firearms and the other under the arms act, accused 50 and 52 persons respectively.


