million instalment in June.) The audit report said the three marketing companies of the BPC had been keeping the money in their banks and earning interests, thus making profits at the expense of taxpayers'

money. The three companies then distributed the profits among their officials and employees as incentive bonus and dividends, according to the report.

The audit also found that the main depot of Padma Oil in Chittagong did not send petroleum products to Baghabari depot directly. Instead, Godnail station, a midway depot, received the products first and later sent those to Baghabari.

As a result, the BPC had to bear an additional Tk 3.17 crore in transport cost in 2010-11 and 2011-12.

In the same way, it counted Tk 1.51 crore as

Padma Oil did not transport petroleum products directly to Parbatipur from its main depot in the port city. It sent the products via Doulatpur

The BPC pays its subsidiary marketing companies for their transport and marketing costs. The government had to

pay Tk 50 crore in demurrage over the same period as the BPC could not unload petroleum products from ships due to its inadequate storage capacity. The BPC lost another Tk

19.89 crore as incentive for product improvement was raised from 15 percent to 25 percent for Eastern Refinery Ltd, even though the processing fee of the refinery company more than doubled in the last two decades. Surprisingly, the state-

run company did not compare shipping charges among different companies and opted for higher charges for importing diesel from

different oil suppliers. It cost the country an additional Tk 23.84 crore.

The public exchequer also lost Tk 73.72 crore in revenue in the two financial years as some depots of Padma Oil sold excess oil totalling 1.2 crore litres to dealers and agents mainly in the bordering areas, said the report. Allegations are rife that

petroleum products are smuggled through the border into some neighbouring countries, causing a huge a loss every year. "If excess oil was not sold, it could be used to

meet the local demand and

the government would not have to import more oil. Then the subsidies would have been lower," said the This, however, is not the first that the audit department has found irregulari-

ties at the BPC and at its subsidiary companies. The public exchequer

lost Tk 730.33 crore in 2007-08 and 2009-10 due to irregularities at the staterun companies, according to the audit department.

Contacted, BPC Chairman Eunusur Rahman said the efficiency audit mainly looked at deficiencies and faults that held back any organisation to better perform. He added that the audit

did not look at the financial irregularities and corruptions. "We have already dis-

cussed some of the objections among ourselves and made some decisions so we can correct our mistakes and overcome the deficiencies," he told The Daily Star last week. He said some objections

were made also in the past. "Nothing can be done about them overnight. But there are some areas where we can improve in a short time if we try."

"BEM's documentation and file maintenance systems are similar to that of JMB, so we suspect the new organisation is formed by JMB members," Wing Commander Habibur Rahman, director of legal and media wing of Rab, told The Daily Star.

"Members of the new outfit may have a few groups in other parts of the country like the one we have busted in Bogra," said Special Company Commander of Bogra Squadron Leader Mohammed Miran Hossain.

He said going through the books and seized documents it seemed to them that each group had around 18 members who worked in two shifts. While some men in their shift study, exercise, pray or train on arms, others remain on guard, he added.



MASUM in its letter to NHRC said that after the incident the victim was produced before the Additional Chief Judicial Magistrate's court by the police, from where she was sent to correctional home with her minor son and husband in violation of the Indian Home Ministry's office memorandum which clearly stated that "if a woman or a child is found to be a victim, the victim should not be prosecuted under the Foreigners

The victim woman also lodged a complaint against the BSF constable, which was

also registered by the police.

Roy said "we have unconfirmed report that BSF higher ups suspended the accused BSF man but he was not arrested or remanded till

The MASUM demanded a probe into the incident by an independent agency and adequate compensation for the victim.

"The victim woman with her minor son must be transferred to any care home from the correctional home (prison), her safety and security must be ensured and any interference by police and BSF must checked during the whole investigation process", the letter
