Labour law serves "(These) issues are being owners' interests

Allege garment workers' leaders STAFF CORRESPONDENT

Instead of being protective of workers' rights, the newly passed Labour Law 2006 serves the profiteering owners' interests, said garment workers' leaders yesterday.

Yielding to the unethical influences of the owners, the gov ernment has forgotten that the role of the law is to protect workers' rights, they claimed. They were speaking at a press conference of Bangladesh

Garment Workers Unity Council (BGWUC) held at Dhaka Reporters Unity. According to a section of the law, a worker will not be given any compensation if he/she is accused of vandalism, arson, riot

or unruly behaviour in the factory, said Salauddin Shapon,

secretary general of the organisation. "We fear that the owners will abuse the section of the law to deprive workers of their dues and harass them with criminal

cases," he said. He went on to criticise other sections of the law that afford owners the leverage to dismiss workers from factories.

He added that there was a "dark section in the law that allows termination of workers without any specific reason or fault." BGWUC urged the government to immediately scrap the

anti-worker sections and sub-sections from the law and amend it at the next parliamentary session.

An amendment of the law will not only protect workers' interests but also ensure future development of the industry, they said.

BUSTED BOGRA MILITANT DEN

Meaning of BEM, weapons source still a mystery

Law enforcers are yet to discover what stands for BEM, a new organisation mentioned in books and documents seized during a raid on a militant den in Bogra on August 22, and the source of sophisticated weapons found there.

However, police seized 500 grammes of gunpowder, a pistol, three toy pistols, eight homemade bombs, a dagger, 15 masks and some books on Jihad from another Bogra house on Saturday.

The seizure was based on information gleaned from Rafiqul Islam Rubel, one of three suspected militant BEM members arrested during the August 22 raid at a house in Thonthonia Paschim Para.

During Saturday's drive at the Malgram Adarsha Para house, police arrested its owner, Rezaul Karim, and his son Yusuf but suspected BEM members managed to flee.

Rafiqul is the brother of one Sohel, involved with banned militant organisation Jama'atul Mujahideen Bangladesh

(JMB) since 2006, said Bogra Superintendent of Police (SP) Mozammel Haque. Rafigul had tried to mislead law

enforcers by pretending to be one Nahid and that he hailed from Dinajpur. He actually hails from Fulbaria in Mymensingh. Police filed three cases under the

members, Sanaullah Mollah of

Shahjahanpur upazila in Bogra and

Bangladesh fails to attract Malaysian investors

Says envoy

Malaysian High Commissioner in Dhaka Norlin Binti Othman yesterday expressed dismay over the prevailing atmosphere for business in Bangladesh, saying it was not welcoming and apparently discouraging for her country's investors.

Although Bangladesh had immense potentials, a negative perception has emerged among Malaysian investors due to a lack of coordination among Bangladesh's government bodies and a lack of adequate infrastructure and communications system, she said.

She was addressing the Country Lecture Series on Malaysia organised by the Bangladesh International Institute of Strategic Studies (BIISS) in its auditorium in the capital.

"I have personally given up asking my friends to come and visit," Norlin said.

On manpower export, she said under a recently signed government-to-government agreement, Malaysia was recruiting some 10,000 workers from Bangladesh for tree plantation jobs.

workers had already reached Malaysia and the

second batch of 174 will be going soon. Norlin admitted that the process of sending workers was bit slow as her government was maintaining a strict but transparent system in

recruiting manpower. "The government will ensure a minimum wage of 900 Malaysian Ringgit per month," she

On removing the trade gap, Norlin suggested product diversification and analysing the type of products Malaysia wants.

On Malaysia My Second Home Programme, she did not give any figure on the number of Bangladeshis availing it but said now it was open for people of all ages, not only for those above 50.

The programme is an international residency scheme enacted by the Malaysian government to allow foreign nationals to stay in Malaysia on a long-stay visa of up to 10 years.

The Parliamentary Standing Committee on Chittagong Hill Tracts (CHT) Affairs will visit Taindong, a remote village in Khagrachhari, on September 4 to investigate an attack on indigenous people in the area on August 3.

The Jatiya Sangsad body, at a meeting at the parliament building, also recommended that the government buys a helicopter and adequate motorcycles for law enforcing agencies in CHT so that they could rapidly respond to violence. On August 3, arsonists, which the victims claim were

Bangalee settlers from neighbouring areas, torched 35 houses in Taindong and its three neighbouring unions and brutally beat several indigenous people of the area. "We want to know what actually happened there in

attack on our indigenous people," a member of the JS body said. The JS body, led by Mohammad Shah Alam, will submit a recommendation to the government on how to reduce tensions between Bangalee and indigenous people living there.
