**JOBS IN MALAYSIA**

**90 more fly to KL today**

**Another 83 to go tomorrow**

The government will send the second batch of 90 Bangladeshi workers from Dhaka today to join plantation jobs in Malaysia, resuming the operation after a four-month break.

They will leave Hazrat Shahjalal International Airport by Malaysia Airlines for Kuala Lumpur at 12:30pm.

"Another 83 will fly off on Wednesday by the same airlines," Bureau of Man Power, Employment and Training Director Mizanur Rahman (Employment) told The Daily Star on Sunday. BMET received the visas from the Malaysian authorities last week.

The government initiative sent 198 workers to Malaysia, before it was halted in April this year. Expatriates' Welfare and Overseas Employment Ministry sources said the suspension was due to the Malaysian government scrutinizing Bangladesh's manpower export process.

Private recruiting agencies were sceptical as to whether the process could be restarted again, as they blamed

**UN inspectors come under sniper attack**

**Assad denies use of chemical weapons**

UN chemical weapons inspectors in Syria met and took samples from victims of an apparent poison gas attack in a rebel-held suburb of Damascus yesterday after the UN team themselves survived a sniper attack that hit a vehicle in their convoy, reported Reuters.

A Syrian doctor told Reuters from the suburb, Mouadamiya, that investigators from the United Nations had crossed the

frontline from the center of the capital, which remains under the control of President Bashar al-Assad's forces.

The UN said one vehicle in its convoy had been crippled by shooting by "unidentified snipers", but mentioned no injuries. Their arrival meant whoever fired had failed to turn them back.

With Western powers considering military strikes, despite vocal opposition from Assad and his Russian and Iranian allies,

**NIZAMI'S WAR CRIMES TRIAL**

**Prosecutors rebuked for misconduct**

The International Crimes Tribunal-1 yesterday rebuked the prosecutors for their misconduct during cross-examination of a witness in the war crimes case against Jamaat-e-Islami chief Motiur Rahman Nizami.

At one point of expressing discontent, tribunal member Justice Jahangir Hossain Selim said, "The prosecution are supposed to assist the tribunal. If you [the prosecution] cannot assist, please don't appear before the tribunal."

The tribunal said this soon after the defence had drawn its attention to a comment passed by prosecutor Altab Uddin Ahmed to conducting defence lawyer Mizanul Islam.

The Daily Star refrained from publishing the slang and the comment for the sake of its readers.

Conducting prosecutor of the case Mohammad Ali sought apology on behalf of the prosecution.

**BNP won't accept even president-led interim govt**

BNP would not even accept the president or the speaker as the head of an interim government for holding the next national polls, let alone the incumbent prime minister, senior party leader Moudud Ahmed said yesterday.

Referring to the recent reports run by some newspapers on the formation of the interim government with the president or the speaker as its chief, he said these two were also Awami League-nominated persons.

"There is no mention of interim government in the constitution," said Moudud, also a BNP
