US delays deadline for finalising Obamacare health plans

The Obama administration has delayed a step crucial to the launch of the new healthcare law, the signing of final agreements with insurance plans to be sold on federal health insurance exchanges starting October 1.

The US Department of Health and Human Services (HHS) notified insurance companies on Tuesday that it would not sign final agreements with the plans between September 5 and 9, as originally anticipated, but would wait until mid-September instead, according to insurance industry sources.

Nevertheless, Joanne Peters, a spokeswoman for HHS, said the department remains "on track to open" the marketplaces on time on October 1.

Peters said only that the government was responding to "feedback" from the companies, "providing additional flexibility and time to handle technical requests."

Coming at a time when state and federal officials are still working to overcome challenges to the information technology systems necessary to make the exchanges work, some experts say that even a small delay could jeopardize the start of the six-month open enrollment period.

U.S. officials have said repeatedly that the marketplaces, which are the centerpiece of President Barack Obama's signature healthcare reform law, would begin on time.

Centers for Medicare and Medicaid Services, the HHS agency spearheading marketplace development, affects insurance plans that would be sold in federal exchanges that the administration is setting up in 34 of the 50 US states. The remaining 16 states, including Oregon and California, are setting up their own marketplaces.

"It makes me wonder if open enrollment can start on October 1," said a former administration official who worked to implement Obama's healthcare reform.

"But having everything ready on October 1 is not a critical issue. What matters to people is January 1, which is when the coverage is supposed to start. If that were delayed, it would be a substantive setback."

The new timetable for qualified plan agreements is the latest in a series of delays for Obamacare.

The most significant came in early July when the White House and the Treasury Department announced a one-year delay in a major Obamacare provision that would have required employers with at least 50 full-time workers to provide health insurance or pay a penalty beginning in 2014.

Another US watchdog, the HHS Office of the Inspector General, warned earlier this month that the government was months behind testing data security for the federal data hub that represents the information technology backbone of the new marketplaces.

The state of Oregon has already scaled back the October 1 debut of its own healthcare exchange by preventing state residents from signing up for coverage on their own until mid-October. Myanmar approves telecoms bill

Myanmar's parliament has passed a telecoms bill paving the way for licensed international firms to operate, state media said Wednesday, in the latest move to open the potentially lucrative mobile market.

The former junta-run nation last month awarded telecom licences to Norway's Telenor and Qatari firm Ooredoo as it tries to raise telephone coverage from less than 10 percent currently to 80 percent by 2016.

The state-run New Light of Myanmar newspaper said the bill had been approved by parliament. MP Phone Myint Aung said the move would mean

Thein Sein to come into effect. "We have not yet had an opportunity to review the

legislation but look forward to the final approval of the Telecommunications Law and to also reviewing the implementing regulations," Telenor said in a statement. "A clear and stable regulatory and legislative

framework that ensures predictability and a level and transparent playing field is important for a long-term investor such as Telenor."

Telenor added that it was still finalising the terms and conditions of the licence.

The bid process has been closely watched as a bellwether of economic reforms aimed at driving rapid foreign investment in the nation, which has seen sweeping changes since a quasi-civilian government replaced the military regime in 2011.

Ooredoo, formerly known as Qatar Telecom, this month pledged to introduce "affordable" phone services to Myanmar next year as it pumps \$15 billion into the country as part of its 15-year 3G licence.

Few can currently afford mobile phones and SIM card fees, which in the past cost about \$200, although the government is trying to make prices more affordable. In April state-owned giant Myanmar Post and

Telecommunication announced it would start selling SIM cards for less than \$2, and the authorities have begun selling them on an lottery basis.

US pending home sales drop in July

US pending home sales dropped for the second rising mortgage interest rates hit demand, an industry group said Wednesday.

The National Association of Realtors' index for pending sales of previously owned homes, based on contract signings, fell 1.3 percent to 109.5 in July.

The index was 110.9 in June, after an unexpectedly strong jump to 112.3 in May, its highest level since December 2006.

The second straight monthly decline surprised analysts, who on average had predicted the index would rise 0.2 percent in July.

Although the housing market is still rising - pending sales were up 6.7 percent from July 2012 -- higher mortgage rates are slowing the market, NAR said. Lawrence Yun, NAR chief

July figure, saying "the modest decline in sales is not yet concerning."

"However, higher month in a row in July as mortgage interest rates and rising home prices are impacting monthly contract activity in the highcost regions of the Northeast and the West," he said.

The NAR data points to existing-home sales dipping in both August and September, said Ian Shepherdson of Pantheon Macroeconomics.

"Mortgage applications and mortgage lending are now trending downwards in the wake of the surge in mortgage rates over the past three months, and housing transactions will follow," he said.

"We are inclined to see the May surge as a signal that people were rushing to lock-in before rates rose further, rather than an indication of a further sustained pick-up in sales."

82 more workers head to Malaysia

A total of 370 workers have now been recruited by the Malaysian government under the scheme. Expatriates' Welfare and Overseas Employment Minister Khandker Mosharraf Hossain is now hoping the remaining workers selected under the scheme would get to leave over the next two or three months.

Around 1.5 million aspirant workers registered online last January. Of them, 10,000 were selected and given technical training at 23 centres across the country.

The workers paid only Tk 33,178 for the posting in Malaysia, when previously the cost would be as high as Tk 2-2.8 lakh.

While many consumer companies have resorted to price hikes to cope with the currency, long-term supplier contracts and hedging are helping some to bite the bullet for now.

Daimler AG's Mercedes-Benz has held off on a price hike even though it faces severe margin pressure from the sliding currency and rising fuel costs, but it may relent soon.

"We didn't get immediately affected by the weakening of rupee as we have a long-term hedging strategy. However the hedging period cannot be forever and we have to ensure that we run a sustainable business in the long term," Eberhard Kern, managing director at Mercedes-Benz India said. Similarly, branded

apparel maker Lacoste India is expecting a hit on its margins but will hold off on a price hike until the end of the year, Rajesh Jain, director and chief executive officer said. The company imports raw materials like yarn, but long-term supply contracts have so far insulated it from currency-related price increases of 15 percent.

However, that will be small comfort if demand stays weak.
