14.	Brief description of assignment	Background of the Project: At present, around 8 to 10 lakh Non Resident Bangladeshi (NRB) work in UAE. Most of these NRBs still possess hand-written passport. Government of Bangladesh plans to replace all hand-written passports with MRP of these NRBs in UAE by 31 st March 2015. Existing facilities in Bangladesh High Commission in UAE are inadequate to process and deliver this huge amount of MRP within this stipulated time. As such, the authority aims to take up a separate project for Enrolment Data collection and related services incidental to and distribution of MRP among Bangladeshi citizens in UAE. MRP and MRV Project office requests the Expression of Interest (Firm) for the Selection of Service Provider for the abovementioned project. The services include: 1. Establishment of at least 4 Regional Enrollment Centers (REC) and required No. of mobile unit (different sites in UAE where Bangladeshi expatriates live in big numbers) for collecting applications/biometric data and delivering personalized MRPs. This each office will be supervised, controlled and administered by 1X officer from MRP project and one officer from DIP having knowledge on MRP system will assist him. 2. Establishment of one Centralized Management Office (CMO) in UAE to manage and coordinate the end-to-end operation. To maintain such office one officer from MRP project having knowledge on Bangladesh MRP system will be employed. To assist him one officer from DIP will be employed. 3. All Officers from MRP Project will be replaced by DIP Officers during the handing over the Project to DIP. 4. Arranging motivational campaign by the svc provider to convince current hand-written passport holders to upgrade to MRP. 5. Collection of accurate enrolment data (including biometric information) in pre-determined form from all over UAE. 6. All personnel employed by svc provider must be well conversant in Bangla and English language. 7. Pushing the collected data electronically to the central database located at DIP, Dhaka for personalization of MRP booklets. 8. Arranging and distributing personalized MRPs to the applicants with accuracy and promptness. 9. Attending correction issues at the time of delivery and taking measures to resolve those. 10. Applicants' payment related issues need to be reconciled and synchronized daily with High Commission of Bangladesh in UAE and Department

Seamless integration with existing application for compliance with necessary workflow is also the responsibility of the service provider. 12. Data security and data encryption must be ensured to prevent data leakage, identity theft or any other fraudulent activities. 13. Premises must have adequate public facilities as per UAE government guideline. 14. Logical and physical security of the premises and surveillance should be ensured. 15. Handing over of all necessary information and data (hardcopy and softcopy) to MRP unit of Bangladesh High Commission in UAE after completion of the job. 16. Web page to open to notify all Bangladeshi in UAE and may link High Commission, DIP and MRP Project. 1. The intending service provider must have following experiences to qualify and shall have to submit necessary proving documents with EOI: a. Proven experience (user certificate) of providing similar services in at least 01 (one) MRP project within last 5 (five) years. b. Proven experience (user certificate) of using networking equipment, design and installation and providing services in multi countries environment with last 5 (five) years. c. The service provider shall submit the evidence of liquid assets or working capital or credit facilities of minimum USD 10 (Ten) million or equivalent. d. Bidders should be consortium compulsory having, independent companies that are incorporated in Bangladesh or firms registered in Bangladesh whose prime area of business activity is in the field of Information and Communication Technology (ICT) and one local company registered in UAE or consortium compulsory having, at least one company that is incorporated in Bangladesh or one firm registered in Bangladesh whose prime area of business activity is in the field of Information and Communication Technology (ICT) for last 3 years and one local company registered in UAE.
