

# Good catches of hilsa in Khulna ease prices

The ongoing peak season sees good catches of hilsa in the coastal belt of Khulna region, much to the happiness of fishermen and traders as well as consumers.

Over 1500 trawlers from Khulna, Bagerhat, Satkhira and Barguna districts are now engaged in catching hilsa in the sea and different rivers in the Sundarbans and adjacent areas, said members of local fishermen's association.

Amid the abundant supply, prices of the popular fish have reduced by 20-25 percent per kg compared to last month, locals said.

We went to the deep sea with 50 fishermen and came back to the shore after two weeks with 120 maunds of hilsa that sold for Tk 20 lakh to Khulna traders," Mizan Molla, a fisherman of Baniashanta area under Dakope upazila in Khulna, said on Friday.

"Around 45-50 trawlers



loaded with 850-900 maunds of hilsa from the sea arrive here daily and we buy it for around Tk 550 per kg from the fishermen," said Abdus Salam Sheikh, a fish wholesaler in Khulna No-7 Ghat area adjacent to the Bhairab River.

Alam Howlader, a hilsa wholesaler of Rupsha fish market, said around 35-40 trawlers with 50 maunds of hilsa reach there daily and retail traders in different kitchen markets buy the fish for Tk 570-Tk 600 per kg.

Kabir Hossain, a retailer

of city's evening kitchen market, said they sold 700gm-800gm sized hilsa for Tk 600-Tk 650 and a kg sized hilsa for Tk 800-Tk 850 on Friday while the prices were Tk 750-Tk 800 and Tk 1100-1200 last month.

Meanwhile, several wholesalers and retailers alleged that cold storage owners in Khulna region are hoarding huge hilsa in the current season after buying it for low prices with hope to sell it for high prices later.

# Jamaat man held for killing cop

73 arrested on Friday sent to jail

An activist of Jamaat-e-Islami was arrested in Harinakundu upazila of Jhenidah district on Friday on charge of killing a policeman.

The arrestee is Rahaj Uddin, son of Jobed Ali of Chtakabaria village, reports our correspondent.

Police said constable Omar Farooque was stabbed to death by Jamaat-Shibir men during a mayhem at the upazila parishad complex in March this year.

Later, a murder case was filed in this connection, said Mahibul Islam, officer in-charge of Harinakundu police station.

In Dinajpur, Shibir men snatched two arrested activists from police after injuring two police officials on Friday evening, reports our correspondent.

The injured are sub-inspectors Md Ziaul Islam, 45, and Md Sharif, 38, of Chirirbandar police station.

Being informed that a group of Shibir men were holding a secret meeting, a police team raided the area and arrested Md Sadequul Islam, 28, former party president of Nasratpur union of Chirirbandar and activist Md Towhidul Islam,

22, of the upazila.

However, the rest managed to flee, sensing the presence of the law enforcers, said Md Abdur Rahman, officer in-charge of the police station.

When police were going back to the PS with the arrestees, Shibir men snatched them away after attacking the SIs, said the OC.

Away in Comilla, 73 local Jamaat-Shibir men were sent to jail in a case filed under Anti-Terrorism Act yesterday, reports our correspondent.

Senior Judicial Magistrate Md Sajjad Hossain of the court passed the order after rejecting their bail prayers.

Mahiuddin Mahmud, OC of Kotwali police station, said a team arrested the 73 while they were holding a clandestine meeting at a community centre in Barapara area of the town on Friday.

In Moulvibazar, police arrested a local Jamaat leader in Rajnagar upazila yesterday.

The arrestee is Nazrul Islam, nayeb-e-ameer of Rajnagar upazila unit Jamaat, reports our correspondent.

Nazrul was arrested on charge of assaulting police on April 14 this year, said M Kamrul Hasan, OC of Rajnagar police station.

Fishing in Chamuar Beel, a government-owned water body in Domar upazila under Nilphamari district, has become a rare scene for the last few days as authorities imposed a restriction on the act to avert unwanted incidents amid bitter rivalry between two groups of local fishermen.

# Dispute over leasing stops fishing in Chamuar Beel

The upazila administration has imposed temporary restriction on catching fish in Chamuar Beel, a 4.43-acre water body in Sonarai union of Domar upazila under the district, as two groups of fishermen are at loggerheads over taking possession of the water body.

This situation has arisen as the upazila administration allowed two individual fishermen, instead of local fishermen's cooperative society styled Naba Chetona Matsyajibi Samobai Samity, to cultivate fish in the *khas* (government owned) water body.

"This year upazila water body management committee called tenders from interested parties of fishermen's community for leasing Chamuar Beel but none participated," said Mizanur Rahman, assistant land officer of Sonarai union.

"Then upazila committee for collection of revenue from *khas* properties allowed fishermen Binod Das and Paresh Das to cultivate fish in Chamuar Beel and deposit revenue for the purpose. In the previous year also, none came forward to take lease and the committee allowed the two persons to cultivate fish there and they deposited only Tk 30,000 as revenue whereas the yearly lease money taken two years ago was 4.70 lakh," he added.

This initiative of the upazila administration aggrieved the fishermen belonging to the cooperative society.

Around two months ago, local lawmaker of Jatiya Party leader Jafar Iqbal Siddiquee

requested the upazila nirbahi officer (UNO) of Domar in writing to allow the cooperative society to cultivate fish, as they represent large majority of the local fishermen.

The lawmaker along with the cooperative society members also released spawn in the water body on the occasion of National Fishery Week in last July.

After that the society members tried to take control of the water body, Binod and Paresh and their men resisted, creating a tense situation.

Binod and Paresh claimed that the water body was handed over to them legally but the cooperative society members are creating chaos.

On the other hand, Monoranjan Das, general secretary of Naba Chetona Matsyajibi Samobai Samity, said, "As per government rule, fishermen's cooperative society members, not any individual, deserve the right to cultivate fish in the *khas* water body. A section of government officials are trying to mislead the UNO so that a vested groups can take control of the water body from behind by showing and financing the two fishermen for fish cultivation there."

Shafiqul Islam, UNO of Domar, said, "I shall look into the matter. Efforts are on to solve the problem soon."

Talking to this correspondent, many fishermen of the area including Nokul, Kajol, Subash, Suresh and Bhabani have demanded quick withdrawal of the restriction on fishing in Chamuar Beel as their daily earning depends on fishing.

# 4 'robbers' held in Laxmipur

Police arrested four people along with firearms while taking preparation to commit robbery in Wapda Sluice Gate area in Ramgati upazila on Friday night.

The arrestee were identified as Zahurul Islam, son of Joyanal Abedin, Sohel, son of Raijul Haque of Chargazaria village, Yusuf, son of Ahmed Ullah of

Poragachha village, and Ahmed Hossain, son of Bashir Ahmed of Sabujgram village in the upazila.

Locals said a gang of four robbers came by an engine-boat reached to Alexander Sluice Gate area to commit robbery in the fishing trawlers in the Meghna River at about 10.00pm.

While they were taking preparation, the fisher-

men caught them on suspicion.

Later locals gave them a good beating and then handed them over to police.

Police recovered a gun, a pipe gun and a few sharp weapons from their possession.

Moktar Alam, officer in-charge of Ramgati police station, said a case was filed under the Arms Act in this connection.

# Man killed, over 100 hurt in two clashes

A man was killed and over 100 were injured in two incidents of clashes in Netrakona and Bagerhat districts yesterday and the day before.

More than 100 people including three police constables were injured in a bloody clash between people of two areas in Netrakona district yesterday, reports our correspondent.

Additional Police Superintendent Delwar Hossain said that a conflict was running between students of Madan upazila headquarters and Jahangirpur over establishing supremacy on Madan Haji Abdul Aziz Degree College during the last few days.

Yesterday morning, students and people of Jahangirpur and Madan upazila headquarters engaged in a bloody clash with sharp and lethal weapons.

In Bagerhat, a man was killed and 10 others were injured in a clash between two

groups of villagers over a trifling matter at Goshgati village in Mollahat upazila on Friday.

The deceased was identified as Anisur Raman Mollah, 35, son of Mohammad Ali Mollah of Natun Goshgati village, reports UNB.

ANM Khairul Anam, officer in-charge of Mollahat police station, said the Sheikh family and Mollah family of the village had been at loggerheads over establishing supremacy in the village.

The clash ensued when some children, belonging to the two families, picked up a quarrel over getting on a boat for a trip in the morning.

As a sequel to that, two groups of the families, one led by Anisur Rahman Mollah and another led by Jahangir, equipped with lethal weapons, attacked each other, leaving 11 people injured.

The injured were rushed to Mollahat Upazila Health Complex where doctors declared Anisur dead.
