
Anniversary of Dr Moin Uddin's death today CITY DESK

Seven people were killed and 30 others injured in separate road accidents in the country yesterday and Saturday.

Staff Chittagong correspondent reports, a passenger was killed and the rickshaw-puller injured when a truck hit the rickshaw at Baluchhra in Chittagong city yesterday.

The deceased was Md Solaiman, 35, of Savar. Injured Md Sumon is undergoing treatment at Chittagong Medical College Hospital.

Our Lalmonirhat correspondent reports, a passenger was killed and 25 others were injured as the bus fell into a roadside ditch at Mohendranagar in Lalmonirhat Sadar upazila yesterday.

The deceased was Manowara Begum, 42, of Kaliganj upazila. Six of the injured were admitted to Rangpur Medical College Hospital while the others to Lalmonirhat Sadar Hospital. Our Moulvibazar correspondent adds,
