JS to exist, but not in session

Polls within Jan 24, PM tells top bureaucrats; cabinet to function but won't take any major policy decision

Amid confusion over the polls-time administration, Prime Minister Sheikh Hasina yesterday said the general election would be held without dissolving the current parliament and the cabinet.

She added the polls would be held within the last 90 days of the parliament's tenure, which ends on January 24.

But the prime minister did not specify the polls date, Cabinet Secretary Mohammad Mosharraf Hossain Bhuiyan told journalists after the PM's meeting with the secretaries at the Cabinet Division.

In the meeting, Hasina said the House would not be in session and the

cabinet would take no important policy decision during the 90-day timeframe (October 27 to January 24). She also advised the secretaries to study how transition of powers takes

place in other parliamentary democracies. The main opposition BNP has been pressing for dissolving the House and restoring the non-party caretaker government system before holding the election.

Like in the past, Hasina in yesterday's meeting rejected the demand, saying polls would be held under the constitutional framework. She also directed the secretaries to prepare themselves for the election.

Confusion has been running high for the past several months over the role of members of parliament and cabinet in case the election is held under the present administration.

Hasina, also president of the ruling Awami League, recently told the nation that parliament would be dissolved before the election.


But she changed her mind after consulting with her cabinet colleagues

Hurt deep down Buddhist heart

PM to reopen repaired temples in Ramu, Ukhia today; still may not see many happy faces

When Prime Minister Sheikh Hasina visits Ramu today, she can expect to see some happy faces, as the government has rebuilt 19 Buddhist temples that were torched and vandalised in Ramu and Ukhia in September last year.

But the question remains how safe do the victims feel when the main culprits behind the attacks on the Buddhist community are moving freely.

Ramu's roads and alleyways are swarmed with huge banners and festoons showing portraits of several of the men, whose involvement in the attacks was confirmed by two probe

HALL-MARK'S TK 2,964CR SWINDLING

A year on, Sonali mulls litigation

Sonali Bank is finally making moves to sue the owners of Hall-Mark Group and some bankers for realising Tk 2,554 crore swindled from the bank more than a year ago.

The bank's board of directors at a meeting last week directed its management to take initiative to file cases after the bank's lawyers alerted it to a time-bar for filing cases, said a high official at the bank.

Bangladesh Bank in May last year detected the country's biggest banking fraud in the state-run bank. The forgery took place between 2010 and 2012, when the controversial business group took the loan amount from the bank on forged documents. The Anti-Corruption Commission has already lodged 11

cases against several officials of Hall-Mark Group and Sonali Bank. In March, the finance ministry had asked the bank to

suggest ways to resume operations of Hall-Mark Group, including rescheduling the loan. The move faced strong criticism from different quarters.

Instructed by the ministry, Sonali Bank later appointed six lawyers for their opinion about six matters including legal steps and rescheduling of the loan.

Voter list without war crimes convicts

Govt to amend law in

next JS session

The cabinet approved yesterday a proposed amendment to the electoral roll law to bar convicted war criminals from being registered as voters.

As per the proposed change, the name of a person will be excluded from the electoral roll or will not be included in it if he or she is found guilty under Bangladesh Collaborators (Special Tribunal) Order, 1972 and International Crimes Tribunal Act 1973. The approval was given at a cabinet meeting held with

Prime Minister Sheikh Hasina in the chair at the Secretariat,

Cabinet Secretary M Musharraf Hossain Bhuiyan told journalists. The government will place a bill in the upcoming session
