Pabna villagers beat two 'outlaws' dead

Villagers beat dead two 'outlaws' at Hadol village in Faridpur upazila yesterday and the day before.

The deceased are Kazem Uddin, 30, son of Sohrab Ali of Dublapara village in Chatmohar upazila and Abdul Aziz, 35, son of Abdus Samad of Hadol village.

Of them, Kazem was a regional leader and Abdul Aziz was an activist of outlawed Sarbahara Party.

Officer in charge of Faridpur police station SM Faruk Hossain said, villagers caught Kazem at Hadol Bazar yesterday noon when he went there to collect illegal toll from the traders and beat him to death on the spot.

Police recovered the body and sent it to Pabna Medical College Hospital morgue for autopsy.

Faruk Hossain said, outlaw Aziz was on the run since long. On information that he

had returned home, villagers at about 10am on Sunday, condoned his They caught him and

beat up mercilessly near the Hadol madrasa. Critically injured, he was taken to Pabna Medical College Hospital where the doctors declared him dead.

Aziz was one of the most wanted criminals and accused in many cases including for murder, said the OC.

A case was filed against 1000 unnamed villagers on Sunday night in connection with the killing.

Sources said, at least 11 people were beaten dead by the villagers in Hadol and said.

Villagers besiege PS demanding arrest of rapists

People of Dakkhin Balapara village in Lalmonirhat district besieged Aditmari police station on Sunday, demanding arrest of the culprits who raped a housewife on Friday.

Earlier on the day, they brought out a procession in favour of their demand, reports our correspondent.

Police and locals said, a gang of four entered the house of a woman in Aditmari upazila on Friday morning and raped her when her husband was at his workplace.

Hearing the hue and cry, locals rescued the housewife in unconscious condition and sent her to Lalmonirhat Sadar Hospital. However, the rapists managed to flee.

The following day, victim's brother-in-law filed a case with the police station against Abdul Batan alias Baten Kosai, 42, Manzu Miah alias Manzu Kosai, 39, Manzurul Islam alias Monju Kosai, 38, and Maniruzzaman Miah alias Mantu Miah, 44, of the village, in this connection.

The villagers laid a siege to the PS on Sunday night as police seemed reluctant to arrest the rapists, alleged

Refuting the allegation, officer in-charge Aslam Iqbal said police were raiding different areas to arrest the accused.

The victims were sent to Patuakhali General Hospital for Medical test, reports our correspondent.



Dhaniram community centre-cum-flood shelter in Phulbari upazila is facing a serious threat of erosion by the River Dharla, much to the worry of local ultra-poor

people. Local Government Engineering Department (LGED) constructed the three-storied centre with the facilities of electricity at Dhanirum villages in 2009

to shelter hundreds of flood victims.

The shelter now may go into Dharla anytime as the onslaught by the river is going on very close to the centre, said Altaf Hossain, chairman of Barobhita union parishad.

He also expressed deep concern as over 200 floodhit people take shelter at the

centre every year. Despite repeated pleas, the authorities are yet to

take any steps to protect the centre from the erosion, said the chairman.

"Where we will take shelter in the upcoming flood period if the lone shelter goes into the river' said Noor Jamal, 60, a flood-victim, who is now

living on the embankment. We see no way to save the shelter as the river is closing to it, said upazila nirbahi officer Sheikh Mohammad Balayet Hossain.

6 held in UZ chairman killing case

Police arrested six people early yesterday for their alleged involvement in the killing of Forkan Uddin Mridha alias Pahari Selim, 40, chairman of Dhubaura upazila parishad, on Sunday evening.

The arrestees are Murad Hossain, Milon, Idris Ali, Abdul Jalil, Emran Hossain and Al Amin. They were yesterday produced in a Police also seized one court that sent them to jail, courts sources said.

Forkan Uddin, also general secretary of Awami League upazila unit, was killed and 10 others were injured in an intra-party clash at Panchanandapur in the upazila on Sunday evening.

The clash ensued following a programme arranged to mark the upgrading of the 30-bed Dhubaura Upazila Health Complex to a 50-bed one. When Azizul Haque Khan, general secretary of Gamaritala union AL, tried to enter a venue where VIP guests were having lunch around 2:00pm, Mridha and his supporters obstructed him. At one stage, Mridha's brother Maznu beat up Azizul Haque.

After the incident, the upazila administration imposed Section 144 to avoid any further incident. In the afternoon, the supporters of Mridha and Azizul Haque equipped with lethal weapon locked in a violent clashed at Panchanandapur, defying Section 144, leaving 11 people from both sides injured, witnesses said.

Seven of the injured, including upazila parishad chairman Forkan Uddin Mridha, were rushed to Mymensingh Medical College Hospital where Mridha succumbed to his injuries in the evening, policesaid.
