Biswanath hartal passes off peacefuly

An eight-hour hartal, enforced by Biswanath upazila unit of BNP demanding immediate release of 92 leaders and activists, passed off peacefully in the upazila yesterday.

The upazila unit BNP leaders earler called the shutdown from a rally on August 24.

On August 23, a court here sent the leaders and activists to jail after rejecting their bail prayers in a case for attacking police in the upazila during a countrywide hartal on April 23 this year.

The hartal was called to press the outhorities to make clear the whereabouts o missing party central organising secretary Ilias Ali.

Ilias Ali disappeared from the capital city on the night of April 17 last year. The incident still remained a mystery as the law enforcers are yet to make any headway in the matter.

During the hartal, two JCD men and one Jubo Dal activist were killed in a clash with police, said party sources.

Local BNP leaders and activists yesterday brought out a procession and held a rally in the town. Upazila unit president Jalal Uddin chaired the rally.

Alamgir Murder Case in Satkhira

12 Jamaat-Shibir men held

Border Guard Bangladesh (BGB) and police in a joint drive yesterday arrested 12 Jamaat-Shibir men in Garanbaria area of Debhata upazila in the case for the killing of Sramik League leader Alamgir Hossain on August 16.

The arrestees are Hasan Tarafdar, 48, of Kamta village in Kaliganj upazila, and Abul Hasan, 28, Anisur Rahman, 28, Shariful, 26, Abdur Gaffar, 25, Abu Raihan, 22, Sofet Ali, 24, Mahfuz Ahmed, 24, Ashraful Haq, 25, Rabiul Islam, 26, Golam Mostafa, 22, and Md Mohiuddin, 25, of different villages in Debhata upazila.

Law enforcers led by Executive Magistrate Rezaul Karim conducted the drive in the area from 7:00am to 12:00 noon and arrested the Jamaat-Shibir men. They are among the 200 accused in the murder case, police said.

During the drive, Jamaat-Shibir activists barricaded the road by felling logs. They also blasted cocktails and hurled brick chips at the law enforcers, prompting them to fire tear gas shells and blank shots.

Alamgir Hossain, 48, vice-president of

Sramik League Debhata upazila unit, was hacked by Jamaat-Shibir men in Garanbaria area on August 13. Critically injured Alamgir was admitted to the upazila heath complex and then shifted to Dhaka Medical College Hospital where he died on August 16.

Sramik League leader Md Shahidullah filed a case with the Debhata Police Station on August 14, accusing 33 identified and 167 unnamed Jamaat-Shibir men. The case was later turned into a murder case.

Discontent brewing as first cousin of Bangabandhu's killer made GS

Discontent among the activists of Rangabali upazila unit of Jubo League is brewing as Md Abir Hossain Talukder alias Sajol Talukder, first cousin of Major (dismissed) AKM Mohiuddin, one of the killers of Bangabandhu Sheikh Mujibur Rahman, has been made general secretary of the unit.

Mohiuddin and four other killers of Bangabandhu were hanged at Dhaka Central Jail in the early hours of January 28, 2010.

The new committee of upazila Jubo League was formed in an extended meeting held at upazila Awami League office on Saturday (August 31) with Humayun Kabir Talukder as president and Md Abir Hossain Talukder alias Sajol Talukder as general secretary.

Md Monir Hossain, former president of Borobaishdia union jubo league, said a conspiracy is going on to rehabilitate family members and relatives of the killers of Bangabandhu. Dedicated leaders and workers of the party are aware of such conspiracy and they will thwart the evil plan, he added.

Md Reaz Howlader, a member of the immediate past convening committee of upazila Jubo League, said it's a matter of great regret that family members and relatives of the killers of Bangabandhu is being rehabilitated in different wings of Awami League.

"We won't accept the committee where a brother of killer of Mohiuddin is holding a key post," Reaz said.

League Convener Arifuzzaman Roni said the list of the new office-bearers of Rangabali upazila Jubo League is yet to reach his office.

"I won't accept such a committee where a family man of a killer of Bangabandhu is holding a vital post," the convenor added.

Six held over militant links

Forty-five Bangladeshi teenage girls returned home on Monday after languishing in Indian jail for two years there. Indian authorities handed the girls over to the Bangladeshi immigration police at Benapole check post around 8:30pm. The returnees hailed from different areas of Khulna, Barisal, Chittagong, Narail and Gaibandha districts. Kamruzaman, officer in-charge of Benapole check post immigration police, said human traffickers took the young girls to India three years back, promising them to give good jobs there. However, they were arrested by Mumbai police and later sent to jail. Rescue Foundation, a leading NGO of India later freed them from Pune jail.
