# Tree looting denuding torests in all 8 Patuakhali upazilas

Criminals have continued tree looting from forests in all eight upazilas under the district allegedly with the connivance of a section of forest staff while the authorities are struggling to protect the natural resources with inadequate manpower and logistic support.

A gang looted over 200 trees from over three kilometre stretch of area (km) from Bhuria launch ghat to Dakkhin Char Moishadi under Patuakhali Sadar upazila early July this year,

said locals and sources of Patuakhali divisional forest "Informed by locals, I

requested the forest officials to take step against the tree looters but in vain," said Abdus Salam Mridha, chairman of Kamlapur union parishad (UP). A gang allegedly aided by

three forest staff felled and looted over 300 trees from Baher Char area in Amkhola UP under Galachipa upazila from July 14 to July 19, locals told journalists and forest officials. After hearing the matter,

Divisional Forest Officer

(DFO) Mihir Kanti Do visited the spot and seized 40 pieces of trees at night on July 19. At the same night a team of forest seized a trawler loaded with stolen trees from Lohalia River

### 2 housewives murdered

Two housewives were killed allegedly by their husbands and in-laws in Rangpur and Bogra districts on Wednesday.

A housewife was stabbed to death allegedly by her husband at Jugitari area in Rangpur city on Wednesday night. She was identified as

Salma Begum, 21, wife of Mahmud Ali, 28 and an employee of Rangpur Foundry Limited, reports our correspondent. According to the family

sources of the deceased, Mahmud was a drug addict and often tortured Salma for money, they said. At around 10:00pm on

Wednesday, Mahmud demanded money from his wife in front of their residence while Salma was returning from her office.

They locked in a quarrel as Salma refused to give money.

At one stage, Mahmud stabbed his wife indiscriminately with sharp weapon, leaving her critically injured.

Hearing her screams, locals rescued in and took her to Rangpur Medical College Hospital where she succumbed to her injuries the same night.

In Bogra, a housewife was killed allegedly by her inlaws at remote Shanpacha Char of Jamuna River under Shariakandi upazila on Wednesday night. The deceased was identified

as Mohiful Begum, 25, wife of day labourer Shukur Ali and daughter of Sholaiman sheikh of the village, reports our correspondent. Police said they recovered

the body of Mohiful from a bamboo cluster in the morning. The body bore marks of injury, they said.

Mohiful's father alleged that her daughter was beater to death by in-law while the in-laws claimed that she died from snake-biting.

# Punish offenders, pay damages to victims

Demand Khagrachhari protesters

Democratic Youth Forum (DYF), Pahari Chhatra Parishad (PCP) and Hill Women's Federation (HWF) have demanded exemplary punishment to the people involved in torching and looting of the houses of indigenous people and vandalising two Bhuddhist monasteries in Matiranga upazila of the district on August 3.

Leaders of the three front organisations of United People's Democratic Front (UPDF) also demanded Tk 10 lakh to rebuild each of the houses burnt down by the attackers, food rations for the victims for five years, and Tk 6 lakh in compensation for the affected families. They made the demands at a protest rally

held in Mahajanpara area of the district town yesterday. Prior to holding the rally, the leaders and activists of the organisations took out a procession in the town and paraded the main streets. The speakers at the rally criticised the

government for not taking steps to rebuild the torched houses and pay compensation to the victims even one month after the attack.

The Padma was flowing above 11 centimeters above its danger level while Mahananda flowing above 19 centimeters of danger mark yesterday, said an official of Water Development Board (WDB) in the district.

The water levels of both the rivers are increasing alarmingly and if it continues, more people will be marooned in the next 24 hours, he said.

A large number of flood-hit people have already taken shelter on embankment and high lands. They are facing acute crisis of food, fuel and drinking water.

Many educational institutions suspended their academic activities as floodwater entered the classrooms.

Deputy commissioner Sardar Sarafat Ali said, local administration prepared a list of over 40,000 worst affected poor people for relief. We have already started distribution of relief among the poor, he said.

Besides, two medical teams have been formed to look after the flood victims, said the DC.

He further said that a few low lying areas of the municipality have been submerged. At least 40 families of the town took shelter at stadium.

The floodwater also damaged Aus paddy on about 6.83 thousand hectares and vegetables on 530 hectares in the upazilas, said officials at the District Agriculture Extension (DAE).
