4 abducted fishermen rescued, arms seized

Coastguards rescued four fishermen, kidnapped for ransom a few days ago, following a gunfight with forest robbers in Dudmukhi canal under Sharonkhola range in the Sundarbans in Bagerhat district yesterday.

The law enforcers also seized four firearms, 77 bullets and a sharp weapon from the spot, said a press release issued by operation officer Lt. Commander M Mohiuddin Mojumder of Coastguard Mongla west

Acting on a tip-off, members of the coastguard surrounded the spot on Dudmukhi canal from 4.00am to 9.45am yesterday and later swooped on the den of the notorious 'Shirsho Bahini' led by robber Rezaul in the area.

Sensing the presence of the coastguard members, the robbers opened fire, prompting the law enforcers to retaliate.

After an hour-long gunfight from 7:30am, coastguards rescued the four abducted fishermen and seized one single barrel gun, three shooter guns, 77 bullets, one billhook and a boat from the den while the members of the gang managed to flee the scene.

The rescued fishermen are Md. Sekender Fakir, 36, son of Md. Kutub Uddin, Md. Aziz Sheikh, 26, son of Motaleb Mia, Md. Abu Zafar, 22, son of Farid Uddin and Md. Zalal Uddin, 40, son of Sohag Mia of Sonaitala village under Mongla upazila in Bagerhat.

The rescued fishermen were taken to a safe place while the seized arms and ammunition deposited in Sharonkhola police station.

Tree looting from reserve forest on near Kuakata

A gang backed by a section of influential people have continued to loot trees from Gangamoti reserve forest near Kuakata. The gang cut down five

trees on Friday night and Saturday. They also took away 7 more trees 15 days ago from the same area. Locals said five rain trees,

each over 20 years old, were felled by a gang on Friday night and Saturday morning. On hearing the news that

a gang cutting down trees on the flood control dam at Char Kawa under Gangamoti reserve forest, a team of local newsmen visited the spot on Saturday morning. They found two woodcutters, Faruque Akon and Khokon Howlader of same village, were engaged to fell the trees. The team identified at least five trunks of trees that were cut down by the gang.

Both the woodcutters told journalists that they were hired by some Humayun Jomaddar and Hemayet Hossain Pannu of the area.

Earlier, the same gang was found off. However, Hemayet Hossain Pannu was available who said that some trees damaged during Cyclone Mohasen have been kept under their custody by forest men.

Polybags, urea seized

Polythene bags worth Tk. 30 lakh were seized from a market in the district town on Sunday. Acting on a tip-off, a mobile court led by executive magistrate Md. Police arrested the truck driver and sent him to Dinajpur jail on Sunday.

2 BNP-Jamaat leaders attacked

Witnesses said, a group of armed activists of the youth front of the ruling Awami League, numbering 7/8, swooped on Zamirul and Sirajul and blugeoned them and also stabbed them as they allegedly were making objectionable remarks about Awami League while gossiping at a tea stall at night. Critically injured, they were admitted to Jessore Medical College Hospital.
