Chamber judge Justice MA Wahhab Miah refused to halt the HC verdict after hearing a petition filed by Omar Faruq seeking a stay on the verdict.

Anti-Corruption Commission (ACC) counsel Khurshid Alam Khan told The Daily Star that Omar Faruq could not withdraw money from the accounts following the SC

AVOIDING UNGA MEETING

PM wants to evade answer on polls

Say senior BNP leaders

Senior BNP leaders yesterday said Prime Minister Sheikh Hasina had decided not to attend the 68th UN General Assembly (UNGA) meeting due in end-September, as she could not give any satisfactory answer to the UN authorities over the upcoming general election.

Addressing a rally of the party's Dhaka city unit at the capital's Suhrawardy Udyan, the leaders also alleged that the decision had hurt the country's dignity.

The prime minister disclosed the decision at the cabinet meeting on Monday. BNP standing committee member Khandker Mosharraf

Hossain said the prime minister did not follow the UN's proposal for holding dialogue to ensure all parties' participation in the polls. "She could not answer when UN chief Ban Ki-moon would ask her about the proposal."

BNP acting secretary general Mirza Fakhrul Islam Alamgir and the party's city unit convenor Sadeque Hossain Khoka, among others, spoke on the occasion.

They also accused the government of hatching a conspiracy to file "fake" cases against Nobel laureate Muhammad Yunus. Meanwhile, BNP Joint Secretary General Ruhul Kabir Rizvi yesterday demanded scrapping of the proposed

Women in 20-24 Age Group

64pc victims of child marriage: Study

Around 64 percent of all women aged between 20 and 24 in Bangladesh were the victims of child marriage, shows a nationwide survey.

The occurrence of child marriage is

higher in rural areas than in urban areas, and education significantly contributes to the elimination of this curse, says the report, which was launched at a hotel in the capital yesterday. Plan International Bangladesh and

International Centre for Diarrhoeal Diseases Research, Bangladesh (ICDDR,B) jointly carried out the survey between July and August last year, when 5,367 married

women were interviewed across the country. Around 86 percent women of this age group who did not go to school were married off at early age and the wish of the parents or family was the reason for their marriage, said Dr Quamrun Nahar, associate

scientist of ICDDR,B, while presenting the findings.Based on the report, she placed a series of recommendations to end child marriage. These include strict enforcement of existing laws, implementation of online birth registration, and improvement of girls'

The other recommendations are increasing awareness of families and communities, fostering children's agency in preventing child marriage, involving men and boys as key agents to stop child marriage, investing in girls' education and adolescents' sexual and reproductive health.

Addressing the function as chief guest, Meher Afroze Chumki, state minister for women and children affairs, said lack of awareness and poverty were the key reasons for child marriage. She emphasised awareness building and training of community leaders to eliminate child marriage and dowry system.



11 jailed for illegal herbal business

A mobile court of Rapid Action Battalion yesterday sentenced 11 people to one-year imprisonment for running an illegal herbal medicine business and sealed three shops in this connection in the capital's Farmgate.

Sharif Forhad, executive magistrate of Rab-10, who led the court, said they recovered illegallyproduced herbal items worth Tk 10 lakh from the three shops.

The arrestees used to campaign for the herbal medicines through singing songs and performing magic tricks. Once someone shows interest, they take him to their office "The Khan Kabiraj Ghar", he added.

The office was where the criminals used to instigate physical relationship between the customers and women as proof of how sexually powerful the client had become after taking

their medicine, he added. Some of the "medicines" are harmful to the skin, said Md Aziulla, an official of Drug Administration.

Woman strangled in Ashulia

Body found at Jubo League leader's house

A woman was found strangled at a house of a Jubo League leader at Bogabari in Ashulia, on the outskirts of the capital, yesterday. The deceased Farjana Akter, 19, daughter of Abdul Mazid of

Fulbaria in Maymensinh, was wife of one Uttam, 27, of Dinajpur. Ashulia police recovered the body yesterday morning from the house of Mansur Alom alias Mansur Madbor, joint-secretary of Ashulia Thana unit of Jubo League, the ruling Awami

League's front wing. Mansur, also a jhut (scraps of fabric) trader, used the house only for his business and political purposes.

Sheikh Badrul Alom, officer-in-charge of Ashulia Police Station, said Farjana and Uttam had been living separately for the last few months.

Shafiqul Islam, 27, a cellphone trader in the area, said Farjana came to Ashulia from Dinajpur with her husband one year ago and started a beauty parlour on the first floor of Mansur Market, owned by Mansur. Shortly, Mansur, a married man, made a relationship with

Farjana and she started living in a room of the house, at least half a kilometre off his family residence, said another local Monir Hossain, 35.

Recently, Mansur had a quarrel with Farjana as his family could not tolerate the relationship, said Mansur's younger brother Masud Ahmed Madbor.

Masud claimed Uttam fled the scene after killing Farjana. Denying the allegation Uttam told The Daily Star over the phone that he was currently living in Sylhet as Mansur's

Despite repeated attempts, Mansur could not be contacted for comments. Sub-inspector Abul Kalam Azad said the woman might have

accomplices beat him and got him out of the area.
