A well furnished house at the railway staff quarters beside the residence of Lalmonirhat railway divisional engineer in the town is being used for pastime following its illegal occupation allegedly by ruling Awami League (AL) men a month ago.

A district level leader of AL also inaugurated a club named "Winner Club" at the flat beside Balatari Shishu Park in Lalmonirhat town in the middle of last month.

"The railway staff quarter flat has been occupied in the name of a so-called club that is yet to see any committee. Nobody dare protest leader inaugurated it," said a local AL leader seeking anonymity.

FALLOUT OF PRICE DIP

Farmers stop drawing potato from cold storages in Dinajpur

Farmers in the district have stopped drawing potato from cold storages as price of their produce continues to fall in wholesale and retail markets.

According to the officials of the Department of Agriculture Extension [DAE], around 7.5 lakh tonnes of potato were produced on 40,000 hectares of land in the district during the last season.

As the price was low at the beginning of potato harvest time, the farmers stored their produce in the cold storages, hoping that the

price would go up gradually in the wholesale and retail markets. Md Abdur Razzak, a

potato grower of Birganj upazila, said he stored 200 sacks (each contains two maunds) of potato in Rahbar Cold Storage in the upazila. He had to spend Tk 800 to produce each sack of potato and pay Tk 360 as cold storage charge for the same amount.

"One sack of potato in toes. local market is priced at Tk 700. So, I have to incur Tk 460 (market price +cold storage charge) for each sack," Razzak said, added that he has stopped drawing potato from the cold storage

to avoid further loss. Cold storage operators

said the farmers and traders usually collect their potatoes in August, but they are not coming ever in September to draw potatoes. Azizur Rahman Hiru,

manager of Rahbar Cold Storage, said they need to operate the cold storage for extra time as farmers are yet to come to draw their pota-

While visiting a local market yesterday, this correspondent found that potato was being sold for Tk 7 to 9 per kilogram, while it was sold at Tk 18 to 22 last year.

Rape case recorded finally

Police have finally recorded the case filed by the father of a gang-raped victim of Baro Kamlabari village in Aditmari upazila of the district.

However, the accused remained out of police dragnet.

The case was filed with Aditmari Police Station on September 5, but police recorded the case yesterday.

The accused in the case are Rezaul Islam, 25, Fazar Ali, 23, Habibur Rahman, 24, of the village under Aditmari upazila, and Alamgir Hossain, 26, Ashraful Islam, 23, and Ashiqur Rahman, 24, of Nilphamari district.

The victim, a class seven student of a local madrasa, fell in love with Ashiqur Rahman, who works at a bridge construction site at the village.

Ashiqur Rahman with the help of five others took the girl to a hotel in the capital on September 1. She was gang raped by the six for three days and sent back home at Kamlabari village on the night of September 4.

Family took the madrasha girl to Lalmonirhat Sadar Hospital the same night and her medical test was done yesterday, said Dr Nabiur Rahman, resident medical officer of the hospital. Contacted, Officer-in-

Charge (OC) Aslam Iqbal of Aditmari Police Station said they recorded the case after getting medical test and investigation reports. Police have launched a drive to arrest the accused, the OC added.
