Govt denies EC more clout

Polls expenditure to go up, parties to get more donations as cabinet okays changes to RPO

The government yesterday approved a set of proposals for bringing changes in the Representation of the People Order, but ignored a few others that the Election Commission proposed for having more clout to conduct general election.

The approved proposals include increasing the ceiling of candidates' election expenses and their security deposits and donations for political parties, according to a copy of the proposals that the law ministry prepared for yesterday's cabinet meeting.

The cabinet, however, didn't decide on the proposal for lessening the punishment for election offences. The EC made the proposal so that executive magistrates, alongside judicial magistrates, could hold trial for electoral offences.

Some of EC's proposals were not placed before the cabinet, as the law ministry didn't include them in the draft bill for amending the RPO.

Before the preparation of the draft bill, the law minister held meetings with two advisers to the prime minister and some senior Awami League leaders to examine the EC's proposals for electoral reforms ahead of the general election, according to media reports.

The commission's proposal for awarding punishment to individuals for furnishing false information or concealing any information in the nomination paper or in the affidavit was excluded from the draft bill. The EC had proposed that an individual would be disqualified for

contesting the parliamentary polls for such offence. The proposal for introducing electronic voting machines in the polls

also didn't find its place in the draft bill. The EC also suggested a provision for punishing individuals and government officials for negligence in duties assigned by the commission or for their refusal to assist it. And the offender would be sentenced up to three years' imprisonment or fined Tk 50,000 or both.

ACC appeals to HC

The Anti-Corruption Commission (ACC) yesterday filed a petition with the High Court, seeking cancellation of the bail to Hall-Mark Group Chairman Jasmine Islam because she broke her bail condition.

A trial court in Dhaka on August 4 granted bail to Jasmine, wife of the group's Managing Director Tanvir Mahmud, in 11 corruption cases after she pledged to pay back Tk 2,600 crore in monthly instalments of Tk 100 crore.

BNP Chairperson Khaleda Zia yesterday said the opposition alliance would wage a "new type of movement" after October 25 if the government did not restore the caretaker government system in the constitution within the time frame.

"Our ongoing movement will continue till October 25 and [in the meantime] Eid-ul-Azha will also be celebrated. But the government will have to face dire consequences if it doesn't accept our demand within this time frame," she told a mammoth rally at



the Rajshahi Madrasa ground.

Khaleda, who is the chief of the 18party opposition alliance, called upon all political parties outside the alliance to constitute a united platform and wage a movement to topple the incum-

bent government.

"It's not the time to stay away. Let us all sit together, don't think who is superior or inferior, who is to the right or left. It's not the time to think about who had been a big leader in the past. Our only aim is to remove the Awami League government from power and save the country," she said.

Although the BNP chief at a rally in Rangpur on Sunday declared that she had come there not to seek votes, but to drum up public support to foil the government's bid to hold a unilateral election, many BNP lawmaker

Plant to use saline water

Green campaigners still concerned

Taking into account concerns of environmentalists, the proposed massive 1320 megawatt coal power plant in Rampal close to the Sundarbans will use surface water from the Passur river so that the project does not affect underground water table. The water after use will be recycled

through a closed cycle cooling system to avoid any harm to the ecology. Excessive use of groundwater at the

Bengal has caused underground water tables to dry up, wrecking havoc on people of adjacent villages.

Barapukuria power plant in north

Besides, environmentalists like Bangladesh Environment Lawyers Association and Bangladesh Poribesh Bachao Andolon have also expressed concern over the use of underground water at the Rampal power project.

The Environment Impact Assessment (EIA) of the Indo-Bangla joint venture power plant recom-

mends installing a central effluent treatment plant at the project site to treat the saline water of the Passur river before use and then recycle it through the cooling system.

Abdul Matin, secretary general of Bangladesh Paribesh Andolon, said the EIA report had been prepared incorporating false information.

"Initially, they said they would use groundwater at the plant. But later they cancelled the idea due to criticism by

Modified brinjal found okay

An expert committee has termed sound all scientific findings concerning the country's first genetically modified (GM) crop -- Bt Brinjal -- and is now preparing its review report on those for forwarding it to the agriculture ministry, officials said yesterday.

No right to vote or run in polls
