Frustrated growers set unsold jute on fire

Protest in front of BJMC purchasing centre

As jute prices continue to fall in local markets, growers yesterday staged a demonstration in front of BJMC purchasing centre at Mohimaganj in

Gobindaganj upazila and set fire to their unsold raw jute.

Good yield of jute fails to make the growers in the district happy as the prices see a declining trend. Early this season jute sold for Tk

1400 to 1500 per maund but now it is selling for Tk 900 to 1050 in the local markets.

As the number of buyers is poor in the markets, growers return home disappointed with their unsold jute.

Jute procurement by the government has remained stopped at Mohimaganj for the last few years. This year, Alim Jute Mills has opened a purchasing centre here as an agent of BJMC and started purchasing raw jute from farmers on August 6.

The agency has so far procured jute worth Tk 1.13 crore on credit from growers and traders. It has paid up outstanding bills amounting to Tk 10 lakh till date. So, a good number of growers and traders are yet to get Farmers said jute prices in

"We have already sought a fund of Tk 1.3 crore from the mill authorities to clear dues," said Khairul Islam, in-charge of jute purchasing centre at Mohimaganj.

WHERE DOES THE HILSA GO?

Although the catches are still poor from the Padma and Meghna rivers, the wholesale hilsa markets in Chandpur have become flooded with the delicious fish from the coastal Barisal, Bhola, Barguna, Patuakhali and other districts. Traders say, in the last couple of days, at least two thousand maunds of hilsa worth about Tk 4 crore (at the rate of minimum Tk 20,000 a maund) came to Chandpur every day. However, nobody including the officials of the fisheries department here could say how or on what conditions the 35 wholesalers sell the fish to the exporters and their middlemen. Sources said, many exporters are either freezing the fish due to the on going ban on export or sending a portion to different cities in the country for better profit. Also, the allegation is rife that a huge quantity of the fish is regularly smuggled out, keeping the price, especially of the bigger ones, out of the reach of the local consumers.

BSF Laurergar camp in-charge Subedar Md Abdul Hai told BGB that a flag meeting would be held in this connection.

Four get life for killing

Additional District and Session Judge Mohammad Abdul Hamid yesterday sentenced four people to life term imprisonment and fined Tk 20 thousand each, for killing a man in 2001. The convicts are Mohammad Abdul Mazid, Mohammad Lalu Mia, Mohammad Dulu Chowdhury, and Abdur Rouf of Rupchandrapur village under Atpara upazila in the district. The case in brief is that, on November 30 in 2001, the four killed one Tuta Mia, 35, of same village with sharp weapons due to previous enmity. Kulsuma Akther, younger sister of Tuta Mia, filed a killing case accusing the four with Atpara PS.

Fake dollar seized

Police arrested an army man along with 80 pieces of fake US 100-dollar notes from a money exchange in Shatmatha area of the town on Tuesday evening. An employee at the money exchange said when the man insisted on exchanging the dollars too quickly the salesman suspected fake dollars and tactfully informed the police. Poor navigability disrupts Mawa ferry services

Ferry services on the Mawa-Kawrakandi route yesterday disrupted again, this time due to navigability problems in the Padma River.

At least 300 vehicles, including many goodsladen trucks, remain stuck on each sides of the route a day due to partial ferry service.

ghat of Bangladesh Inland Water Transport Authority (BIWTA) Sirajul Haque said, out of the total 16, only six ferries were running on the route for poor navigability at Lauhajang point of the river.

Strong currents in the river has added to the situation.

A dredging work has been planned to resolve the pres-

ent problem by removing Manager of Mawa-based silt from Lauhajang and other points, he said. A survey is going on to examine the feasibility, he added.

While hundreds of passengers continue to suffer, traders from the southern districts are counting heavy losses as a large number of goods-laden vehicles remain stranded for days at the ferry points.

Patuakhali Science & Technology University

Probe into alleged illegal appointments starts

A committee has started to probe the alleged illegal appointments of staff at Patuakhali Science and Technology University during the tenure of immediate past vice chancellor Syed Shakhawat Hossain.

The three-member body, headed by UGC member Prof Mohabbat Khan, on Sunday and Monday examined various records and quizzed a number of staff including the incumbent VC Shamsuddin, registrar Nawab Ali Khan, deans and heads of different departments.

On December 27 last

year, the University Grants Commission (UGC) formed a probe committee to investigate the alleged irregularities in appointments of a large number of staff from 2008 to 2012, said Mohabbat Khan.

During the last three working days from December 17 to 19 last year, the former VC appointed 119 officials and employees against 14 posts mentioned in the newspaper advertisement, said university sources.

The posts include one each of deputy registrar, assistant registrar, assistant librarian, accountant, assistant engineer (electrical), deputy assistant engineer

(civil), senior assistant for the office of the registrar, senior assistant for budget section, and six section officers. However, the authorities

appointed 33 against those posts, said the sources.

Eighty-six other people including seasonal, part time and master roll employees were also appointed during December 17-19 although there were no such posts, it

added. Besides, a good number of teachers, officials and employees were appointed at the university allegedly through dubious means during the last four years.

Seeking a two-day adjournment yesterday, prosecutor Mohammad Ali, the conducting lawyer of the case, told the tribunal he would not produce

any more factual witness. In the adjournment petition, Ali said the 23rd witness, Syeda Salma Mahmud, who gave deposition on September 16, fell sick and therefore could not come to the tribunal.

"The 23rd prosecution witness was the last witness. I'll produce two seizure list witnesses and after that the IO [investigation officer] will give his deposition," said Ali in a bid to convince the tribunal for adjournment.

The tribunal adjourned the proceeding until Sunday. The defence will cross-examine Salma Mahmud on that day.

The prosecution produced their first witness in Nizami's case on August 26, 2012, and in the last 22 other witnesses.
