"It's a rare victory" of Angela Merkel, he said, "because she is highly respected political figure in Germany and voters' enormous confidence in her." She successfully handled the Euro zone crisis, Albrecht

The envoy said Merkel might face difficulties to form her new government since her party failed to get an absolute majority. She will have 30 days to find a suitable partner to form a coalition government and win the confidence of the Bundestag, the German parliament. But if she fails she will inform the German president to hold a fresh election, he added.

HC seeks number of ETPs set up since 1996

The High Court yesterday sought a report on how many effluent treatment plants (ETP) have been established by industrial organisations in greater Dhaka, Gazipur, Savar and Tangail since 1996.

The director general of Department of Environment has to submit the report to the HC in two months, the court said.

In response to a writ petition, the court also ordered the director general of DOE to state in the report the amount it had fined the industries for violating the Bangladesh Environment Conservation Act, 1995 and relevant rules.

An HC bench of Justice Mirza Hussain Haider and Justice Muhammad Khurshid Alam Sarkar also stayed a notice issued by the DoE imposing a fine of Tk 1.5 crore to Pakiza Dyeing and Printing Limited, a dyeing industry at Savar, for violating the act.

The bench also issued a rule upon the officials concerned of the government to explain in two weeks why the notice issued against Pakiza Dyeing and Printing Limited should not be declared illegal.

The environment secretary, director general of DoE and its director (enforcement) have been asked to reply to the

The company filed the writ petition with the HC on September 22 challenging the legality of the notice issued by DoE on July 22. During hearing, petitioner's counsel Barrister Abdul

Halim told the court that DoE fined his client in violation of relevant provision law, as DoE cannot fine a company more than Tk 10 lakh.

He prayed to the court to seek the number of ETPs effective in greater Dhaka, Gazipur, Savar and Tangail and the amount of money collected by DoE so that it can examine whether the industries have establish ETPs to protect environment or DoE released them after collecting fines.
