

# Nusrat longs for mother's return

Six-year-old Nusrat Samia still lives in the vain hope that her mother is in hospital. She is too young to understand her mother is never coming back, even after witnessing her mother being crushed under a bus in the capital's Kamalapur area on Tuesday.

"Where is my mother? Why isn't she coming back?"—these are the questions she is badgering her family members with round the clock.

Right after the bus ran over Roksana Begum Laila, 37, killing her on the spot, onlookers whisked off Nusrat to Motijheel Ideal School where her two brothers study, to spare the tender heart the gory scene.

Meanwhile, Nusrat's father Saifullah Khan filed a case accusing the unidentified, absconding driver of the Ananda Paribahan bus, said Syed Ziauzzaman, officer-in-charge, Shahjahanpur Police Station.

Anisur Rahman, a paternal uncle of Nusrat, said Roksana's everyday life was centred on her three children, and she would never leave Nusrat to anybody else's care. "Had I got the driver and the bus owner, I would have asked them why three children's lives should be shattered only because of reckless driving," he said.

Roksana was returning home in Rayerbagh with Nusrat, a kindergarten student in Shantinagar, by a rickshaw. Nusrat's brothers Badir Rahman Leon, 11, and Mehedi Hasan, 14, study in class IV and class VIII.

Roksana will be buried in the capital's Matuail graveyard after Asr prayers today.

### Maitree train service shut Oct 15, 16

The biweekly "Maitree Express" train service between Kolkata and Dhaka will remain suspended for two days, on October 15 (Tuesday) and 16 (Wednesday), on account of Eid-ul Azha, Indian Railways announced yesterday.

The train departs Kolkata every Tuesday and Saturday and leaves Dhaka every Wednesday and Sunday.

"On request from Bangladesh Railway, Indian Railways decided to cancel the trip to avoid operational complications arising due to non-running of trains in Bangladesh on Eid days," an official statement said. Services will resume thereafter, it added.

### 27 law professionals remembered

### Woman killed by husband

A woman was strangled allegedly by her husband at her residence in the capital's Mughda on Tuesday.

The body bore strangulation marks but police are yet to find out the weapon, said Saifuddin, a sub-inspector of Mughda Police Station.

The victim, Nurunnahar, a garment worker, and her husband Altaf Hossain lived separately. However, on Tuesday Altaf visited Nurunnahar around 1:30pm, he said quoting Nurunnahar's father who lived with her.

The victim's father found the body around 3:30pm, he said, adding that Altaf is on the run.

A case was filed.

Tribunal to decide on contempt petition today

The International Crimes Tribunal-1 will decide today whether it will issue show cause notices to five officials of private television station Channel 24 and three others, asking for an explanation why contempt proceedings should not be initiated against them for commenting on the war crimes case against BNP leader Salauddin Quader Chowdhury.

SC HEARING ON APPEAL  
Sayedee urges two judges to quit bench

Convicted Jamaat-e-Islami leader Delawar Hossain Sayedee yesterday filed two separate petitions with the Supreme Court urging its two judges to quit from the five-member bench hearing his appeal challenging a death penalty given to him.

The International Crimes Tribunal (ICT)-1 sentenced Sayedee to death on February 28 for committing crimes against humanity during the 1971 Liberation War.

The two judges are Justice Surendra Kumar Sinha and AHM Shamsuddin Choudhury Manik.

In one petition, Sayedee said, as per "Skype conversations" between the tribunal's former head Justice Md Nizamul Huq and expatriate Bangladeshi legal expert

## JU crisis deepens

Teachers declare fresh strike from Sept 28 demanding VC's resignation

Jahangirnagar University (JU) teachers yesterday declared a strike from September 28 demanding the vice-chancellor's (VC) resignation as, they claimed, the probe report on the allegations against the VC missed its September 24 submission deadline.

If Prof Anwar Hossain did not resign by September 30, they will embark on tougher movements from October 1, said the teachers under the Sadharan Shikkhak Forum at a press conference on Tuesday.

Education Secretary Kamal Abdul Naser Chowdhury told The Daily Star last night that the committee had sought time till September 29, when the report would be submitted.

The two-member committee led by University Grants Commission member M

Muhibur Rahman was formed on September 2 upon a directive of President Abdul Hamid, also the JU chancellor.

The crisis began on April 6 when Bangladesh Chhatra League's JU unit General Secretary Rajib Ahmed Rasel assaulted a teacher.

The agitating teachers launched a movement on April 14 demanding the VC's removal for not expelling Rajib. They also accused him of doing anomalies in teachers' appointments, ruining the campus by taking up unnecessary projects, and misusing funds.

Since April 27, the teachers have been observing strikes at different times. Coupled with other shutdowns, this has caused nearly three months' of session jam.

Academic and administrative activities in the running session were suspended for 34 and 43

days respectively till date, stated the registrar building sources. The students claim the figures are much higher.

Moreover, the teachers have not been attending the meetings of the central admission committee and of the syndicate and finance body as these are headed by the VC.

Without holding meetings, the central admission committee is not being able to decide on whether to hold the 2013-14 session admission exams department or faculty-wise, although the schedule has been fixed from November 2 to 9.

The absence of syndicate meetings is barring MPhil and PhD candidates from getting admission and holding back evaluation of 70 theses while that of the finance body is barring 25 teachers from getting retirement allowances, added the sources.

## DEATH SENTENCE OF MOLLAH Pro-BNP lawyers urge reprieve

A pro-BNP lawyers' association yesterday urged the government not to execute the Supreme Court verdict against war crimes convict Jamaat-e-Islami leader Abdul Quader Mollah until his review petition is settled in that court.

"Article 105 of the constitution ensures the right of every citizen to move a review petition against any Supreme Court verdict. We want to see execution of this provision of the constitution, the supreme law of the country," said Barrister Moudud Ahmed, an adviser of Bangladesh Jatiyatabadi Ajnabi Forum (BJAF) and BNP leader.

He was placing a written statement at a press conference organised by BJAF at Supreme Court Bar Association in the capital.

The SC sentenced the 65-year-old Jamaat secretary general to death, overruling the February 5 judgment of International Crimes Tribunal-2, which had given him a life sentence for crimes against humanity during country's Liberation War in 1971.

The convict will file a review petition with the SC against his death penalty after getting the certified copy of the verdict, his lawyers said earlier, though the law minister

## KEEPING CHILDREN AWAY FROM HAZARDOUS JOBS Enforcing law urgent Seminar told

Proper implementation of laws is needed to stop children from getting involved in hazardous jobs in the country, said speakers at a seminar in the capital yesterday.

They said causes of child labour in the country have been already identified but those need to be addressed.

The seminar on child labour was jointly organised by International Labour Organisation (ILO), Terre des Hommes- Netherlands and Bangladesh Shishu Adhikar Forum (BSAF) in the Cirdap auditorium.

The speakers opined that overall economic development might reduce child labour in the country.

Referring to the national plan of action 2012-2016, a five-year government policy, Dhaka University's Dr Mohammad Nazmuzzaman Bhuiyan said there are 7.4 million children aged between five and 17 working in the country and among them 1.3 million are involved in hazardous jobs.

He pointed out that the government has published a list of 38 hazardous jobs for children through a gazette notification. "However, the list ignores agricultural activities, mining and quarrying, domestic work and the use of children to transport harmful goods including drugs, firearms and explosives," he said.
