Power import starts formally tomorrow

National grid to get 175 MW electricity from India

The much-talked about power import from India will get under way on a commercial basis from tomorrow through the addition of 175 megawatt (MW) of electricity to the national grid.

"Prime Minister Sheikh Hasina will formally inaugurate the electricity import at the power transmission centre in Bheramara. Indian Prime Minister Manmohan Singh will attend the programme through video conference," said Tawfiq-e-Elahi Chowdhury yesterday.

Tawfiq, energy adviser to the premier, was speaking at a press conference at the PID conference room in the capital.

The test supply of power began on September 27 when 50 MW of electricity were added to the national grid through a high voltage sub-station at Bheramara in Kushtia, said a senior official of the Power Grid Company of Bangladesh (PGCB).

Detectives are listing the people involved in preparing the draft verdict against BNP lawmaker Salauddin Quader Chowdhury, which was apparently leaked before the court delivered it. "We are trying to know

how a draft of a court verdict is prepared. We will interrogate all the people, who had involvement in the process, to find out the culprits behind the leak" said Joint Commissioner Monirul Islam of Detective Branch (DB) of Dhaka Metropolitan Police yester-

A 164-page document, which did not contain judges' observations or the sentence, was found online on Monday night with claims that a draft verdict had been leaked.

DB began an investigation after AKM Nasiruddin Mahmud, registrar and spokesman of International Crimes Tribunal (ICT), filed a general diary with Shahbagh Police Station in connection with the leak.

On Tuesday, ICT-1 Nasiruddin. awarded the BNP leader the death sentence for committing crimes against humanity and genocide in Chittagong during the Liberation War in 1971.

Immediately after the pronouncement of the verdict, his family members and defence lawyers told the media that the verdict had been available in a few websites before the tribunal delivered it. They also alleged that the

draft verdict had been retrieved from a computer of the law ministry and that it was written by the ministry itself. ICT the following day confirmed that an organised

killed in the February 25-26 mutiny. Hasina claimed that 33 of the slain army officers were from pro-AL families.

FROM PAGE 20 deadline for the amnesty, allowing the illegal foreign nationals to legalise their visa status, or transfer their jobs, or return home without facing any penalty.

Later, the amnesty period was extended until November 4 following the demand of the foreign nationals.

The move came as a blessing for many Bangladeshis who had been staying in the KSA for several years without any valid documents, and were

not getting any chance to get legalised.

However, some Bangladeshi migrants without any "entry documents" are still in danger, as they are not allowed either to return home or to legalise their status under the ongoing amnesty.

These migrant workers are those who ran away from their legal employers, leaving behind their passports and other documents with the employers, said the embassy officials.

As a result, these workers

lack necessary documents, and thus fail to prove that they entered the country through legal channels, they added.

Emdadul Haque said a few thousand Bangladeshi workers, who went to Saudi Arabia before 2008, did not have their fingerprints recorded with the Saudi immigration department, as the mechanism was not introduced before 2008.
