'Robber, mugger' killed in mob beating

A 'robber and a mugger' were killed in mob beating in Munshiganj and Rangpur districts yesterday and the day before.

An alleged robber was killed by a mob at Dalalpara under Sadar upazila of Munshiganj early yesterday, reports our correspondent.

Sahabuddin Sabu, 30, succumbed to the injuries at Munshiganj Sadar Hospital. Three other alleged robbers -- Sardar Nagar, 50, Roman, 30, and Ratan, 32, -- were arrested from adjacent places along with valuables looted in the incident.

They looted valuables, fied as Saju, 40, of

including five tolas of gold, and Tk 80,000 in cash from the house. During the robbery, they severely beat up Hekmat Bepari when he tried to resist them. He was later rushed to Dhaka Medical College Hospital.

Hearing hue and cry, neighbors rushed to the spot and caught one of the robbers, Sabu, after a hot chase.

Later, local people gave him a good beating, leaving him critically injured. He was rushed to Munshiganj Hospital where he died early in the morning. Police raided some places

Abducted boy's body found in dustbin

Police recovered the body of a schoolkid from a dustbin at Chandra Bazar in Faridganj upazila on Friday, after three days of his abduc-

The deceased was identified as Nabi Rahman Emon, 6, a playgroup student at Chandra Shishu Academy and son of Mizanur Rahman of the upazila.

Being informed by locals, police recovered the body, wrapped in a polythene bag, from the dustbin and sent it to hospital morgue for autopsy.

Emon was abducted while returning home from school on October 1. Later, the kidnappers demanded Tk 10 lakh as ransom over phone. They also threatened the family members to kill Emon if they informed the

matter to police. Emon's father, Mizanur Rahman, filed a case with Faridganj police station on the following day.

Police arrested Chandra union unit's Jubo League leader Mafiz Sheikh, Chandra Bazar association member Manik Hossain and a trader, Harun-or-Rashid, for their suspected involvement in the killing and abduction.

DB nabs top Benapole criminal

Members of Detective Branch (DB) of Police in a drive arrested a top criminal and his two accomplices along with arms after a gunfight at Kagajpukur village here early yesterday.

The arrestees were identified as Amirul Islam, 45, ring leader of infamous 'Amirul Bahini', and son of Lutfur Morol, Tito, son of Moslem and Ahmed, son of Aynal of the village.

Maniruzzaman, officer in-charge of DB police, said acting on secret information that Amirul and his gang were staying at the Kagajpukur field, a team of DB police raided the area.

Sensing the presence of the law enforcers, the criminals opened fire on them, prompting DB police to retaliate, triggering a gunfight.

At one stage, Amirul was caught in the line of fire and received injuries.

Later, police arrested bullet-hit Amirul and his two accomplices along with pistol and bullets while they were trying to flee the scene.

Police said, Amirul was wanted in a number of cases. He was the prime accused in Zillur Rahman, UP chairman of Singholi union in Chowgaccha upazila and former president of the district unit Chhatra League, murder case. Zillur was shot dead in broad daylight on September 27, said police.

Amirul went into hiding soon after the incident.

3 PCJSS supporters abducted allegedly by UPDF men

Three supporters pro-peace treaty Partbatya Chattagram Jana Sanghati Samity (PCJSS) were abducted allegedly by the rival members of United People's Democratic Front (UPDF) at Tulaban village in Marishya union under Baghaichhari upazila of the district on Friday midnight.

The three were identified as Sumon Chakma 28, Udayan Chakma, 31, and Lal Baran Chakma, 35. Sumon and Udayan are night guards at Tulaban High School and Baghaichhari municipality office respectively and Lal Baran is younger brother of Bararishi Chakma, general secretary of PCJSS, Baghaichhari upazila unit. A gang of armed crimi-

nals, numbering about 15, came to Tulaban village at about 11:30pm and picked up the trio from their respective image of UPDF by maktive residences at gun point. ing false propaganda, Sona The criminals took them Moniadded.

The incident might be linked to the kidnapping a Karbari (village chief) named Hulomoni Chakma from his house in Sazek union in the same upazila on Thursday night. He was picked up allegedly by the cadres of PCJSS, Rafique added.

He, however, said no one lodged any complaint with his police station in this connection. Sajib Chakma, assistant information secretary of PCJSS central unit, yesterday blamed anti-peace UPDF for the kidnapping. He condemned the incident and demanded release of the villagers immediately.

Sona Moni Chakma, press secretary of UPDF, Rangamati district unit, refuted the allegation.

As per three-day protest programmes of the local journalists, they will submit a memorandum to the deputy commissioner today in favour of their demand. The participants expressed concern as the law enforcers are yet to arrest the criminals into the attack on Kamonashish. Police said they were raiding different areas to arrest the attackers.

Hilsa seized in Benapole

Members of Border Guard Bangladesh seized 2080 kgs of hilsa fish worth Tk 62.40 lakh from Sadipur border area here yesterday. A patrol team of BGB, on a tip-off, raided the border area in the early hours and seized the hilsa fish while those were being smuggled to India, said 26 BGB commanding officer Lt Col Matiur Rahman. However, the smugglers managed to flee, sensing the presence of the border guards. The seized fish were later deposited to Benapole Customs godown and a case was filed in this connection.

Four newborn babies died at Tangail General Hospital on Friday due to premature birth complications, revealed the three-member physicians' probe body.

The hospital authorities formed the body headed by Dr Abdulah Al Harun, senior consultant (child) of the hospital on the day and asked it to submit the report within the next 24 hours.

Two other members of the committee are Dr Rafiqul Islam, resident medical officer, and Dr Tapas Kanti Bhoumik, consultant (cardiology) of the hospital.

Dr Abdulah Al Harun told this correspondent yesterday that the newborns were underweight and suffering from different com-
