Merkel hints at forming govt next week

AFP, Berlin

German Chancellor Angela Merkel met the opposition Social Democrats' leader yesterday, ahead of a decision expected next week on her preferred governing partner for Europe's biggest economy.

A new poll showed a record two-thirds o Germans would favour a rerun of a left-right 'grand coalition' between the two big parties, Merkel's conservatives and the centre-left Social Democrats (SPD).

For now Merkel, whose centre-right CDU won the September 22 vote, is keeping her options open and has agreed to more talks early next week with both the SPD and the left-leaning and ecologist Greens.

In the end "the typically cautious Merkel will probably still prefer the tested combination with the SPD" with whom she governed in her first term, said an analysis by Berenberg Bank.

"We see an 80-percent probability for a grand coalition in Germany."

Senior economists at the bank cautioned that an SPD pledge to let its party base vote on any coalition deal "introduces an element of unreliability" and that "the readiness in Merkel's CDU (Christian Democratic Union) to do a deal with the Greens seems to be grow-

Almost three weeks after the election left Merkel without a clear majority, decision time is approaching for her CDU and its Bavarian allies the CSU.

They have said they want to know by October 22, one month after the election, with whom to launch serious coalition talks.

On Friday -- a day after the conservatives held their first exploratory talks with the Greens, described as cordial by both sides despite many points of conflict --Merkel and CSU chief Horst Seehofer met quietly with SPD chief Sigmar Gabriel in

the chancellery. If a 'grand coalition' takes shape, the SPD has said it will push its core campaign demand for a national minimum wage to help the country's growing army of working poor -- an idea supported by most Germans, according to a new poll.

While 35 percent support the SPD's call for an 8.50 euro (\$11.5) hourly minimum wage, another 56 percent want one that is even higher, found the Infratest dimap poll for ARD public television.

The same survey found that 67 percent of Germans would back a 'grand coalition', while only 27 percent preferred an alliance of the conservatives and Greens, called a "black-green" coalition in Germany's colourcoded politics.

The Greens may narrow Merkel's options as early as Tuesday.

AU accuses ICC of bias, opens summit

Terms the court as 'political' and 'unfair'

The International Criminal Court was under fire yesterday over its "unfair" and "totally unacceptable" treatment of Africa, as Ethiopia opened a special African Union summit with a scathing attack on the tribunal.

The meeting comes amid mounting tensions between The Hague-based ICC and Kenya, whose president and vice-president have been charged with crimes against humanity for allegedly masterminding a vicious campaign of ethnic violence after disputed 2007 elections. Several nations in the 54-

member AU, whose rotating presidency is currently held by Ethiopia, have accused the ICC of singling out Africans for prosecution, and have demanded that the court drop the proceedings against Kenya's leadership.

"The manner in which the Court has been operating, particularly its unfair treatment of Africa and Africans, leaves much to be desired," Ethiopian Foreign Minister Tedros Adhanom Ghebreyesus told ministers and delegates at the opening of the two-day meeting. "The court has trans-

formed itself into a political instrument. This unfair and unjust treatment is totally unacceptable," he said of the ICC, the world's first permanent court to try genocide, war crimes and crimes against humanity. A Zimbabwean govern-

ment official yesterday said his country which never signed the Rome Statute supports calls for African states to cut ties with the ICC.

African countries account for 34 of the 122 parties to have ratified the Rome Statute, the ICC's founding treaty, which took effect on July 1, 2002. A mass pullout from the court -- as some countries have demanded -could seriously damage the institution.

Sudan's Foreign Minister Ali Karti told AFP that "African countries have their own mechanisms of justice and they prove to be good, better than the European ones".

The bloc, however, appears divided on the issue -- with countries like Kenya, Sudan, Ethiopia and Rwanda taking a tough line, but other nations seemingly more reluctant to get embroiled in a diplomatic confrontation and some prominent African figures lobbying hard against a pull-out.

Islamists urge protesters to avoid Cairo's Tahrir

An Islamist alliance urged its supporters to stay away from Cairo's Tahrir Square during protests yesterday to avoid more bloodshed after a week in which nearly 80 Egyptians were killed.

The interior ministry warned the Islamists that it will "confront any attempts to break the legitimacy" of the interim government.

The Anti-Coup Alliance, which rejects Egypt's military-installed government, said the "coup regime is shedding blood without any respect to law or values adopted by our great peo-

"So the alliance is calling for marchers to avoid places of bloodshed, be it Tahrir or other squares," said a statement from the group which demands the reinstatement of ousted Islamist president Mohamed Morsi.

It said its appeal follows

calls by several intellectuals and political forces as marches to the iconic square "will lead to more bloodshed"

The alliance had repeatedly called on its supporters to march yesterday towards Tahrir, the main symbol of the Arab Spring-inspired uprising that toppled former strongman Hosni Mubarak in 2011.

"We are just limiting our marches" yesterday, the alliance said, adding it reserves "the right to protest in all squares including Tahrir, Rabaa and Nahda in the coming weeks".

Cairo's Rabaa al-Adawiya and Nahda squares were sites of a brutal crackdown by security forces on Morsi's supporters on August 14. Hundreds of people were killed in some of the worst carnage in Egypt's modern history.



For Mamataz Begum in the meantime, the Rana Plaza collapse has been a collapse in every sense. It has taken away her son and with him the source of her family income. It has taken away, too, the joy she shared with him on Eid days.

"I wish I could get at least my son's body so I could bury him."

Asked what this year's Eid meant to her, she said: "What can a festival mean to a mother who has lost her son?"

She said she did not get any help from the government.

Worse, she cannot open the little tea shop she and her husband ran near the collapsed nine-storey building. The place where the shop had been remains restricted on security grounds.

Mamataz is one of the 15 mothers the correspondents spoke to while visiting Majidpur area, close to Rana Plaza.

At least seven of them are yet to find the bodies of their children or get any government help. Whenever they see a journalist they show the pictures of their sons or daughters with documents to prove their claims.

Among those who shared their heart-breaking stories with The Daily Star was Rasheda, 55. The body of her daughter, Rina Akhter, was pulled out from under the rubble by rescuers two days after the collapse. A few days later, Rasheda's husband Yunus Akhter, who joined the rescue operation with many other civilians, died of a heart attack, possibly because of the trauma he had gone through. Last year, Eld meant joy

to her because her daughter arranged the celebration with her little savings. But this year, all she feels is desolation. She is worried too.

Worried, because another of her daughter, who used to work at a Rana Plaza garment factory, had her waist badly injured in the collapse.

Rasheda is struggling to manage the treatment cost. And she does not know where the money will come from in the days ahead.
