The defence then furnished a short list of five witnesses -- Abdul Hamid, S Alam, Abdul Hamid, Abdus Salam Mukul and Mohammad Nazibar Rahman.

The first defence witness in the case was supposed to be one of the two people named Abdul Hamid on the list.

But yesterday a lawyer from Pabna named KM Hamidur Rahman testified before the tribunal and the tribunal recorded his testimony at length. However, before cross-examination,

prosecutor Mohammad Ali sought three hours for preparation. He said the witness was not the person mentioned on the witness list. The judges of the tribunal, to their

astonishment, discovered that there was no KM Hamidur Rahman on the list.

When the tribunal asked the defence what was going on, defence counsel Mizanul Islam said a junior lawyer had made a mistake and mentioned Abdul Hamid instead of KM Hamidur Rahman. He apologised for the mis-

Tribunal-1 Chairman Justice ATM Fazle Kabir then said, "Why didn't you point it [mistake] out before the deposition? It cannot be a mistake."

Addressing the junior lawyer concerned, Justice Kabir said the lawyer perhaps did not understand the magnitude of fraudulence before a court.

"We'll expunge the deposition," said Justice Kabir directing the witness to step down from the dock.

However, the tribunal asked the lawyers to check if KM Hamidur Rahman was on the list of the 10,111 witnesses.

KM Hamidur Rahman was not found on the list.

The tribunal then adjourned the proceeding for two hours giving the defence the opportunity to find KM Hamidur Rahman's name on the list. Surprisingly, after lunch, the defence

told the tribunal that the 7,165th witness was KM Hamidur Rahman, even though one Alhaj Md Hamidur Rahman was the 7,165th defence wit-

The defence claimed that the initials 'KM" were omitted mistakenly but the person on the list and the person who testified yesterday were the same. The defence also filed a petition in this regard pointing out they had made inadvertent mistakes, but did not apologise.

Interestingly, the defence in the petition asked the court to change the name Abdul Hamid to Alhaj Md Hamidur Rahman even though KM Hamidur Rahman was the person who testified.

The court then asked the defence to correct their mistake in the petition and file it afresh. It also allowed the testimony of KM Hamidur Rahman.

The prosecution was disappointed with the court order.

In his about 25-minute deposition, Hamidur claimed that he was a freedom fighter who along with others asked the family members of Razakars, an auxiliary force of the Pakistani army, not to harm the locals of Pabna.

Hamidur, of Gokulpur village in

Sujanagar, said during the Liberation

War none told him that Nizami committed any crimes against humanity or was involved in any such crimes. He also claimed that he did not find Nizami's name on the list of Razakars and Al-Badr members, which was pre-

Parents aged 42-54 years old blamed technology for keeping the young adults in the UK from walking and said they walked more than their children do when they were their

The top excuse given by young adults for not walking was "I don't have anyone to walk with" suggesting they were still lonely in the age of social media.

Fifteen percent of all adults admitted to giving up walking somewhere en route and getting public transport instead, at least once a week.

The average British woman was found to walk 12 minutes a day, while men walked an average of eight minutes. Both fall short of the 30 minutes a day suggested by the

British Heart Foundation. Women were shown to be more likely to create excuses to get out of walking, with their top reasons being poor

weather and feeling too tired. Men generally blamed their hectic schedules and lack of

Dr Paula Franklin, UK medical director at Bupa, said: "It's so easy to make numerous excuses but there are many health benefits to walking. For most people it is the most accessible form of physical activity, which is also free and can be great fun.

"For example, adding just 20 minutes walking to your day can dramatically reduce the risk of cardiovascular disease, which includes heart disease and strokes."

France's bus driver serial killer dies

Emile Louis, an ostensibly harmless bus driver who became one of the most notorious serial killers in French history, has died at the age of 79.

Louis, who was convicted in 2004 of killing seven mentally impaired young women in the late 1970s, died on Sunday morning in a secure hospital in Nancy in eastern France, his lawyer Alain Fraitag told AFP.
