Alam said members of the Peace Committee and Razakar force were from needy families and were only involved in "stealing chickens and cattle".

"We didn't have to fight against Razakars," he claimed.

The BNP Parliamentary Party took the decision at a meeting chaired by Khaleda at her Gulshan office last night, said meeting sources.

The 19th session of the ninth parliament resumes this afternoon. On October 9, Speaker Shirin Sharmin Chaudhury adjourned the session for Durga Puja and Eid-ul-Azha. The BNP joined the last budget session

but has been boycotting the current one.

In the presence of the 37 opposition MPs, including one each from Jamaat-e-Islami, Liberal Democratic Party and Bangladesh Jatiya Party, the BNP chairperson said she was positive about resolving the political stalemate through talks. "Our attitude is positive; we want to go

to parliament soon and place the chairperson's proposal on polls-time government," an opposition MP told The Daily Star after the 40-minute meeting. There was, however, no formal briefing

for journalists as the Opposition Chief Whip Zainul Abdin Farroque said the meeting was adjourned till this afternoon.

But talking to The Daily Star, a number of BNP MPs said they want to see the

government's formal reaction to Khaleda's proposal.

The Awami League-led 14-party alliance will sit today to discuss, among other issues, the BNP chief's proposal.

"Besides, we want to observe the meeting of the Jatiya Sangsad's Business Advisory Committee, which sits today to decide on extension of the ongoing parliament session," a BNP MP said.

Earlier on September 12, the Business Advisory Committee announced the current session would end tomorrow.

At last night's parliamentary party meeting, Khaleda asked all MPs to be available in the capital so they could join the parliament session at short notice, a BNP lawmaker said.

"Even we have been asked to stay in the opposition chief whip's room today. After observing the ruling party's reaction to madam's proposal we will finalise our decision on joining the parliament session," said the MP wishing not to be quoted.

Before the BNPPP meeting, Khaleda sat with some leaders of the 18-party alliance to determine strategy regarding the rally planned for October 25 and the DMP ban on political gatherings.

Sri Lanka has suspended final approval for two casinos involving a total investment of around a billion dollars after protests from within the ruling coalition's ranks, a minister said yesterday.

A bill giving the two separate casino hotels the go-ahead and granting them a 10-year tax holiday was due to be presented to parliament on Thursday. But Investment Promotion Minister Lakshman Yapa

Abeywardena said he has withdrawn the bill, which was meant to grant final approval to the projects after cabinet gave them the green light last month. "The government felt that we should withdraw this bill

because of the concerns raised by some of our own coalition partners," Abeywardena told reporters. "There is a lot of misunderstanding and we want to

address all that before we go to parliament."

Local firm John Keells Holdings is expected to invest \$650 million in a waterfront casino in the capital, in conjunction with a so-far unannounced foreign partner. Australian gambling mogul James Packer's company has committed \$350 million for a similar development.

A party made up of Buddhist monks, which is a member of the ruling coalition, has opposed the casinos, while individual monks have warned they will stage protests if the government goes ahead with the projects.

Abeywardena denied the bill has been axed, saying it was being reworked so that the 10-year tax holiday was confined to the hotel operations and not the casino side of the business.

Even at its last meeting on Saturday, the committee didn't discuss the issue of sending any letter to the AL for holding talks, said the BNP policymaker.

In her proposal, Khaleda suggested forming a non-partisan election-time government headed by a respected citizen to be chosen by consensus between the ruling

and opposition parties. She proposed that the AL and the BNP nominate five advisers each from among

the former advisers of the 1996 and 2001 caretaker governments. The two caretaker governments had 10

advisers each. But two of the advisers served

both the governments. Of the 18 individu-

als in the two advisory councils, four have passed away, a few are suffering from oldage complications, and some are unwilling to take the responsibility again.

Wishing anonymity, another committee member said, "The party could have avoided embarrassment had it allowed us to discuss the proposal at the committee meeting. We know almost all the individuals who served as advisers in the two caretaker governments."

At its last meeting on Saturday, the standing committee only discussed the proposal for picking a non-partisan person as the head of the election-time government by consensus. It also agreed to propose a search com-

mittee for picking a respected person to head the interim government. This proposal was also discussed and endorsed when top leaders of the BNP-led alliance met the following day, said sources. But the proposal for the search commit-

tee was not included in the formula that Khaleda announced at Monday's press conference.

A top business leader, who helped prepare Khaleda's speech, said the party made pledges to fight militancy to allay concern of the West and India that Islamist militancy and trans-border terrorism would be encouraged if the BNP comes to power.

"We put emphasis on the issue on advice of some foreign diplomat friends," said the business leader.

Through Khaleda's speech, the BNP also gave a message that "those who were involved in ousting the BNP chief from her cantonment residence and torturing her elder son Tarique Rahman would not be victimised if BNP is voted in".

Former military bureaucrats had drafted this part of Khaleda's speech, said the business leader.

Italy urges EU to adopt immigrant action plan

Italian Prime Minister Enrico Letta vesterday urged an EU summit this week to adopt an action plan to deal with the "immigration emergency" after two shipwrecks that killed over 400 people.

Europe "cannot sit there and watch" these tragedies, Letta told the Italian parliament, adding: "I am hoping for immediate action".

He called for the EU's Frontex border agency to be bolstered, the Eurosur patrol programme to be implemented sooner than its scheduled start date of December, along with the action plan.

Eurosur links different EU border patrol agencies and helps them communicate with each other and share satellite and surveillance drone data.

He also urged "dialogue with Mediterranean countries" where the migrants come from or transit through on their journeys to Europe's borders.

"The drama of Lampedusa is a European issue," Letta said, referring to the Italian island where thousands of migrants crossing the Mediterranean from north Africa have landed this year. A boat carrying mainly

Eritrean asylum-seekers caught fire, capsized and sank within sight of the coast of Lampedusa on October 3, killing 364 migrants in Italy's worst refugee disaster. On October 12,

another boat with Syrian refugees capsized in high seas between Lampedusa and Malta.

Thirty-six bodies were recovered but officials said the death toll may
