War crimes accused Yusuf denied bail

The International Crimes Tribunal-2 has again denied bail to Jamaat-e-Islami leader AKM Yusuf, who is historically known as the founder of infamous Razakar force in 1971.

The three-member tribunal headed by Justice Obaidul Hassan with members Justice Md Mozibur Rahman Miah and Justice Md Shahinur Islam yesterday rejected his bail petition as a report from Kashimpur Jail had said his health was 'stable".

The tribunal however directed the jail authorities to ensure the war accused's necessary medical checkup and treatment.

The 87-year-old Jamaat nayeb-e-ameer is facing 13 charges of crimes against humanity and genocide committed during the Liberation War.

Earlier, the tribunal on October 10 asked the jail authorities to submit the health report by October 22 and the authorities complied with the order on Monday.

The court in its yesterday's order said the nal. jail authorities reported that the accused had already undergone necessary treatment and his physical condition was "stable".

A three-member medical board has prepared Yusuf's health report.

Apart from his present physical condition, the court has also considered the magnitude of offences Yusuf has been charged Azharul Islam. Arrested on May 12, Yusuf was denied

bail two days later. The tribunal directed the jail authorities on July 24 to report on his health when he had sought bail again.

After the jail authorities then described his health as "stable", the court on August 1 had neither granted nor denied him bail but kept his petition on record.

He again sought bail in the first week of October.

that senior lawyer Abdur Razzaq had wanted to place the argument. He then sought an adjournment until November 3. The tribunal adjourned the proceeding

until October 31 for further hearing on charge framing.

The prosecution have brought nine charges against Subhan, who was produced before the tribunal yesterday.

He said some of the former advisers have already died while some others are unable to take up new responsibilities because of advanced age.

Sircar, in his response, criticised Tofail for rejecting the opposition proposal. "We placed the proposal for consideration by the prime minister. Let her decide on it."

significantly lower than the government's target of 7.2 percent, it is in line with the Asian Development Bank and International Monetary Fund's forecast of 5.8 percent and below six percent respectively. These agencies made lower projections for what they said are growing unrest and political uncertainty in the run-up to the coming elections. The WB country director said politi-

cal unrest put tremendous pressure on Bangladesh's economic growth and prospect.

Zahid Hussain, lead economist at the WB office, said overall the country's economy is moving into a more volatile phase centring on the elections. "The risks stemming from impeding the political transition have grown significantly." Zahid said, "Growth outlook hinges

primarily on internal stability and policy reforms. Policymaking is expected to improve if the transition to a new government in 2014 happens smoothly." The WB report -- Bangladesh

Development Update -- said real pri-

cent in fiscal 2012-13 due to political turmoil and uncertainty, compliance failures and labour unrest in the readymade garment sector, banking scams and a lacklustre global economy. Inflation decelerated but remained

high with annual average inflation declining from 8.7 percent in FY12 to 6.8 percent in FY13. This reflects a decline in both food and non-food prices. Softer international prices helped reduce food inflation, it said. The financial system remains under
