Tuku's PO detained at airport with wife

State Minister for Home Shamsul Haque Tuku's personal officer (PO) Anisuzzaman Dolan and his wife were detained at Hazrat Shahjalal International Airport in the capital on Wednesday as they tried to fly to the United States without taking official permission.

Talking to The Daily Star, Tuku said, "I asked the airport authorities to bar him from flying to the US as he [Dolan] did not take my permission." Instructed by the state minister, the airport authorities

barred Dolan and his wife from flying to the US and detained them at the airport for a few hours, said a source in the home ministry, adding that Dolan had come to office yesterday. Several sources in the ministry claimed Dolan was involved in influencing postings of several police offi-

cers and sending several other officers to United Nations' peacekeeping missions; taking bribes from them. Dolan might have been trying to flee to the US fearing a change of government, they said, adding that he might be

sacked soon on different grounds.

Dolan could not be reached for comments.

Last year, the government decided to build these bridges as the existing ones are no longer in a condition to handle the heavy traffic flow on the highway billed as the country's economic lifeline. Obaidul Quader said the

existing two-lane bridges would also be rehabilitated. The new four-lane bridges will be constructed at a cost of Tk 8,487 crore, of which Japan has committed to providing Tk 6,429 crore as soft loan, he said. In order to prepare the

designs and carry out initial works, a Tk 2,315 deal has already been signed with Japan International Cooperation Agency (Jica). An international tender

will be floated once the appointed consultant prepares the designs, which will take four to six months. "We are hoping to begin

the construction of the new bridges by the next year and complete those in two and a half years," said an official of the Roads and Highways Department. The new Kanchpur,

Meghna and Meghna Gumti bridges will be 396 metres, 870 metres, and 1,410 metres long.


