A court here on Wednesday sentenced 11 people to life term imprisonment for snatching a microbus killing its driver in Srimangal upazila of Moulvibazar district in 2010.

The court also fined each of the convicts Tk 20,000, in default of which they will have to serve one year more jail term.

As the three-wheeler drivers gathered in Thakurgaon bus stand area, demanding punishment to the bus driver, the transport workers immediately blocked Thakurgaon-Panchagarh road at bus stand and Thakurgaon-Bliadangi road at Art-gallery intersection keeping buses haphazardly on the roads. After two hours they withdrew the blockade when police gave them assurance to investigate the matter.

26 illegal travellers held

Members of Coastguard arrested 26 Bangladeshi nationals from Teknaf bus stand area yesterday while they were trying to go to Malaysia illegally. They also held three brokers--Sona Ali, 45, Abdur Rahman, 32, and Md Jahed, 32. Lt Dewan Rafiqul Awal, station commander of Teknaf Coastguard, said acting on a tip-off, they raided the area around 5:00pm and arrested them. The arrestees hailed from Jessore, Chuadanga, Natore, Meherpur, Kurigram, Sirajganj and Narayanganj districts. The arrestees were later handed over to Teknaf police station, said Rafiqul.

Scuffle on BAU campus

A pro-BNP teacher of Bangladesh Agricultural University (BAU) scuffled with a Chhatra League leader on the campus over a trivial matter yesterday. Refuting the incident of slapping, Azad said he only tried to save the teachers from Selim, an outsider.

Pabna criminal jailed

A court here yesterday sentenced a local criminal to life imprisonment in an arms case. The convict is Md Abdur Razzak, of Kashinathpur village in Santhia upazila. Additional district judge Munshi Md Moshiur Rahman pronounced the verdict. According to the prosecution, Rab arrested Razzak along with a shutter gun and five bullets at Nurdah village in Ataikula upazila on October 6, 2009. A case was filed with Ataikula police station in this connection. Sub-inspector Md Mamunur Rashid later submitted a charge sheet accusing Razzak in the arms case. Razzak is also accused in three murder cases, said court sources.

Smuggled clothes seized

Members of Border Guard Bangladesh (BGB) seized a huge quantity of Indian smuggled clothes worth Tk75 lakh from Sadipur border in Benapole of Jessore early Tuesday. As many as 63 percent of the surveyed victims said injuries like amputations, paralysis and severe pains in the body have stopped them from going back to work. Moreover, 92 percent have reported of being deeply

traumatised, with more than half experiencing insomnia and trembling from loud sounds. Some said they were even scared to walk into a building or an enclosed room. The ActionAid released the survey report in London

yesterday. The survey came as the Bangladesh government along with the global alliance of trade unions continue to negotiate compensation for survivors and families of the deceased.

The report also reveals that the victims are facing severe financial difficulty. More than half of the surveyed said they had mounting debts and over 90 percent said they had no savings due to low wages before the factory collapse.

Only one company, Primark, has given Tk 15,000 each to 3,300 workers. The government has also given Tk 22 lakh each to 777 people, around one-third of the victims and their family members.

"While corporations sit on their hands, the victims of the Rana Plaza disaster are in urgent need of medical and psychological support, as well as the financial means to feed and care for their families," said Farah Kabir, ActionAid's country director in Bangladesh.

The report quoted 21-year-old Naznin Akhter Nazma, who was pregnant when pulled out from the rubble and lost her husband in the collapse.

"I heaved a sigh of relief when the doctor said my unborn baby was OK, but now I am worried that I can't provide for my child. I haven't had any compensation. My rent is five months overdue and soon shopkeepers will stop giving me credit for food," Nazma was quoted as saying.

Of the 2,297 people surveyed over phone, 1,509 were survivors and 788 family members of those who died. All 2,421 survivors and families of the 1,133 deceased could not be contacted due to change of cellphone numbers, ActionAid states in the report.
