### Bangladesh urges Saudi Arabia to join **UN Security** Council

Bangladesh yesterday urged Saudi Arabia to join the UN Security Council to promote and protect the interest of humanity and that of the Muslim Ummah.

The call was made following a decision of the Saudi government on October 21 to reject its newly elected position in the UN Security Council for the term 2014-15.

Taking note of the decision of Saudi Arabia, the foreign ministry in a statement yesterday said Bangladesh said it fully appreciates the compulsions that led to Saudi Arabia's decision to reject a seat in the Security Council which is in need of effective reforms on the basis of a broad based consensus.
