## 'Fugitive' RU Shibir president attends rally, gives speech

Police say arrest avoided to avert violence ANWAR ALI, Rajshahi

With 47 arrest warrants for him still active, the president of Islami Chhatra Shibir's Rajshahi University unit attended a rally in Rajshahi city for around three hours yesterday and then left unscathed, right under the nose of law enforcers.

Addressing the rally for around 20 minutes, Ashraful Alam Imon, whom police previously claimed to be a "fugitive", even threatened "retaliatory steps" against police and Rapid Action Battalion over the death of a Shibir man. The man, Rashedul Islam, 30, the pro-Jamaat student

organisation's Motihar thana unit treasurer, died in a clash prompted by cocktails hurled by Jamaat-Shibir men at police in Kajla area on October 26. The arrest warrants were issued over 47 cases filed over

one murder and mostly over numerous attacks on law enforcers and Bangladesh Chhatra League men in the city since November 6, 2012. That day Jamaat-Shibir men, demanding the release of Jamaat leaders, especially those being tried

over war crimes charges, wounded 30 policemen, beating two of them with their own rifles, in the city.

That month the first case was filed and the first arrest warrant was issued.

# Several thousands to be deported after Nov 3

Several thousand Bangladeshi workers, who migrated illegally to Saudi Arabia without valid documents and therefore were denied the chance to legalise their status, must return home after an ongoing amnesty expires on November 3, according to officials.

The number of such Bangladeshis who face deportation would not be more than 5,000 to 10,000, said Emdadul Haque, labour counsellor at Bangladesh Embassy in the Kingdom, talking to The Daily Star by phone recently.

Around 7 lakh Bangladeshis have received consular services taking the opportunity of the amnesty, he added.

Haque requested the Bangladeshis, who are still waiting to have their status legalised under the amnesty, to get registered to avoid punishment after the deadline. Those who have applied for legalising status would not face any problem, as the embassy is providing them with temporary documents, he said.

Last week, Deputy Labour Minister of Saudi Mefreh Al-Haqbani declared that the

expatriates seeking legalisation to continue to work in the Kingdom would be exempted from penalties and fines for violations that took place after April 6 this year. In addition, expatriate labourers who

have sought final-exit visas during the grace period will also be exempted from penalties, he added. Haqbani, however, warned that the ille-

gal migrants, who will fail to legalise status, must face punishment after November 3. Employers, individual sponsors and enterprises would also face extensive penal action for harbouring illegals, he added. "The timely submission of paperwork

is imperative to avoid deportation and being banned from entering the country,' Haqbani told Arab News. In early May, Saudi authorities set July 4

as the amnesty deadline allowing illegal migrants to legalise their visa status, transfer their jobs, or return home without facing penalty. Upon demands from foreign nationals, the amnesty period was extended till November 3 but Haqbani said there

## Statements collected through torture

Say two accused former NSI officials

Two former National Security Intelligence (NSI) officials, accused in the Chittagong arms haul cases, told a Chittagong court yesterday that they were forced to provide confessional statements under duress, tortured physically and verbally abused during remand. The officials, former NSI director general Brig Gen (retd)

were allowed by Chittagong Metropolitan Special Tribunal Number 1 to have their say on the charges. The two cases, one for smuggling firearms and the other under the arms act, were filed a day after seven truckloads of

Abdur Rahim and director Major (retd) Liakat Hossain,

arms and ammunition were seized at a jetty of Chittagong Urea Fertiliser Ltd in Chittagong city on April 2, 2004. Abdur Rahim said he was arrested at his Dhaka residence

on May 15, 2009 without a warrant. During remand, he was once blindfolded, tied up and

hung upside down from a ceiling fan. Another time, he tripped and fell on wires in the darkness inside a Chittagong jail, where conditions were unhygienic, and hurt his eyes and required eight stitches around them, he said.

He started fearing for his life after overhearing several phone conversations the investigation officer (IO), Md

## Quader Mollah to be executed as per laws

Says law minister

Law Minister Shafique Ahmed yesterday said the Supreme Court's death penalty verdict for Jamaat-e-Islami leader Abdul Quader Mollah would be executed as per relevant legal provisions.

The law would take its own course and the release of the verdict's full text was under process, he, without elaborating, told journalists after a closing ceremony at Hotel Ruposhi

Bangla in the capital.

The death sentence was passed on September 17, overruling the International Crimes Tribunal-2 judgment that awarded him a life term for committing crimes against humanity during the 1971 Liberation War.

Without the release of the full text, the execution cannot be carried out. Shafique said the International

## Govt to create new welfare fund for journos: Inu

The government will create a trust fund to provide financial assistance to journalists in times of their need, Information Minister Hasanul Haq Inu announced yesterday. The trust fund will replace the current Journalists'

Assistance Fund. In this regard, a proposal will be placed in the cabinet

meeting on Monday, he told a meeting with Sangbadik Sramik-Karmachari-Oikya Parishad (SSKOP) at his office. If approved, the proposal will be placed as a bill in the

current parliament session for its passage into law, the minister said. Inu said the government would provide a block allocation for

the Journalists' Assistance Trust Fund but did not specify its size. In his speech, the minister also said the government might

declare the newspaper sector as an industry next week. About the recent attacks on journalists and media houses, Inu said, "To me, attacks on the media are tantamount to attacks on democracy." Action will be taken

against the attackers, he said. Speaking on the occasion, Ruhul Amin Gazi, president of a faction of the Bangladesh Federal Union of Journalists (BFUJ), urged the information minister to take an initiative to allow operation of the media which have been shut by

the government. Monjurul Ahsan Bulbul, president of another faction of the BFUJ, also spoke.
