# 2 Hatiya AL men killed while holding party meeting

Criminals backed by local MP blamed

Two Awami League (AL) leaders were stabbed to death and 14 others injured in an attack by criminals while they were holding a meeting at Sheikh Hasina Bazar in remote Bayerchar of Hatiya upazila on Wednesday night.

The deceased were identified as Shafiqur Rahman, 42, vice-president of Chanondi union unit AL and Aminul Haq, 35, a member of the same unit.

The attackers also set fire to two rooms of slain Aminul's house adjacent to the bazar and looted his four cattle and eight goats.

Seriously injured Rakibul Islam, 14, Tarif, 16, Morshed, 20, Abdur Rahim,

38, Nur Uddin, 28, Sajib Baperi, 48, and Sharif, 22, were admitted to Noakhali Medical College Hospital yesterday afternoon. Witnesses said, the incident took

place when around 20 to 25 AL leaders and activists were holding a view exchange meeting centring the upcoming national election at their party office. All on a sudden, over 100 people,

led by Belal Majhi and Faruk, who were supporters of local lawmaker Engineer Fazlul Azim, swooped on them Equipped with lethal weapons, they

started hacking them indiscriminately, leaving Shafiqur and Aminul dead on the spot, injuring 14 others.

Vice president of district AL and former

lawmaker Mohammad Ali told local newsmen that the supporters of MP Fazlul Azim launched the attack on the meeting.

Refuting the allegation of attack by his men, lawmaker Fazlul Azim said that the incident was a clash between the robbers and local landless people.

Syed Fazle Rabbi, officer in -charge of Hatiya police station, said the attack followed an altercation between two groups over harvesting paddy in the upcoming season.

Contradicting the OC's statement, Aminul's wife Fatema Khatun and Shafiqul's son Rafiqul Islam said no such quarrel took place as the paddy harvesting season was still one month away.

## 2,320 BNP and Jamaat-Shibir men sued in two districts

At least 2320 BNP and Jamaat-Shibir men have been sued in Dinajpur and Joypurhat districts on charge of attacking police, damaging public properties and arson during the opposition called 60-hour hartal that ended on Tuesday.

One Md Faruk Hossain of Birampur upazila in Dinajpur filed an arson case against 600 BNP and Jamaat-Shibir men while Ishak Ali, president of Biral upazila unit Awami League, and police against 320 in connection with the attack on AL activists and a constable on Tuesday.

On Monday, Dinajpur Sadar police sued at least 650 BNP men on charge of attacking sub-inspector Md Mokhlesur Rahman.

In Joypurhat, the railway authorities on Sunday midnight sued at least 750 men on charge of damaging two trains on Sunday, first day of the shutdown in the district, said SP Hamidul Alam.

Thousands suffer as lone healthcare centre shut

Around 3,000 fishermen families in Dhulasar union of Kalapara upazila are deprived of healthcare service as the lone Family Welfare Centre (FWC) in the area has remained closed for two years. The FWC, built on 0.45 acres of land at

1985 to provide free health service for the local people, especially the families of fishermen. An assistant community medical officer, a pharmacist, a family welfare visitor, and

two class four employees had been working at the centre since its opening. As the building developed many cracks two

years ago, the authorities concerned declared it unfit foruse and stopped all activities for renovation.

Though two years have passed, building

renovation work has not yet started. Locals have to go to Kalapara upazila town, about 30-km away, to receive medical treatment. Most of the fishermen are deprived of

medical treatment as they cannot go to the

upazila town for want of money, said Abul Kalam, a fisherman of the area. KM Khalequzzaman, chairman of Dhulasar Union (UP) Parishad, said he has urged the authorities concerned to renovate

the welfare centre as early as possible to ensure healthcare service for the locals, especially the poor fishermen families. Shah Alam, Kalapara upazila health and

family planning officer, said the renovation of the FWC will start soon. "We will resume health service in the area

very soon by sending a medical team once a week," he added.

## 3 to die for killing madrasa girl

Youth gets life for rape

A court here yesterday sentenced three people to death for killing a madrasa girl in Pakundia upazila in 2012.

The convicts are Rafikul Islam Rubel, Al Mamun and Abdul Momen Robin.

All of them were present at the court while AM Md Sayeed, judge of Kishoreganj District Court, pronounced the verdict.

Rubel, son of Nayan Mia, Mamun son of Bulbul Ahammad and Robin, son of Sirajul Haq, are the residents of Hosendi Purbopara village under the upazila.

According to the prosecution, the three tried to rape the girl after kidnapping her from near her house on the night of 28 March, 2012.

Failing to rape the girl, they suffocated her to death. Police later recovered the body from

Pakundia police station on

29 March, 2013 after police arrested them on the day.

Away in Panchagarh, a youth was sentenced to lifeterm imprisonment in a rape case on Wednesday, reports our Thakurgaon Correspondent.

District and Session Judge and also Judge of Panchagarh Women and Children Repression Prevention Tribunal-1 Muhammad Mahbub-Ul-Alam handed down the verdict in a crowded courtroom in presence of the convict.

The convict is Md Zakerul Islam, 23, son of Md Soleman Ali of Radhanagar village under Atwary upazila in Panchagarh.

The court also fined him Tk 50,000, in default, to suffer another six months of rigorous imprisonment.
