AL MP's son held with yaba

Police arrested two men, including an Awami League lawmaker's son, on suspicion of drug peddling in Rajshahi city's Aam Chattar area early yesterday.

The arrestees, Mustaq Ahmed Tulu, 27, son of Meraj Uddin Mollah, AL lawmaker from Rajshahi-3 constituency, and Tulu's friend Mamunur Rashid, 26, were held with seven yaba tablets around midnight.

The duo tried to flee after they saw police, who were in the area on information, said Hafizur Rahman, officer-in-

charge of Shah Makhdum Police Station. He said the duo admitted to taking the tablets as samples to buyers in Rajshahi city.

Police produced the duo before the Chief Metropolitan Magistrate's Court seeking a seven-day remand to interrogate them on where the yaba pills are stored, said Hafizur,

adding that the hearing will be held on Sunday. The court sent the duo to jail, he said.

He said two years ago, Tulu was arrested while carrying Phensedyl to Dhaka in a truck, but police released him due to the lawmaker's influence.

SAU stop paying 10 teachers, staff for filing writ plea

The Sylhet Agricultural University (SAU) authorities have stopped giving salary and other benefits to 10 teachers and staff as they filed a writ petition against the university administration seeking suspension of the process of "illegal appointments".

SAU Rafiqul Islam, director of finance and accounts department of the university, on Thursday gave the order to stop paying the 10. Meanwhile, SAU authorities also issued a show-cause

notice asking the 10 to explain why they filed the petition against the university. If they fail to respond in a week, the authorities will make a decision regarding the issue without further consulting the 10, said the notice.

The 10 are Prof Siddiqul Islam, Prof Mohan Miah, Prof ATM MAhbubb E Elahi, associate professors Kazi Mehtaul Islam and Md Ataur Rahman, Assistant Controller Gazi Md zahirul Islam, Public Relations Officer Khosru Md Salah Uddin, Assistant Director Md Neamat Ullah, senior lab

attendant Md Foyez Ahmed and MLSS Md Abdul Hamid. After they filed a writ petition on October 8, the High Court ordered the university to suspend appointments for

six months. However, a vacation bench of the court stayed the order for three weeks on October 13. Accordingly, the authorities

appointed 108 officials and teachers on October 22. Prof Siddiqul claimed the university has been making illegal appointments by hiring people for posts although

they do not meet the job criteria. Contacted, SAU Registrar Badrul Islam Shoeb said they

issued the show-cause notice as the 10 went to the High Court violating university rules and acted against the uni-

Says most of the perpetrators left out of charge sheet

Two years have elapsed since the gruesome murder of Narsingdi municipality mayor Lokman Hossain but most of the perpetrators are still walking scot free as police left them out of the charge sheet, said Lokman's wife yesterday.

"It is a matter of regret that we did not get justice...some of the killers arrested earlier even got bail," added Taj Mahal Begum, Lokman's first wife.

She was addressing a press conference in the capital's Crime Reporters Association marking the killing. Lokman, awarded gold medals twice by the government as the best mayor, was gunned down inside the Narsingdi Awami League office on this day in

2011. Lokman's brother Kamruzzaman, the present mayor, filed the murder case accusing 14 persons.
