Pran starts recalling turmeric powder FROM PAGE 16

"We will withdraw our entire supply of turmeric powder from the market within seven days," said Kamruzzaman Kamal, marketing director of Pran.

Pran took the decision after The Daily Star published a report on November 2 that said the turmeric powder sold in the local markets contains high levels of lead -- between 40 parts per million (ppm) and 55 ppm -- that far exceeds the permissible limit of 2.5 ppm set by Bangladesh Standards and Testing Institution (BSTI).

Bangladesh Council of Scientific and Industrial Research (BCSIR) carried out tests and detected a presence of high levels of lead.

Pran's turmeric powder after US Food and Drug Administration found excessive levels of lead, which could cause health problems if consumed.

reports, BSTI also collected samples of turmeric powder and other spices of several

The BSTI results are yet to be made public.

When asked, BSTI Director (Certification Mark) Kamal Prashad Das said the agency has found the presence of lead in high amounts in Pran's turmeric powder.

"We are yet to get all the results. We will submit

Last month, four stores in the US recalled a report to authorities after we receive all the results and will seek explanations from the company," he said. Pran said some tests confirmed the presence of

Following the FDA disclosure and media excessive lead in its turmeric powder and some tests did not. "It seems from our primary assessment that

brands, including Pran, from the domestic the level of lead might be higher in turmeric produced in certain areas of Bangladesh, whereas such excess levels of lead cannot be found in turmeric produced in other parts," it said in the statement.

Pran said it would put its turmeric back in the market by detecting the sources behind lead contamination in the spice.

Right to privacy must be UN priority: Brazil leader

"We consider that privacy on the Internet is part of human rights, and its defense must receive priority treatment in UN discussions," Brazilian President Dilma Rousseff said on her Twitter account.

killing of martyred journalist Selina Parveen. Terming her killing a matricide, the court

described the brutality of her death by bayonet charge even after she pleaded for life for the sake of her only child. Selina Parveen, editor of

Shilalipi, a pro-liberation weekly that published articles by prominent personalities including

Prof Munier Chowdhury, journalist Shahidullah Kaiser, Zahir Raihan and ANM Golam Mostafa, became the target of Al-Badr as she used the weekly's earning to help freedom fighters.

Her son Shumon Zahid was eight when she was abducted on December 13, 1971.

In July this year, Shumon testified in the tribunal. He gave a vivid description of his mother's abduction, which he had witnessed.

Selina's last words that she would return in a few minutes are still fresh in his mind.

In 1996, Shumon came to know about his mother from another witness Delwar Hossain, the lone survivor of Rayerbazar massacre.

Delwar, who in 1971 had an argument with his non-Bangalee boss of a private company regarding Bangabandhu Sheikh Mujibur Rahman, was also detained at Al-Badr's Mohammadpur Physical Training Centre camp along with other freedomloving Bengalees. He testified that he had

been there during Selina Parveen's killing along with other detainees on December 15 at Katasur in Mohammadpur, currently the site of Rayerbazar Martyred Intellectuals Memorial.

Blindfolded, he heard a woman screaming and pleading Al-Badr men not to

kill her.

The judgment quoted Delwar's testimony of what Selina had said, "Don't kill me. You have mothers and sisters. What if I were your mother or sister? I have a little kid; he will die, if you kill me."

She also told the men her name, Delwar had told the court.

Even after that the Al-Badr men showed no mercy; rather they charged her with bayonet to death.

The judgment continued saying, "Selina Parveen was a mother. The appalling attack was done not only to Selina Parveen but to the mother's line. The DIPLOMATIC CORRESPONDENT killing was rather a matricide. This indescribable brutality shocks the human conscience indeed."

Talking to The Daily Star, Shumon Zahid said, "I have received a verdict after 42 years but justice is yet to be served. I will receive justice once the criminals [Ashraf and Mueen] are brought back to Bangladesh and executed."

US, UK, Canada issue travel alert

Worried over hartals and frequent acts street violence, the US, UK, Canada and Australian missions in Dhaka issued travel warnings to their citizens travelling to or residing in Bangladesh, advising them to be very cautious.

Alerting its citizens, the US said violence could

also occur in the evening/night before a hartal. The UK reminded its citizens and travellers that acts of violence in public places could occur

without notice. Canada advised its citizens to exercise high degree of caution due to the fragile political situation and that the security situation could deteriorate quickly.

Australia said with the election ahead, the tempo of political activities in Bangladesh will increase.

"At the dawn of December 11, 1971, when my grandfather was walking in the veranda with my father in his arms, a group of Pakistani occupa-

tional forces along with Mueen Uddin came and forcibly took my grandfather away, saying he will be released soon," he added.

He said they killed and tortured those who

fought in the battle fields, others with pen; and my grandfather belonged to the latter group." Asked from whom Bishonko learned his grandfather's story, Afroza Parvin said he grew up

dreamt of a non-communal country. "Some

Ashraf Uddin. "The DC asked me if I have contacted

the SP and when I said yes, he assured me that the SP would take care of the problem." Around 1:30pm, over 50 unruly people

attacked Anil's house again. "At that time I took refuge in the attic with my family and watched through a

Sukumar Biswas of Ghoshpara said ten to twelve marauding groups, mostly youths, created panic by screaming as they rampaged through the village. "They stole gold ornaments

and cash and destroyed our refrigerator, TV, computer, beds, tables, utensils and what not."

A trail of destruction can be seen throughout the villages.

The areas have maintained communal harmony since the independence despite being dominated by Jamaat-e-Islami, a party historically known for practising communal politics.

Eighty-year-old Bishnu Priya Saha said she was born at Sahapara and lived all her life there but never imagined she would see this day. "Here we, the Hindus and Muslims, are living like brothers and sisters for generations."

Meanwhile, local administration organised a solidarity meeting on the bazaar mosque premises to quell tension and distributed cash, rice and corrugated tin sheets to the
