

Call off hartal, sit for talks

Hasina asks Khaleda

Prime Minister Sheikh Hasina yesterday said Opposition Leader Khaleda Zia must withdraw the 60-hour hartal first to sit in dialogue over the formation of an all-party polls-time government.

"The door for discus-

sion is still open. The hartal has to be withdrawn and you [Khaleda] will have to promise that you won't play with people enforcing hartal again," she said while addressing a rally at the historic Suhrawardi Udyan. She directed leaders and workers of Awami League and

its allies to be on the streets to ensure that pro-hartal activists could not harm people and their properties. In her 33-minute speech that started at 4:35pm, Hasina,

also Awami League president, requested BNP Chairperson Khaleda to withdraw the hartal for the sake of Junior School Certificate exams, which was scheduled to begin from today.

Criticising Khaleda for her recent remarks "on freeing the war criminals", Hasina said Khaleda would not be able to protect the war criminals by enforcing hartals and killing people.

Referring to the trial of BDR carnage, Hasina claimed that pro-BNP-Jamaat lawyers were giving legal assistance to the killers. "The BNP chief went into an underground hideout an hour before the mutiny. It has been proved today how SEE PAGE 11 COL 1

Rally makes commuters suffer a lot

Traffic on the major streets in the city came to a standstill yesterday as ruling Awami League supporters rushed to the grand rally held at Suhrawardy Udyan.

The Kazi Nazrul Islam Avenue was completely choked around 2:00pm with vehicles carrying supporters towards the venue. The road was the main route for supporters coming from Savar, Dakkhinkhan, Uttara, Rupnagar and Mirpur, among other areas.



Arrest culprits in 24 hours

The High Court yesterday directed the police to arrest within 24 hours those who attacked the Bonogram Bazaar Hindus in Pabna on Saturday.

Issuing a suo moto rule,

the court asked the inspector general of police (IGP) to deploy adequate law enforcers at the bazaar under Santhia upazila of the district immediately to protect the minorities.

It asked the police chief to submit a report within 72 hours before it after complying with the direc-

The HC also ordered the police boss to form a threemember committee to investigate the attacks on the Hindus and their property and to assess the amount of loss caused by the attacks.

His refusal led to attack on Hindus by Jamaat-BNP men in Pabna

Extortionists, mostly belonging to the BNP and Jamaat, had planned to frame Hindu schoolboy Rajib Saha in Pabna for maligning Islam after his businessman father refused to pay them.

Rajib's father Babul Saha, a leading trader in Bonogram bazaar, has two grocery shops with warehouses. He had been paying the youths regularly until June when they demanded Tk 2 lakh.

On Saturday morning, the youths went to his house looking for Rajib but found only his mother. They then went to Babul's shop.

"Around 9:00am, Manik, Khokon and a few others came to my shop. One of them showed me something on his cellphone and said my son had maligned the Prophet. They asked me to bring my son or face dire consequences," Babul told The Daily Star yesterday.

Pran yesterday began drives to withdraw its turmeric powder from the local markets after detection of high levels of lead by local and US laboratories. "Representatives of Pran came at noon

and took back all the turmeric powder we had in our store," said Abdul Matin, owner of Faisal Store at Karwan Bazar.

Other retailers at the kitchen market also shared the same experience.

On Saturday, the company in a statement requested retailers to return their entire stock of Pran turmeric powder to its representatives.

Khandaker Nur-e-Burhan, category manager (food) of superstore chain Agora, said Pran withdrew its stock of turmeric powder from the retail chain.

TK 1,174CR SCAM

ACC sues 53 Bismillah Group officials, bankers

The Anti-Corruption Commission yesterday filed 12 cases against 53 top officials of five banks and the controversial terry towel maker Bismillah Group for misappropriation of Tk 1,174.46 crore.

Thirteen of the accused are proprietors and top officials of Bismillah

Group and its sister concerns --Shaharish Composite Factory Ltd, Alpha Composite Towel Ltd,

Shaharish KT Ltd, Hindul Wali Ltd and Bismillah Towel Ltd -- and the rest officials of five banks -- Janata Bank, Prime Bank, Jamuna Bank, Shahjalal Islami Bank Ltd and Premier Bank.

The cases were filed under the antimoney laundering act, said Gulshan

Anwar Pradhan, assistant director of ACC and part of the five-member team enquiring the scam.

If convicted under the anti-money laundering act, the accused may get up to 10 years in prison and their moveable and immovable properties might also be confiscated, said a source in ACC.
