Pope to receive Putin on November 25: official

AFP, Vatican City

Pope Francis will receive Russian President Vladimir Putin on November 25, the Vatican said yesterday, as the Roman Catholic Church seeks to improve ties with the Russian Orthodox Church.

Putin has previously met the pope's predecessor Benedict XVI as well as late pope John Paul II and there are hopes for what would be an historic meeting between a pope and a Russian patriarch.

Putin's predecessor Dmitry Medvedev, who is now the prime minister, met with Benedict XVI in 2011. During another visit by Medvedev in 2009,

the two states re-established full diplomatic ties which had been severed during Soviet times. Relations between Russia and the Vatican

have improved since the coming to power in 2009 of Patriarch Kirill, who headed up the Russian Orthodox Church's diplomatic arm for years.

His comments came two days after parliament ratified the Grameen Bank Act, 2013, replacing the Grameen Bank Ordinance,

"But the bank's activities will be disrupted whenever the government exercises its power. Then the bank will not be able to operate in the way it has operated so

"And gradually the bank will move towards destruction. So, we will have to try hard to return the bank to its previous

shape," he added. There would have been no problem had the government just translated the ordinance into Bengali and made a new law keeping the provisions unchanged, as has been done in the cases of some other ordinances. But the government has not done so, mentioned Yunus.

He is now in the Malaysian capital to join the fifth Global Social Business Summit. The three-day annual event opened in the Kuala Lumpur Convention Centre yesterday on the theme "Social business to change the world".

This year, 600 participants from around 40 countries, including 100 from Bangladesh, are attending the programme.

Yet, political analysts are skeptical about the outcome of the talks, particularly when the two sides seem rigid on their stance on the polls-time government, which is at the centre of the stalemate.

Tribunal-2, considering Alim's poor health, sentenced the 83-year old BNP man to imprisonment till death for committing crimes against humanity and genocide during the country's Liberation War in 1971.

In the appeal, Alim said he was not involved in any crimes against humanity committed during the war.

He also claimed that he was neither the chairman nor a member of Peace Committee, an auxiliary force of the Pakistan army, in Joypurhat.

The tribunal had wrongly convicted him and sentenced him to imprisonment on the basis of false hearsay statements made by prosecution witnesses, he added in the

Advocate Tajul Islam, a lawyer for the former BNP minister, told The Daily Star that 120 grounds had been mentioned in the appeal for the acquittal of Alim.

The SC will now fix a date for the hearing of the appeal, Tajul added.

Meanwhile, Attorney General Mahbubey Alam told The Daily Star that his office was yet to get any instructions from the government whether it [government] would file any appeal with the apex court seeking death penalty for Alim.
