Hearing on continuing in offices adjourned

REGISTRATION OF BNF resignation

BNP joint secretary general Rizvi Ahmed yesterday demanded resignation of the chief election commissioner and four other election commissioners for registering the much talked-about Bangladesh Nationalist Front (BNF) as a political party.

The government has used the Election Commission as well as intelligence agencies to get the new party registered with an aim to splitting the main opposition BNP, he said during a press briefing at the party's central office in the capital's Nayapaltan a day after BNF was registered.

The BNP leader demanded immediate cancellation of the registration of BNF, which applied for "sheaf of wheat" as its electoral symbol but got the "television" symbol.

Rizvi said the EC had done this even after repeated complaints from BNP. The commission is now playing the role of an agent to carry out the government's anti-democratic agenda, he alleged. "The EC has become an extended part of the Prime Minister's Office." He also said the aim of registering the party was to create confusion about BNP and BNF among the people.

BNP demands EC's Unite against anarchy, violence: Hasina

Again accusing the opposition BNP-Jamaat, and Hefajat of attacking the people as well as burning them to death in vehicles during the countrywide shutdowns, Prime Minister Sheikh Hasina yesterday called upon the country's people to unite against such anarchy and violence by the opposition.

"They (BNP-Jamaat-Hefajat) want to take political benefit in the name of Islam. They unleash sniper attacks on people, burn sleeping people to death in buses being aggrieved as people don't respond to their call for movement," she added.

Hasina was addressing a public rally organised by Bamna upazila Awami League

at the Sarwar Jahan Pilot High School ground in Barguna.

Newly inducted Ministers Amir Hossain Amu and Tofail Ahmed, local MP Shawkat Hasanur Rahman Rimon and chairman of parliamentary standing committee on Shipping Ministry Nur-e-Alam Chowdhury Liton also spoke at the rally chaired by Bamna upazila AL president Adv Md Harun ur Rashid.

Listing various development activities of the present government, Hasina sought vote for "Boat", the election symbol of AL, in the next general election and thus give her party another opportunity to serve the nation.

CTG ARMS HAUL CASES

Nizami pleads innocence

Former industries minister and Jamaat-e-Islami chief Motiur Rahman Nizami yesterday claimed his innocence in the Chittagong arms haul cases, saying the charges against him were unfounded and he was implicated in the cases with an ulterior motive.

Appearing at Chittagong Metropolitan Special Tribunal No-1, he prayed for some time to produce witnesses, submit a written statement and documents to prove his innocence. In response, Judge SM Mojibur Rahman asked him to produce the witnesses today.

Nizami claimed his innocence after the prosecution read out the charges against him and cited from the statements of two witnesses--former industries secretary Dr Shoyeb Ahmad and former chairman of Bangladesh Chemical Industries Corporation (BCIC) Maj Gen (retd) Mohammad Imamuzzaman--who testified against him.

In their depositions, the witnesses brought the allegations against Nizami, said Public Prosecutor Kamal Uddin Ahammad. Quoting the two, he said though

Chittagong Urea Fertiliser Ltd (CUFL), where the arms and ammunition were seized in the wee hours of April 2, 2004, was under the control of his ministry and he was informed of the smuggling, Nizami neither did take any step at that time nor launch any investigation into the incident. Rather, Nizami sent former acting indus-


tries secretary Nurul Amin, a fugitive accused in the cases, to CUFL on that night to supervise the unloading of the arms and ammunition, the prosecutor added, citing from the witnesses' statements. In reply, Nizami's lawyer Abdus Sattar

prayed for some more time to produce witnesses and submit a written statement to prove his client's innocence but the prosecutor opposed that appeal, saying it was a "summary trial", which should end as soon as possible.

The trial has already been delayed for different issues and is close to its end now, said Prosecutor Kamal, urging the court to allow him to place arguments instead. Though there is no rule for arguing in summary trial cases, the tribunal can allow it, he added.




