Aman farmers beam with delight due to good yield, fair price

STAR NATIONAL DESK

Aman farmers are happy with good yield as well as fair price of the major paddy this season, according to reports from several districts.

Farmers in Lalmonirhat district are now busy in the field to harvest the paddy, said our correspondent.

Now one maund (40 kg) of aman paddy is selling for Tk 640 to 710 in different markets in the district while the production cost of a maund of paddy was Tk 420 to 450, farmers said.

Officials of the Department of Agriculture Extension (DAE) in Lalmonirhat said aman was cultivated on 81,085 hectares of land against the target of 77,078 hectares in five upazilas of the district this year.

Farmer have got at least 120 maunds (4.8 tonnes) in each hectare of land this year but it was only 90 to 95 maunds last year, they said.

Anwar Hossain, 62, a farmer at Kashinath village in Lalmonirhat Sadar, said, "I cultivated high yielding flood tolerant aman paddy on 68 decimals of land this year and got 25 kg of paddy in each decimal. It was only 18 kg last year."

"I received seed and technical support from the IRRI-STRASSA Project of NGO RDRS to cultivate the variety. I will cultivate it on more lands next time," he

Mamunur Rashid, agriculture and environment coordinator of NGO RDRS said, "Now the farmers apply scientific method for cultivation. They do not use excessive fertiliser and insecticides in their croplands."

Our Gaibandha correspondent reports: Aman production in Gaibandha district is likely to see increase this season as farmers brought total 1,27,800 Favourable weather hectares of land under aman cultivation against the target of 1,22,227 hectares and the weather was favourable, said sources of DAE.

"I have harvested 18 to 20 maunds of HYV of aman crop per bigha of land, as weather and flood was almost favourable this year," said Kamrul Hasan, a model farmer of Kholahati union in Gaibandha Sadar upazila.

This season the farmers are getting fair price of the crop that is now selling for Tk 730 to Tk 775 per maund, said Dipok Pal, a farmer of Badiakhali village in Sadar upazila.

> expected this season in the district as weather condition remained favourable, prices of fertiliser and other inputs were relatively low while pest attack did not affect the crop, said growers and agriculture officials.

Sherpur DAE had set a target to bring 87,393 hectares of land under aman farming in the district this season but farmers cultivated aman on more areas of land.

Chandan Kumar alleged that the accused beat him up seriously and vandalised his motorcycle in Shaplachattar area during the hartal hours on November 4 as he refused to pay them illegal toll.

Youth rapes 4-year-old girl in Nilphamari

A madrasa student raped a four-year-old girl at Khalisha Chapani village in Dimla upazila of the district on November 20, leaving her seriously injured.

She is now undergoing treatment at the children's ward at Nilphamari 100-bed Hospital.

Dr Fazlul Huq, resident medical officer (RMO) of the hospital, told this correspondent that he found injury marks in the private parts of the rape victim, who was also suffering from high

fever and severe pain. Victim's mother told this correspondent that when her daughter was playing in front of their house at noon, neighbour Monsur Ali's son Saiful Islam, 20, a student of Khalishapani Bepari Tola Alim Madrasa, picked her up, saying he would give her chocolate.

"After sometime, I heard my daughter screaming in a bamboo cluster near our house. I rushed there and found her lying on the ground and bleeding profusely from her private parts".

The girl's father lodged a case with Dimla Police Station yesterday aganst Saiful Islam, but the accused went into hiding soon after the incident.

Contacted, Officer incharge Azimuddin of Dimla Police Station said they will launch a drive to arrest the culprit.

A case was filed accusing a few Awami League activists, said officer in-charge (Investigation) Nasir Uddin. "We have already arrested a local Jubo League activist, Shahidul Islam, in this connection, he added.

Eight held in killing case

Police arrested eight more 'Jamaat-Shibir activists' from different places in Debhata upazila on Friday night in connection with the killing of local Awami League leader Abu Raihan. Abu Raihan, 38, organising secretary of the upazila unit of the ruling party, was stabbed to death by miscreants at Parulia Bazar in Debhata on Thursday night.

Man dies in police custody

Teenage girl 'commits suicide'

Police said, she took poison early yesterday but they couldn't ascertain the reason behind the suicide. Contacted, office in-charge of Moulvibazar PS Md. Azizur Rahman said, they sent her body to Moulvibazar Sadar Hospital for postmortem.

Fish traders clash
