

Khokon tortured 17 villagers in Faridpur

Victim tells war crimes tribunal

STAFF CORRESPONDENT

A victim yesterday told International Crimes Tribunal-1 that fugitive war crimes accused and BNP leader Zahid Hossain Khokon with the help of his associates abducted 17 villagers of Bangram of Nagarkanda Thana, Faridpur on April 27, 1971.

The victim Yunus Mollah said Razakar commander Zafar, who was Khokon's elder brother, caught him while he (Yunus) was attempting to flee home.

"Khokon hit me with the rifle butt and I fell to the ground. Then they forced me to do squats and again struck me on the right side," said Yunus, now 69.

The fifth prosecution witness against Khokon said the war crimes accused and his associates caught 19 villagers and released two of them after beating. The remaining 17, including the witness, were brutally

tortured at the Nagarkanda police station. A local chairman and Peace Committee leader Abdus Salam told the detained villagers that they would be freed if they paid Razakars Tk 10,000. Two days later, all of

them got released after the ransom was paid.

The fourth prosecution witness Abdul Hye Mullah who also testified at the tribunal-1 yesterday corroborated the incident narrated by Yunus. A resident of Bangram, Hye man aged to flee home shortly before the raid.

In his deposition, Hye said Khokon's

elder brother was killed in a fight between the freedom fighters and Pakistani army and their collaborators. After Zafar's death, Khokon became commander of Nagarkanda Thana unit of

Razakar, an auxiliary force to Pakistani

occupational army during the 1971 Liberation War. On May 30, 1971, Khokon and his associ ates killed 16 persons of Kodalia village,

said Hye. Following their testimony, stateappointed defence counsel Abus Shukur

Khan cross-examined the witnesses. The proceeding was adjourned until today.



232 gold bars seized in Dhaka, Ctg, Benapole

A total of 232 smuggled gold bars worth approximately Tk 11.78 crore were seized by law enforcers in different entry and

exit points of the country on Monday and yesterday. Customs officials in the capital yesterday seized 160 gold bars weighing 27kg and worth about Tk 8 crore in Hazrat Shahjalal International Airport. No one was arrested in this connection.

The gold bars were found in a bin in one of the toilets of a flight of Regent Airways that landed at the airport from Malaysia, said Wazed Ali, an assistant commissioner of customs.

So far, gold worth over Tk 32 crore has been seized this month at the airport in the capital, said Abdul Aleem, another assistant commissioner. In Chittagong, customs officials yesterday morning found

60 gold bars weighing 7kg in the luggage compartment of a flight of Biman Bangladesh that landed at Shah Amanat International Airport from Doha. The gold bars were worth around Tk 3 crore and no one was
