# 2 witnesses testify on wartime killings

Two witnesses in the war crimes case against Zahid Hossain Khokon yesterday testified how their fathers were killed during the Liberation War at Meherdia village in Faridpur.

One of the witnesses, Abdul Aziz Matubbar, now 63, saw war crimes accused BNP leader and fugitive Khokon shoot his father Asir Uddin Matubbar dead on May 31, 1971. Idris Sardar, 56, the other witness, said he

had seen Khokon dragging out his father Sofiz Uddin Sardar to a corner of their house the same day. He had later heard the sound of gunshots, Idris added.

"After they left the place, I went there and found my father dead. One bullet hit him in the chest and another in his ankle," said Idris.

Idris and Aziz, the sixth and seventh prosecution witnesses respectively, were giving deposition at the International Crimes Tribunal-1.

and properly. The commission also asked the LGRD ministry to make sure that no candidate uses government vehicles, establishments or other facilities in electoral campaigns.

Carried out by Atsuko Saito and Kazutaka Shinozuka, the study tested twenty housecats in their own homes; waiting until the owner was out of sight and then playing them recordings of three strangers calling their names, followed by their owner, followed by another stranger. The researchers then analysed the cats'

responses to each call by measuring a number of factors including ear, tail and head movement, vocalisation, eye dilation and 'displacement' shifting their paws to move. "These results indicate that cats do no

actively respond with communicative behaviour

to owners who are calling them from out of sight, even though they can distinguish their owners voices," write Saito and Shinozuka. The study, published by Springer in the Animal Cognition journal, suggests that the reason for

cats' unresponsive behaviour might be traced back to the early domestication of the species. Recent genetic analysis has revealed that the common ancestor of the modern housecat was Felis silvestris, a species of wildcat that first came into

contact with humans around 9,000 years ago. As early societies developed agriculture, these cats moved in to prey on the rodents that were attracted to stores of grain. In the words of the paper's authors, they effectively "domesticated

human-cat interaction.

complainant of the cases, told The Daily Star that he was satisfied with charge sheets despite the fact that it took 12 years for the police to do Soon after the blasts, police arrested 12 people but the CID, in its final investigation report submitted on December 17, 2003,

cleared the arrestees of the charges as no "correct, impartial and reliable" evidence was found against them. Later the home ministry ordered a reinvesti-

gation into the incident following an application submitted by the CID in 2005.

### Top S.African court orders probe into Zimbabwe torture

South Africa's top appeals court yesterday ruled that the country's authorities have a duty to investigate allegations of torture in neighbouring Zimbabwe. Judge Mohammed Navsa of the Supreme

Court of Appeal upheld a ruling that South African prosecutors had a duty under international law to probe the alleged torture of opposition activists in 2007. South African police "are required to initiate

an investigation... into the alleged offences, Navsa said. The ruling is likely to strain ties between

South Africa and the government of President Robert Mugabe, who described the initial court order as a "direct assault" on Zimbabwe's sovereignty. It could also spell trouble for 17 implicated

officials should they seek to travel to South Africa. South African prosecutors had refused to investigate the allegations, citing political

concerns. Pretoria mediated after disputed polls in 2008 between Mugabe and his arch-rival

Morgan Tsvangirai. The Southern Africa Litigation Centre (SALC) and the Zimbabwe Exiles Forum filed the case to force South Africa to arrest and prosecute 17 Zimbabweans accused of torture in 2007 if they enter the country.

said he would "begin negotiations on the formation of a new government next week", ruling out an immediate election. The next parliamentary elections are set for October 2014.

The November 21 store collapse was Latvia's worst-ever peacetime disaster, leaving the Baltic state of two million people reeling.

"Considering the tragedy and all related circumstances... a new government is needed that has the clear support of parliament," Dombrovskis told reporters as he fought back "Therefore I have submitted my resignation

from the post of prime minister," he said after a meeting with Berzins. Latvia enters the eurozone on January 1, an

unpopular move that Dombrovskis made a policy cornerstone for his administration.

He insisted yesterday that euro adoption played no part in his decision to leave and demanded he step down. "I've given a great deal of thought to the

political and moral consequence of what happened," Dombrovskis said referring to the disaster, adding would stay on as a care-taker prime minister until a new administration was formed.

Dombrovskis said that although he was not prepared to head another government himself, he wanted his centrist Unity party to be part of the future governing coalition.

"I'll probably resume my duties as a member of parliament but that matter requires more thought," he added, without elaborating.

Analysts said yesterday his surprise resignation only ramped up political instability as the country is poised for a currency switch.

"It's going to create a certain amount of

Minister Sheikh Hasina and Leader of the Opposition Khaleda Zia on holding the next parliamentary election in a "free, fair, inclusive and credible" manner, a highly placed source told The Daily Star yesterday.

UN Secretary General Ban Ki-moon is sending the "political mission", comprised of senior officials from the UN Department of Political Affairs (DPA) and experts, with the mandates to encourage dialogue among major parties to ensure an environment "conducive to credible and peaceful election", according to diplomatic sources.

This will be Fernandez-Taranco's third visit to Bangladesh in twelve months since he first came here on December 10 last year, followed by the second trip on May 10 this year.

During his stay in the capital, he will meet the two top leaders, Chief Election Commissioner Kazi Rakibuddin Ahmad, Foreign Minister Mahmud Ali and Foreign Secretary Shahidul Haque.

He will also hold talks with the members of civil society and international community to foster dialogue among political parties ahead of the next national election. Diplomatic and political circles in Dhaka

consider Fernandez-Taranco's visit as crucial. He will come apparently to help the political parties break the standoff over the polls-time

government. The UN official will report to the UN chief on the outcome of his Bangladesh visit.

Meanwhile, UN Resident Coordinator in Dhaka Neal Walker yesterday had a meeting with the foreign secretary at the latter's office. They discussed the ensuing Dhaka trip of the UN mission.

On August 23, UN Secretary-General Ban

Ki-moon made phone calls to Prime Minister Sheikh Hasina and Opposition Leader Khaleda Zia urging them to hold talks for a peaceful resolution of the ongoing political crisis. The UN chief on October 31 expressed concern about the latest wave of deadly vio-

lence in Bangladesh. He called on all concerned to respect the rule of law, exercise restraint and express their views peacefully. He also called all parties for holding dialogue to ensure an environment "conducive to
