Jamaat-Shibir men attack journo

A journalist sustained severe head injuries as Jamaat-Shibir men beat him up mercilessly in Uttar Devnagar area of the district yesterday morning. The victim, Yarab Hossain, 40, is a local correspondent of Bangla daily Manabzamin and joint secretary of Satkhira Press Club. Police said a group of Jamaat-Shibir men waylaid Yarab's motorbike on Satkhira-Akhrakhala road in the area when he along with two others was returning to the town after carrying out his professional duty at 10:30am. Later, they took the newsman to Akhrakhala Primary School campus and hit him with iron rod in the head and legs leaving him seriously injured. He was rushed to Satkhira Sadar Hospital, said Enamul Haque, officer in-charge of Satkhira Sadar Police Station. Police are raiding different areas to arrest the attackers, said the OC.

Youth shot in Laxmipur

A young man was injured as criminals opened fire on him at Parbatinagar village in Sadar upazila yesterday morning. The victim was identified as Sujon Das, son of Chittaranjan Chakravarti. Iqbal Hossain, officer-incharge of Sadar Police Station, said the gunmen shot Sujon in the legs near his residence in the area around 4:00am, leaving him seriously injured. He was rushed to Sadar hospital. The reason behind the incident could not be known immediately.

Four held with arms

50 hurt in clash

At least 50 people, four of them bullet-hit, were injured in a clash between two rival groups in Sadar upazila yesterday morning. The law enforcers fired teargas shell and rubber bullets to bring the situation under control. Police and locals said the rival groups of Chandradhigulia and Jalalabad unions attacked each other with lethal weapons and firearms, leaving 50 from both sides injured. Of them, the bullet-hit injured were rushed to Gopalganj Sadar Hospital while the rest to different hospitals, said Police Superintendent Md Mizanur Rahman.

Burimari Land Port

Blockade brings woe to 5,000 workers

The BNP led 18-party sponsored ongoing 72-hour countrywide blockade, second of its kind in a week, badly affects the thousands of workers involved with Burimari Land Port, as the programme left them temporary unemployed. Workers said that with-

out work and contracts, the workers - stevedores, dockworkers, porters, are struggling to manage meals for their families, while many have borrowed money from local moneylenders with high interest

"Programmes like strikes, shutdowns and blockades leave us unemployed and underemployment. Generally, we earn Tk 250-300 per day in the port, by

loading and unloading shipments going to and coming from India, Nepal and Bhutan. Our families depend on the earning," said Mazidul Islam, 42, a dock labourer at the port.

"These political programmes appear as curse for us as we become unemployed and our families remain half-starved," said Arfan Miah, 48, another dock labourer at the land

"During the 71-hour blockade programme, I borrowed Tk 2,000 from a money lender on condition of paying Tk 500 a month as interest until full repayment of the money. Now I faced another 72-hour blockade before earning," said worker Hamidul Islam, 45.

During the blockades or hartals, a good number of workers sell their labour to the traders in advance for low pay, said Ruhul Amin Babul, convener of Clearing and Forwarding Agents Association at Burimari Land Port.

"At least 5,000 workers are involved with the land port, the third largest of its kind in the country. Political parties should keep land ports outside the purview of their political programmes as these labourers are their family bread earners," Towhidul Islam, general secretary of Burimari Land Port Sangjukta Sramik
