

Non-implementation of the Chittagong Hill Tracts (CHT) peace accord may propel the armed rebels towards initiating another bloody struggle to achieve their right to land and self-rule, indigenous and civil

society leaders said yesterday. Dhaka University Prof Meshbah Kamal said rehabilitation of over half a million CHT people, including 65, 000 repatriated refugees and 92,000 internally displaced families, remained uncertain with the

accord unimplemented. "There is every chance that the disgruntled indigenous people may turn to a bloody armed conflict again," he told a discussion at The

Daily Star Centre in the capital. Parbatya Chattagram

Janasanghati Samity (PCJSS), the political front of CHT indigenous communities, organised it to mark the 16th anniversary of the treaty, which was signed between the then Awami League government and the

PCJSS on December 2, 1997. The government has breached the trust of the adivasis, said PCJSS Organising Secretary Shaktipada Tripura. "We know how to carry on our struggle and make the army

chief say he is tired of war," he said. Successive governments, particularly that of the AL, resorted to tricks and avoided implementing the most fundamental conditions despite being in power for nine years since the signing, said Sanjeeb Drong, general secretary,

TARIQUE'S ACQUITTAL IN MONEY LAUNDERING CASE ACC to appeal

The Anti Corruption Commission is likely to file an appeal with the High Court within this week challenging a lower court verdict that acquitted Tarique Rahman, in a money

laundering case involving Tk 20.41 crore. In the appeal, the ACC will pray to the High Court to convict Tarique, elder son of BNP Chairperson Khaleda Zia, on the laundering charge.

A Dhaka court on November 17 acquitted Tarique, who is now in London for treatment, of the charge though it sentenced his business partner, Giasuddin Al Mamun, to seven years in prison and fined him Tk 40 crore in the same case.

A counsel for the ACC who has drafted the appeal said the lower court has not fully considered the statement made by Debra Laprevotte, a supervisory special agent of the Federal Bureau of Investigation of the USA, before it.

Laprevotte, in her testimony had narrated before the lower court on November 16, 2011, how she had tracked down the money allegedly laundered by Tarique, also senior vicechairman of BNP, and Mamun to a bank account in Singapore.

The ACC counsel on request of anonymity recently told The Daily Star that the 100-page appeal will be filed by Thursday urging the High Court to declare that the trial court verdict about Tarique was "erroneous and wrong."

In October 2009, the ACC filed the case against the duo for laundering Tk 20.41 crore to Singapore between 2003 SEE PAGE 4 COL 1 and 2007.

Cracker, piece of shroud found in JU VC's house

Pro-VCs freed from confinement after 12 days

A cracker and a piece of shroud were recovered from the official residence of Jahangirnagar University Vice Chancellor Prof Anwar Hossain yesterday, a day after an unknown person texted him that he would be bombed if he

returned to the campus. Ahsulia police removed the unexploded cracker from the courtyard of the house where Prof Anwar arrived yesterday afternoon following 12 days of sick leave. Police said these things might have been put there to create panic.

It is less than a month that the embattled VC, who has been asked to resign by a section of teachers since February, received a second death threat. The same sender issued the first threat on November 7, asking him to leave JU immediately. Meanwhile, JU Teachers'

Association (Juta) President Prof Ajit Kumar Majumdar received a second death threat yesterday with the sender asking him to stop the movement against the VC. He received the first threat on November 8.

Proctor Prof Muzibur Rahman said they filed a general diary (GD) with Ashulia Police Station and increased police presence around the VC's residence. Meanwhile, Pro-VC (education)

Prof MA Matin and Pro-VC (admin) Prof Afsar Ahmed were freed around 9:15pm last night after 12 days of confinement since November 20.

"As the pro-VCs will no longer carry out the responsibilities of the VC upon Prof Anwar's return, we withdrew the confinement," said one of the agitating teachers, Prof Kamrul Ahsan.

4 decades old Indo-Bangla passport regime ends

A four-decade-old India-Bangladesh passport regime in India's north-eastern and West Bengal states came to an end on Sunday following an instruction by the Ministry of External Affairs on the state governments. Passports under the old system are usable till the expiry date.

This special passport, allowing travel to Bangladesh, used to be issued by the north-eastern state governments with consent of the regional passport offices in Kolkata.

It was introduced after Bangladesh's independence in 1971 and was availed mainly by businessmen and individuals having families and relatives in Bangladesh.

Thousands of the states' residents were born in Bangladesh and migrated to India in four phases. The phases comprise the 1905 partition
