Door shut yet open for BNP

concessions," he added. Earlier on Sunday, he said the EC would consider extending the time for submitting forms if the BNP decided to take part in the polls.

The opposition BNP, however, has been enforcing a countrywide blockade of roads, railway and waterways demanding elections under a non-party caretaker administration and the suspension of the polls fixture. It even extended its ongoing 72-hour blockade to a 131-hour one yesterday.

BNP chief Khaleda Zia yesterday again called on the EC to suspend the polls schedule. The prospect of a deal between the Awami League and BNP on the type of election-time government still remains dim. However,

Communications Minister Obaidul Quader yesterday claimed that there was still hope. He said there could be a deal brokered between the government and the opposition

since the national and international communities were working towards this end. With the BNP-led opposition alliance staying out, 1,107 people, mostly leaders belonging to 15 parties, including Awami League, its alliance component Jatiya Party, and around 150 independent

candidates filed their nomination papers. The returning officers will scrutinise their papers on December 5 and 6.

The EC on the night of November 25 announced the election schedule keeping only six days, the shortest in the last two decades, for submitting nomination papers.

The EC gave 28 days' time for candidates to file nomination papers at the 2008 parliamentary polls, in which 1,500 candidates took part. In 2001 nine days' time was given and 1,900 lawmaker aspirants took part. At least 16 days were given for the seventh parliamentary elections in 1996 with 2,500 people joining the battle of ballots.

For the 10th parliamentary election, there are at least eight constituencies with only one candidate who filed the nomination papers: MK Alamgir in Chandpur-1, Momtaj Begum in Manikganj-2, Rezwan Ahmed Tawfiq in Kishoreganj-4, Abdus Shaheed in Moulvibazar-4, Nuruzzaman Ahmed in Lalmonirhat-2, Morshed Alam in Noakhali-2, Amanur Rahman Khan Rana in Tangail-3, and SK Afil Uddin in Jessore-1.

However, Awami League nominated candidates in many constituencies will have to deal with rebel candidates of their own party running as independents.

Former state minister Mannujan Sufian for Khulna-3, and Awami League leaders Zahid Ahsan Russel for Gazipur-2, Mrinal Kanti Das for Munshiganj-3, Sagupta Yesmin Emili for Munshiganj-2, and Mostofa Rashidi Suja for Khulna-4 will have to battle rebels in their party.

Meanwhile, the EC yesterday decided to request the authorities to transfer the divisional commissioner of Dhaka and deputy commissioner of Khulna.

An election commissioner told The Daily Star that the two officials did not act as per the EC's directives and that was why the EC wanted their transfer.

7-member probe body formed

Police in separate drives until yesterday arrested 41 people in connection with the fire incident at Gazipur factory compound of Standard Group early Friday.

A seven-member committee led by Gazipur Additional Superintendent of Police (North) Sanjib Kumar Roy was formed yesterday to investigate the arson. Gazipur Superintendent of Police (SP)

Abdul Baten, at a press conference in his office yesterday told journalists that the committee would submit the probe report to the court in next 10 days as part of the judicial enquiry.

He added that Md Siddikur Rahman, administrative officer of Standard Group, had filed a case in connection with the fire incident with Joydevpur Police Station.

On November 29, some unruly workers of adjacent areas aided by outsiders stormed the factory and set fire to two buildings in the factory compound.

miscreants" were killing the innocent by carrying out mindless attacks on them. "They're burning people alive by hurling bombs and torching passenger buses. Even elderly people, women and children are not spared."

Mentioning Awami League leader Sheikh Fazlul Karim Selim's statement after 1/11, she said the recent violence during hartals and blockades bore the hallmarks of terrorism by the AL and "it is clear to everyone that Awami terrorists are the masterminds behind all these brutal killings and destruction." To the Election Commission, Khaleda said,

"Save the country by cancelling the election schedule and don't behave like a puppet of a party through taking steps to hold a unilateral, farcical election.' She also requested all concerned not to

engage in the "farcical election process". The former prime minister asked the govern-

ment to stop "harassing opposition activists and break the ongoing political impasse through consensus." She then urged officials of the civil administration and law enforcement agencies to carry

out their duties impartially and not to make any move against people. She called on those "affected and repressed" by the Awami League-led government in its

tenure to continue what she said was their movement in a peaceful manner. "People's legitimate movements have never

failed. God willing, our victory is certain and imminent. Getting back to the recent wave of violence,

the BNP chief said she along with the people wondered how such horrendous attacks could

take place amid the highest security alert across the country.

She wondered how the perpetrators could get away to safety and how none of them had so

far been arrested on the spot. Khaleda continued, "Our leaders and activists are being shot dead every day by police, Rab, BGB members and Awami terrorists. The peaceloving innocent people are not our opponents. Our movement is for saving the country and its people and it's not for taking their life and property.

She alleged that the ruling party and the prime minister have taken to various propaganda campaigns, cashing in on the heinous acts for narrow political gains.

"Failing to ensure security for the common people, resist miscreants and arrest the offenders, they now blame the opposition without any information or documents.

She said the way BNP Joint Secretary General Ruhul Kabir Rizvi was arrested at the BNP headquarters after midnight and the party office vandalised and looted reminds one of the attacks by the Pakistani occupation forces in 1971.

Khaleda also blasted the government for filing "false cases" without any proof.

Five-year-old Sumaiya Akhter Sadia was hit in the head by a cocktail while she was going to school with her mother by a rickshaw at Signal

The incident happened when their rickshaw was moving past a procession of blockaders.

In another incident, blockaders threw petrol bombs at a truck at Sitakunda upazila around 2.00pm, leaving its driver Md Yasin of Patiya injured.

In an arson attack on a CNG-run autorickshaw at Battali, its driver Abdul Aziz, 50, suffered burns on more than 35 percent of his body.

He was admitted to the burn unit of Chittagong Medical College Hospital. At the DMCH's burn unit, the arson victims

expressed anger at the attacks on innocent people and demanded punishment to those responsible. Lying on a bed at the burn unit, Abdur Razzak, victim of the November 28 arson attack

opposition parties. "Both parties must give compensations, since they both are fighting. They are equally responsible for our plight," he said.

Another arson victim Shamim, who was on the same bus, said he had no hope of getting

justice. "There is no justice for the poor. I might have to wait my entire life for justice or compensation. I will seek justice from Allah," said Shamim, a salesman, who suffered burns on 25

percent of his body.
