BB depends on 'agent banking'

The central bank has introduced agent banking aiming to provide banking and financial services on a limited scale to the underserved population.

Agent banking is a new concept in time. Bangladesh, but practiced globally as an important distribution channel for financial inclusion through agents of the banks.

With prior approval from the central bank and agreements with a commercial bank, organisations ranging from NGOs to retail shops can perform banking transactions on behalf of the bank, without charging the customers.

Bangladesh Bank on Monday issued a guideline on agent banking to all commercial banks.

"Bangladesh Bank has decided to currency. promote this complimentary channel to reach out to the poor segments of society as well as existing

Through agent banking, cash deposits can be collected in addition to cash withdrawal and fund transfers. However, the ceiling will be determined and revised by BB from time to

Other activities of agent banking will be inward foreign remittance disbursement, small value loan disbursement, recovery of loans and instalments, utility bill payment, cash payment under social safety net programmes, among other regular banking activities.

However, banking agents will not be allowed to give final approval on new bank account opening, issue bank cards/cheques, loan or financial appraisal, cheque encashment and dealing in foreign

Those who can be eligible for agents are: nongovernmental organisations, micro-finance institutions, cooperative societies, post offices, courier and mailing service companies, agents of mobile network operators, offices of rural and urban local government institutions, union information and service centres, educated individuals capable of handling IT based financial services, agents of insurance companies, owners of pharmacies, chain shops and petrol pumps or gas stations.

Customers will not be charged directly by the agents for providing services.

Bank will pay reasonable fees or commissions to their agents. However, banks may charge commissions or fees or charges applicable to its customers.

Nokia faces \$3.4b tax claim in India

...... Finnish mobile phone maker Nokia faces a tax bill of more than 210 billion rupees (\$3.4 billion) in India from liabilities arising out of unpaid charges and penalties since 2006, a report said Tuesday.

Indian tax authorities froze some of Nokia's assets in October including its bank accounts and buildings over a dispute which has forced Nokia to approach the Indian courts seeking relief.

Nokia has reportedly offered to pay about 30 billion rupees (\$490 million), but the income tax department "has informed the Delhi High Court that Nokia India and its parent Nokia Corp have a tax liability adding up to 211.53 billion rupees", the Times of India reported.

DSE submits probe report on 12 low-cap companies

The Dhaka Stock Exchange has submitted its investigation report to the stockmarket regulator on an abnormal hike in the prices of 12 low-cap companies' shares.

The companies, whose market capitalisation range between Tk 40 lakh and Tk 31 crore, gained nearly 50 percent to 150 percent in just 15 trading days in September, when the overall market sentiment was dull.

The stockmarket regulator will take action against the firms soon, said Saifur Rahman, executive director of Bangladesh Securities and Exchange Commission.

Govt to buy 50,000 tonnes of wheat from Vitol Asia

..... A cabinet panel yesterday approved the purchase of 50,000 tonnes of wheat by the Directorate General of Food to increase food stock.

The government will buy wheat First Pte Ltd. from Singapore's Vitol Asia at \$313.92 a tonne, which was the lowest bid, Nurul Karim, additional secretary of the cabinet division, told reporters.

Five bidders participated in the tender. The government plans to import 8.5 lakh tonnes of wheat in

the year ending June 30.

The committee also approved a proposal to import 50,000 tonnes of urea fertiliser. Desh Trading Company Bangladesh will supply the fertiliser through Singapore-based Commodity

Of the amount, 25,000 tonnes will be priced at \$387.3 a tonne and another 25,000 tonnes will be at \$383.4.

In the current fiscal year, demand for urea fertiliser is 24.5 lakh tonnes, of which 6 lakh tonnes will be imported.

70-80 for each kg of broiler chicken, the lowest in five years, when the production cost is Tk 110-120, the BPICC convenor said. The price of a day-old chick also

fell by a half. The minimum production cost is Tk 35, but it is now selling at Tk 15-20.

At the retail level, the scenario, however, is completely the opposite. Retailers are charging Tk 30-32 for four pieces of eggs, which was Tk 26-28 about two weeks ago, according to Trading Corporation of Bangladesh.

The poultry industry accounts for 4 percent of the gross domestic product. The country has six grandparent stock farms, 60-70 parent stock farms and hatcheries and 70,000 poultry farms. The sector has so far invested around Tk 25,000
