## ATTACK ON COPS, DAMAGE TO PUBLIC PROPERTY 700 BNP, Jamaat-Shibir men sued in Dinajpur

At least 700 BNP and Jamaat-Shibir activists have been sued on charges of damaging public properties and attack on law enforcers during the blockade enforced by BNP-led 18-party alliance in Sadar upazila on Tuesday.

Sub-Inspector (SI) Nazmul Alam of Sadar Police station filed the case yesterday, accusing 150 identified and 550 unnamed Jamaat-Shibir and BNP activists.

Khalekuzzaman Babu,

vice-president of Dinajpur district unit of BNP, Mukur Chowdhury, general secretary, and Hasanuzzaman Ujjal organising secretary of the unit, and local Jamaat leaders Mujibar Rahman, Tayab Uddin, and Tamizuddin Ahmed, and Shibir district unit President Motiur Rahman are among the named accused.

In the case statement, the complainant said the accused were obstructing train communications in Nimnagar Balubari area during the opposition sponsored blockade programme on Tuesday

noon.

As police tried to resist the blockaders, they swooped on the law enforcers, prompting them to fire rubber bullets and tear gas shells, the complainant said, adding that the opposition activists also damaged public properties in the area.

None of the accused was arrested as of filing of this report at 5:00pm yesterday. Contacted, Officer-in-Charge Abdul Kader Zilani of Sadar Police Station said they will launch a drive soon to arrest the accused in the case.

## Housewife tortured to death

A housewife was beaten to death allegedly by her husband at Kharibari village in Sadar upazila of the district on Monday.

The deceased was identified Usha Rani, 27, wife of Pitambar Sen of the same village.

Police arrested Pitambar after recovering the body.

Police and local sources said Usha Rani, daughter of Bisnu Kumer was married to Pitambar, 35, son of late Goynath Sen of the village ten years ago. They had an eight years old son.

The relation between the two started to deteriorate 3-4 years ago due to reasons unknown and Pitambar often tortured his wife.

On Sunday night, the couple engaged in an altercation over a trifling matter and Pitambar beat up his wife.

As Usha Rani woke up a little late in the morning, Pitambar beat her again, leaving her dead on the spot.

On information, a team from Ruhea police station went to the spot and recovered the body and sent it to Thakurgaon Sadar Hospital morgue.

Contacted, Sub-Inspector of the police station Md Jahangir Alam told this correspondent that an injury mark was found on Usha's forehead.

"After investigation, we will ascertain the cause of death," he said.

No case was filed till filing of this report at 5:00pm yesterday.

## KALPANA CHAKMA ABDUCTION CASE

# Time for submission of fresh probe report extended

A court here yesterday extended time for submission of fresh investigation report in Kalpana Chakma abduction case until January 16 next year.

Chief Judicial Magistrate's Court extended the time upon a prayer submitted by the investigator. Rangamati Police Superintendent Amena Begum was assigned by the court to reinvestigate the abduction case on April 24 this year.

Kalpana Chakma, the then organising secretary of Hill Women's Federation, was kidnapped from her house at Lalyaghona in Baghaichhari upazila of the district on June 12, 1996.

Her elder brother Kalindi Kumar Chakma filed an abduction case with Baghaichhari Police Station the same day.

A probe committee was formed in September 1996, which submitted its report on February 27, 1997 without naming any perpetrators.

Another probe body submitted its final report on May 21, 2010, saying no clue was found regarding the case, ignoring the testimonies of the victim's brothers.

Investigator Amena Begum Said, "I need more time to complete the investigation. So I have prayed for extension of time. I talked to locals and Kalpana's elder brother Kalindi Kumar Chakma, who is also the complainant of the case".

## Foot and mouth disease breaks out in Lalmonirhat

Vaccine for treatment of affected cattle  
not available at livestock offices

Foot and mouth disease (FMD) in cattle has broken out at many villages in five upazilas of the district.

Treatment of the affected cattle has become uncertain as vaccine is not available at the district livestock office. Many farmers are using herbal medicines for treatment of their cattle.

Farmers crowd livestock offices in their respective upazilas every day, but return empty-handed. FMD vaccine isn't available in the market. Only livestock officials supply it at a government-fixed rate, they said.

Azizul Islam, a farmer of Sakoya village under Sadar upazila, said two of his five cows have been affected with FMD. Failing to get vaccine from upazila livestock office, he is now applying herbal

medicines on the cows.

Atahar Hossain of Goddimari village in Hatibandha upazila said his three cattle have been attacked by the disease, but he can't provide treatment for them due to lack of vaccine.

"I went to upazila livestock office three days ago, but the official concerned could not give me vaccine. If I fail to ensure their treatment, they will die," Atahar said.

District Livestock Officer (DLO) Abu Hossain Sarker said they are unable to provide treatment for the FMD affected cattle for lack of vaccine. "I sent a letter to Dhaka office two weeks ago, asking for vaccines, but these are yet to reach due to opposition sponsored road blockade," the DLO said.

### AL man stabbed to death

A local Awami League leader was hacked to death in Karampur area under Borolekha upazila on Tuesday night. The deceased is Bodrul Ahmed, 40, AL upazila unit youth secretary and son of Moyub Ali of the area. Police said a gang of masked criminals on three motorbikes attacked Bodrul with sharp weapons, leaving him critically injured while he was returning home around 11:30pm. He was rushed to the upazila health complex where on duty doctors declared him dead, said Abul Kasem, officer in-charge of Borolekha Police Station.

### Land feud kills one

UNB, Sylhet

A man was killed and nine others were injured in a clash over a piece of disputed land at Ronikhai village in Companyganj upazila on Tuesday. The deceased was identified as Sujit Baidya, 30, son of Shetu Baidya of the village. Locals said Subodh Baidya of the village and Jagesh Biswas of Betmura village had a longstanding conflict over the land. On Tuesday morning, both groups equipped with lethal weapons locked into a clash in the area around 8:00am, leaving Sujit dead on the spot and nine others injured. Of the injured, two were admitted to Sylhet Osmani Medical College Hospital while the rest to the upazila health complex.

### 3 held on extortion charge

Army personnel arrested three men on extortion charges in Boding Para area under Thanchi upazila on Tuesday evening. The arrestees are Ram Bung Mro, 36, Three Tang Mro, 37, and Aba Mro, 38, of the upazila. Police said acting on a tip-off, a team of army arrested the trio while they were demanding illegal toll from the Karbari (Para chief) of Boding Para. They also recovered a handmade gun and lethal weapons from their possession. A case was filed in this connection, said Md Omar Ali, officer in-charge of Thanchi Police Station.

### Four shops gutted

At least four shops were gutted in a fire at Sawrupkathi Bazar in Nesarabad upazila on Tuesday night. Locals said the fire originated from an electric short circuit at a shop and soon engulfed the adjoining shops. On information, firefighters rushed to the spot and doused the flame after one hour of frantic efforts. The affected shop owners claimed that the loss caused by the fire could go up to Tk 10 lakh.

### Outlaws kill trader

Undergrounds operatives killed a local trader in Santhia upazila on Monday night. The deceased is Bakul Hossain, 32, son of Samad Pramanik of Paiksha village. Officer in-Charge of Santhia Police Station Md Shahed Mahamud suspected that the members of outlawed Nokshal Bahini killed him with sharp weapons as a sequel to previous enmity. The body was sent to Pabna Medical College and Hospital morgue for autopsy, said the OC.
