# Butcher of Mirpur hanged

Mollah first to walk gallows for war crimes 42 years back, to be buried at Faridpur village home under police protection

The digital display showed 10:01pm at the Dhaka Central Jail gate. The entire nation had waited long for this moment.

It was the moment when Jamaat leader Abdul Quader Mollah walked the gallows, barely four days before the nation celebrates Victory Day.

Around 42 years back, Mollah didn't wince even once and neither did his heart skip a beat when he led his men to thrash a two-year-old child to death and slit the throats of a pregnant

woman and two minor girls.

In the first-ever execution in a war crimes case last night, the 65-year-old Jamaat man finally paid for these acts of cold-blooded savagery.

The hanging of Mollah, who earned the nickname Mirpurer Koshai (butcher of Mirpur) for his sinister role during the Liberation War, represents a watershed in the nation's pursuit of a closure on the wounds inflicted in

gallows around 5 to 6 minutes before his execution by Chief Hangman Shahjahan Bhuiyan, said jail sources.

"He [Mollah] was hanged at 10:01pm. His body was kept dangling for 20 minutes to confirm his death," Dhaka District Magistrate Sheikh Yusuf Harun told The Daily Star.

An ambulance carrying Mollah's body went out of the prison under police protection at 11:15pm and headed for his village home at Sadarpur upazila in Faridpur.

Arrangements were made to bury The Jamaat leader was taken to the Mollah in his village home, Abu Hena Morshed Zaman, deputy commissioner of Faridpur, told The Daily Star

at 10:15pm.

The Jamaat leader was executed hours after the Supreme Court rejected his petition to review the death sentence, bringing an end to the drama that had played out for two days since Tuesday evening.

Mollah's counsels took out an order from the SC chamber judge on Tuesday night to stay his execution only one and a half hours before he was to hang at 12:01am.

The apex court yesterday rejected Mollah's plea for reviewing his death sentence, clearing the way for the

criminal.

In an instant reaction after the execution, Shafiuddin Mollah, who testified against the Jamaat leader, told The Daily Star, "We are very happy. Much of the grief and agony that have weighed on us for the last 42 years will go now."

Shafiuddin, who lost his paternal uncle in a massacre at Alubdi village in Mirpur, said they would feel happier when all 1971 war criminals get their due punishment.

execution of the condemned war all pro-Liberation War forces for their continuous efforts to bring the war criminals to justice.

Mozaffar Ahmad Khan, the first prosecution witness in the war crimes case, said, "Our efforts to bring the war criminals to book have finally seen some success. As a freedom fighter, I am very happy today."

Mollah, then leader of Islami Chhatra Sangha, later renamed Islami Chhatra Shibir, never expressed remorse over the war crimes he committed 42 years ago. His party also SEE PAGE 2 COL 1

## One survived to see justice

Not even a two-year-old boy was spared by Abdul Quader Mollah and his cohorts.

They killed the boy, slamming him on the floor, slit the throats of his mother and two sisters, and raped his two other sisters, one of whom died from her wounds.

All but one member of the family were killed just because Hazrat Ali Laskar, the father and a tailor by profession, was a supporter of the Awami League and Bangabandhu Sheikh Mujibur Rahman.

More than 42 years later, justice was finally delivered and Mollah, the infamous "Mirpurer Koshai" (Butcher of Mirpur), was executed at 10:01 last night. The Supreme Court in its verdict, released on

December 5, said the manner in which Mollah had led the killers in the planned murder of Laskar and his family members "exceeded all norms of humanity".

The lone survivor of the massacre was one of SEE PAGE 2 COL 1

An execution is no cause for cheers, but a reason for reflection. And when a war criminal, convicted and sentenced through due process, takes those final steps of life to the gallows, the collective prayer is one, and only one: that such criminality does not recur, that men like him do not walk the earth again.

This morning, in this people's republic preparing to observe yet one more anniversary of its liberation, the knowledge that justice has finally caught up with Abdul Quader Mollah, that for the first time in the forty two years we have spent, so far, in freedom a collaborator of the Pakistan occupation army, indeed a war criminal, has met his due end only reminds us of what we must yet do to preserve our selfesteem as a nation.

## Justice reigns, Case completes freedom wins all legal phases

With a Supreme Court bench hearing two review petitions, no legal phase has been left unexplored in the war crimes trial of Quader Mollah.

The defence filed one of the petitions with the chamber judge of the apex court on Tuesday night, seeking a review of the death penalty. The other one was filed yesterday morning against his life imprisonment.

The bench headed by Chief Justice Md Muzammel Hossain rejected both the petitions yesterday, clearing the legal bar to Mollah's execution.

Earlier on September 17, this bench sentenced Mollah to death, overruling the life term handed down by

## 4 killed, 28 injured

Another dies in Comilla

At least four people were shot dead and 28 were injured when Rapid Action Battalion personnel opened fire during their clash with opposition men in Laxmipur town yesterday morning.

Jamaat activist Anwar Hossain was killed and 38 people, including three policemen, were injured in Comilla after police clashed with Jamaat men in Monoharganj upazila, on the last day of the opposition alliance's blockade.

In Laxmipur, the clash erupted after a Rab team raided the house of district BNP General

Secretary Sahabuddin Sabu around 6:00am to arrest him, reports a correspondent from Laxmipur.

Sabu and his family tried to resist and the

law enforcers shot Sabu in the leg before arresting him and his brother Azizul Karim, witnesses claimed.

As the news spread, activists of Jatiyatabadi Chhatra Dal, a pro-BNP student body, brought out a procession and engaged in a clash with the Rab team in Chawkbazar area of the town.
