Army ready for deployment

The army has been kept ready for deployment to maintain law and order during the general election, said Chief Election Commissioner Kazi Rakibuddin Ahmad.

"The time as well as number of the army personnel to be deployed will be decided in the meeting with the security forces and returning officers soon," he told reporters at the EC secretariat yesterday.

The army might be deployed one or two days earlier in remote areas than elsewhere in the country, the CEC said expressing hope that the ongoing violence would reduce and law and order would improve soon.

Sources in the EC told The Daily Star that the

meeting with security agencies might be held on December 19.

Rakibuddin once again expressed hope for a political consensus to end the political deadlock.

Replying to a question whether the election would be acceptable without the participation of the BNP, the EC boss said, "We cannot say it so early. We will be able to make comments on it considering many issues like voter turnout rate, polling atmospheres and other things."

About Jatiya Party Chairman HM Ershad's request for not allocating its electoral symbol plough to any other candidates, he said, "Returning officers will take the decision in this regard."

"If any appeal is filed with the commission against any decision of returning officers, we will

look into it," the CEC added.

Ershad in a letter yesterday requested the CEC not to allocate the party's electoral symbol to any other candidates, saying that the JP would not participate in the polls.

On the meeting with the visiting British Senior

Foreign and Commonwealth Office Minister, Baroness Warsi, Rakibuddin said, "We have discussed different technical issues related to the election."

Asked about foreign observers, he said the EC had sent invitations to many international organisations and many of them have responded

The 10th parliamentary election is scheduled for January 5.

ATTACK ON COVERED VAN IN CTG

Injured helper dies

Yet another man loses his life to the ongoing mindless political violence.

Md Mahabub Alam, 30, helper of a covered van, succumbed to his injuries early yesterday at Chittagong Medical College Hospital (CMCH).

Hailing from Amtali upazila of Barguna, Mahabub sustained injuries on Wednesday night when pickets hurled brickbats targeting his van on Dhaka-Chittagong highway at Lalpool in Feni. Hit with brick chunks and shards of a

broken windowpane, he was rushed to a local hospital in Mirsarai upazila of Chittagong. As his condition deteriorated, he was

shifted to CMCH where doctors declared him dead at around 2:45am, said his neighbour Mohammad Sohel.

The attack also left driver Monir Hossain with minor injuries.

Meanwhile, the burn unit of Dhaka Medical College Hospital still wears a look of horror and dismay with burn victims writhing in pain.

Munira Begum, 20, was seen battling with life in the female High Dependency Unit of the burn unit.

She sustained 25 percent injuries with her face severely burnt in Meherpur on November 11 during an oppositionenforced hartal.

"It is better to die than live like this. I have been admitted here [at the burn unit] only thinking of my one and a half years old daughter. Otherwise, I would rather rot to death in Meherpur. My future is ruined in the interest of others," she grieved.

Not only Munira, the faces of all the four ICU patients were heavily burnt and had blackened, saw this reporter while visiting them yesterday.

They also sustained critical injuries to their respiratory organs which, according to Resident Surgeon of the burn unit Partha Shankar Paul, might become life-

threatening for the victims. Al-Amin, a bus driver whose vehicle was set alight in Gazipur on December 3, was found shivering in fever.

His relatives attending him at the hospital said Al-Amin had been running high temperature frequently over the last couple of days.

Kamal Hossain, 35, who sustained 25 percent injuries on November 10 in the capital while travelling in a human haulier, shared the horror of the incident that, according to him, took only a minute or

"I was sitting behind the driver's seat and suddenly saw fire engulfing the vehicle. I jumped through the window-like tiny opening. I found other passengers lying on the ground around me and writhing in pain. Later, I came to know that the passenger seated next to me had died," he said.

Thirteen-year-old Shimul, a human haulier helper who sustained burns in Dhanmondi, was lying on the bed next to Kamal. He said he had begged pickets to spare him when they were about to set fire to the vehicle.

"Instead, they shut the door and set fire to the laguna [human haulier] while I was inside," he said

TESTIMONY AT WAR TRIBUNAL

Khokon, his accomplices killed 3 of a family

A prosecution witness yesterday gave a description of how fugitive war crimes accused MA Zahid Hossain Khokon along with Razakars and Pakistani army had shot dead his mother, brother and sister during the Liberation War.

The 16th prosecution witness, Kalom Sheikh, 65, told the International Crimes Tribunal-1 that Khokon along with other Razakars and Pakistani army had gone to their Ishwardi village in Faridpur on May 30, 1971. Kalom said he had hidden in a bush

north of their house. "My mother Boru Khatun, brother Salam Sheikh and sisters Srimoti and Fulmoti ran to a jute field to save their lives," said the witness. Kalom broke down in tears saying

Khokon, Razakars and Pakistani army had gone to the jute field and opened fire on them.

After they had left, Kalom recovered their bodies from the field. His another sister Fulmoti was shot in the back but survived after treatment.

During cross-examination, defence counsel Abuds Shukur Khan made a suggestion that Khokon had not shot his family members.

Getting excited at hearing the sentence, the witness shouted, "I saw Khokon shoot my mother."

The proceeding of the case has been

adjourned until December 23. FAKHRUL CONTEMPT

The tribunal-1 yesterday deferred hearing of a contempt of court proceeding issued upon war crimes convict Salauddin Quader Chowdhury's counsel Fakhrul

Islam to January 12, 2014. The notice, issued following a petition Fakhrul submitted on December 30, 2012, asked why contempt of court proceedings would not be initiated against him for maligning the tribunal's reputation.

In the petition, Fakhrul asked whether ICT-1 had known about the alleged Skype conversation between former ICT-1 chairman Justice Nizamul Huq and an expatriate legal expert, Ahmed Ziauddin.

Fakhrul was arrested on November 20 and is now in police custody for his alleged involvement in leaking the draft verdict in war crimes case against the BNP lawmaker.

The defence counsel had earlier offered 'unconditional apology'.

Prosecutor Zead Al Malum told the tribunal there was no need of hearing as Fakhrul had offered 'unconditional apology' and there were many instances to that end.

The tribunal led by Justice ATM Fazle Kabir asked Malum to submit at least two instances of contempt of court proceedings where the Appellate Division had

taken action even after 'unconditional apology'was offered.

TRIBUNAL-2

The International Crimes Tribunal-2 has meanwhile closed cross-examination of Sikdar Habibur Rahman, 18th prosecution witness in the case against Jamaat-e-Islami leader AKM Yusuf, as one of his junior counsels expressed inability to cross-examine him in the absence of senior colleagues.

The tribunal on Wednesday cancelled the vokalatnama [power of attorney] of Yusuf's conducting counsel Syed Mizanur Rahman, as he had been absenting from the proceedings since November 25.

It also asked his other counsels to inform the tribunal about the appointment of new counsel within yesterday. Yusuf's junior counsel Gazi MH Tamim yesterday said they could not appoint a new lawyer.

The three-member tribunal led by Justice Obaidul Hassan had earlier closed the cross-examination of five prosecution witnesses as Mizanur Raman didn't show up and Tamim expressed his inability to cross-examine the witnesses.

The court, however, fixed Sunday for passing orders regarding defence petitions for recalling the crossexamination of 12th, 13th and 14th

national polls.

In the appeal, Jamaat prayed to the apex court to scrap the HC verdict, saying the party amended its constitution in December last year in line with the Representation of the People Order (RPO).

The EC did not object to the amendment that time, the appeal added.

A total of 21 points had been mentioned in the appeal to turn down the HC judgement, the party lawyer Belayet Hossain told The Daily Star.

He said the hearing of the appeal might be held in January next year, as the court would go into a vacation from tomorrow [today].

It will reopen on January 2.

Following a writ petition, a three-member special bench of the HC by a majority view declared Jamaat's registration illegal and unlawful on August 1, mentioning that the registration had no legal effect.

The HC released full text o the verdict on November 2.

The court came up with the verdict as many provisions of the charter of Jamaat, which got registered with the EC in November 2008, run counter to the country's constitution and the RPO.

Jamaat's charter contains provisions including the call for establishing the rule of Islam, and refusal to accept parliament's plenary power to enact laws. The provisions do not

conform to Bangladesh's constitution and the RPO.
