





Martyred intellectual Dr Fazle Rabbee's death anniversary today


Today is the 42nd death anniversary of Shaheed Dr Fazle Rabbee.

On this day in 1971, Pakistani occupation army and its collaborator Al-Badr force picked him up from his Siddheshwari residence in the capital in the afternoon and killed him brutally at Rayerbazar at midnight, says a press release.

His body was recovered from the Rayerbazar killing field on December 18, two days after the victory of Bangladesh in the Liberation War.

Rabbee, a renowned heart specialist, served Dhaka Medical College as a professor of medicine and cardiology.

To mark his death anniversary, wreaths will be placed at his grave this morning and food will be distributed among the poor.



Death anniversary | DOMESTIC WORK BY CHILDREN Most employers unwilling to recognise it as risky

Say rights activists, labour ministry officials

The reluctance of the middle class, the largest section of society to employ children in their house, is the biggest barrier to recognising domestic work as a risky job for children, human rights activists and officials said yesterday.

Mikail Shipar, secretary to the labour and employment ministry, said it was mostly the urban middle class that employed children as domestic helps, and they were the ones who made the policy decisions.

As policy makers have child workers in their houses, they are generally unwilling to call it risky, he told a roundtable of the Bangla daily Prothom Alo at its office in the capital.

"The reason why the labour ministry's list of 38 very risky jobs for children does not include domestic work is not that we don't understand the risks, but we are too often confronted by the middle class's reluctance to let go of one of their conveniences," Shipar said.

Executive Director of Ain o Salish Kendra Sultana Kamal opined that a system of registering the identities of the domestic workers, their parents and employers needed to be introduced and administered by the local government representatives to ensure their safety.

ENSURING RIGHTS OF PERSONS WITH DISABILITIES

Representation in JS a must

ADD International, The Daily Star discussion told

Parliamentary representation is a must to establish the due rights of Bangladesh's 15 million physically and mentally challenged people, speakers told a discussion

yesterday. Their representation can be ensured with 10 percent reserved seats both at local government institutions and parliament, said Mahbubur Rahman Bhuyan, project focal, ADD International, in his keynote

presentation. Action on Disability and Development (ADD) International jointly with The Daily Star organised the discussion, "Break Barriers, Open Doors: for an inclusive society and development for all", in the capital's

The Daily Star Centre. Despite having the same competence as of persons without disabilities, these people are deprived of equal consideration in job opportunities, said Nasima Akhtar, president, Protibondhi Nari Jatiya Parishad.

"Neither are they treated equally in soci-

human right," she said, adding that the representation was a prerequisite to chang-

ing society's discriminatory mindset. The Election Commission must ensure ramps, ground floor polling booths and tactile ballot papers so that these persons can cast votes in the upcoming parliament elections without hindrance, she

added. Noted lawyer Barrister Rafique ul Huq, as chief guest, said the constitution clearly guards against any discrimination against

these people. If implemented, the recently enacted Disabled People's Rights and Protection Act, 2013 can adequately protect their rights, he said.

Pointing out the insensitivity these persons face, Md Liakat Ali, president, Alor Pradeep, said even a government social welfare officer sits on the fifth floor of an office that has no provision to ensure access of

physically challenged persons to the officer. Brig Gen Shahedul Anam Khan, editor of

strategic affairs, The Daily Star, said without


SKELETAL REMAINS IN RANA PLAZA DEBRIS Victim primarily identified

The skeletal remains which were found with an ID card and a mobile phone in the Rana Plaza debris Friday belong to garment worker Obaidul, police primarily confirmed yesterday, after contacting the victim's relatives through the retrieved SIM card.



remains are of two persons. On Friday night, police dialled a number saved in the SIM card as "Vial" (thought to be misspelt for "Via" meaning brother) and one Faruq Hossain replied from the other side identifying him as a cousin of Obaidul, said police. Faruq answered all their queries properly, they added.

The ID card shows that Obaidul was a sewing assistant at New Wave Bottoms garment factory on the second floor of the nine-storey Rana Plaza, which crumbled eight months
