Jamaat-Shibir activists attack, loot FF's house, business centres

Criminals, allegedly belonging to Jamaat-Shibir, ransacked and looted the house of a freedom fighter at Kutubpur village in Chirirbandar upazila on Friday night.

House owner Altaf Hossain, 62, said a gang entered the house around 11:30pm and went on rampage. Sensing trouble, he along with his family members fled the scene.

The gang also took away three cattle before leaving the spot. However, the cattle were recovered later, he said.

FF Altaf Hossain suspected that Jamaat-Shibir men carried out the attack.

Meanwhile, many traders of different 'sensitive areas' in the district have started shifting their business items at warehouses to safer places in fear of arson attack and looting as Jamaat-Shibir called countrywide hartal for today.

The areas are Bhusirbandar and Ranirbandar of Chirirbandar and Pakerhat of Khansama upazilas.

Trader Sekendar Ali Shah of Bhusirbandar area said, the decision to shift the business items was taken following an attack by Jamaat-Shibir men on Bhawani Agarwal in the area on Thursday night.

The attackers torched at least five buses, a jeep, a pickup van and two motorcycles at the business centre. They also looted the shop.

BGB Darshana Camp commander Abdul Awal said, a flag meeting was held between BGB and BSF at Gedy border at 11:00am over the issue.


Later BSF handed the meeting and Damurhuda police handed them to their relatives.

Prime Minister Sheikh Hasina yesterday said her party had reached a compromise with other parties over the polls-time government. "We've withdrawn our candidatures from some seats after liaising with other parties." Food Minister Amir

Hossain Amu, who is a member of the Awami League advisory council, told BBC Bangla Service that the EC repeatedly had said there was no scope to change the polls schedule.

Responding to a query about talks with the opposition BNP, he said discussions were going on but there were constitutional barriers to a change in the schedule.

On another question, Amu said it would not be ethical to brand the election farcical if a single party boycotted it.

The number of candidates to be elected unopposed has broken the record of the controversial February 15 election in 1996. Held amid a boycott by opposition parties, the election saw 49 ruling BNP candidates declared elected without challenge.

Then in opposition, the Awami League led the boycott alongside waging a street agitation for the introduction of an election-time caretaker government sys-

This time, the BNP is leading the election boycott alongside the violent blockade to get the caretaker system restored and resist the January 5 polls. The violence has claimed many lives and paralysed the economy.

The boycott has also resulted in the lowest-ever participation of candidates in the January 5 polls. Only 398 candidates will fight for 149 seats. Each of the nine other parliamentary polls held since 1973 had more than 1,000 candidates.

Also yesterday, the returning officers allocated electoral symbols to the candidates for the remaining constituencies, another step towards the January 5 polls.

In many areas, the returning officers, who are also deputy commissioners of districts, have started declaring lone candidates as winners in different seats.

The EC will publish gazettes announcing the Later, they launched an official results on completion of the polls. The MPselect will take oath within three days of the gazette publication, EC officials have said.

Tortured, driven out for dowry, Rima doesn't know what to do now

Tortured by husband and inlaws, a dowry victim took shelter at her father's house and now passing days amid fear, agony and uncertainty.

As Sohel Miah and his family members could not realise dowry money from the mother of Rima Akhter, they allegedly chained her and shaved her head on December 4 night, said Md Kamal Hossain, officer in-charge of Pagla police station in Gafargaon upazila.

According to police and the victim, Rima, daughter of late Chandu Miah of Belobo village under the PS was married off to Sohel of the same village four years

and his family members beat up Rima several times, they said.

Following an altercation over the demanded dowry, Sohel, his mother Shahor Banu, sister Kulsum Begum and sister-in-law Kalpona Akhtar on December 4 night chained Rima and shaved

her hair and confined her to a room.

On information, local people rescued Rima the next morning and caught Sohel red-handed.
