A gang posing as guests murdered Faruque, his son Sarwar Islam Faruqe, and his four disciples by slitting their throats.

The law enforcers say religious extremists might have had a hand as Faruque used to preach a radical version of Islam. Police are also investigat-

ing whether any wealth related disputes or personal enmity were behind the murder, Joint Commissioner Monirul Islam of Detective Branch of police told reporters at his office yesterday. The amount of wealth

owned by the pir remains unknown, as he had been unemployed since 1999, said his village neighbours, who described him as being in the "lower-middle class".

His nephew Rakibul, however, said he sent around Tk 5,000 to 7,000 to

his village home for his poor relatives twice a year.

His Gopibagh residence was a 2,300-square feet flat rented for Tk 24,000 a month,

according to the house owner. A twelve-member family lived in that apartment, comprising the pir, his wife Salma, two sons, his daughter-in-law Bithi, his daughter Shamsunnahar Runi and her infant, and disciples Shahida, Mujibor, Shaheen, Manjur, Asma and her fouryear-old son Rajon.

The pir's daughter Runi said her father often brought home guests who ate and lived there.

"He used to host religious gatherings twice a week at our house, although the frequency dwindled in the past month. Around 40 people used to come," added her brother Abdullah.

Azizul Rahman Babul, a disciple, said he had contributed Tk 2,000 on many occasions. "I have been with him since 2003. In many months, he would ask us to financially help him." Babul, however, said the

donations were not big. Among the twelve members of his family, only his

children did any regular work. His elder son, deceased Sarwar, worked in City Bank and got a salary of Tk 50,000, claimed some ten-

ants choosing anonymity. His younger son is a fresh graduate working as a marketing officer at Abul Khair Ceramic, revealed his colleagues. The daughter was a lecturer at a private univer-

sity, her cousin Rakibul said. Previously, Lutfar had worked as an assistant general manager at a private firm and owned a buying house, which was shut

down in 1997.




